

HB 2949 isn't perfect, but the "Risky Business" group is urging its passage so that in the event of the inevitable disaster money is available for clean-up, saving the State from having to use taxpayer money.

Nuclear Lobby Day Recap

On May 19th, 2025 OPSR joined over [25 organizations representing over 120,000 Oregonians as part of the Keep Oregon Nuclear Free working group.](#)

We gathered at the Oregon Capitol to lobby against [HB 2410](#) which would approve the development of a small modular nuclear reactor (SMNR) demonstration facility in Umatilla County to power data centers that use enormous amounts of energy.

We held conversations with public officials to share our concerns about the experimental project (this would be the first SNMR in the U.S.) and the dangers it poses to environmental and human health.
