 4. two (2) members of the State Board of Education
 5. two (2) members each for the Wayne State University Board of Governors, the Michigan State University Board of Trustees, and the University of Michigan Board of Regents
2. Transacting other such business as may properly come before the State Convention.

There will be a \$50 registration fee for all elected delegates, alternates, and guests who plan on attending the endorsement convention. A link for payment was sent to your county chair in the days leading up to the county convention on February 26th, 2026.

All convention activities will be held at the Vibe Credit Union Showplace, 46100 Grand River Ave, Novi, MI 48374.

There will be concessions on site and Vibe Credit Union **does not allow** open carry. This is a state law.
