





The post also presents evidence-based solutions to improve wait times in the public system.
- The Slow Death of the Alberta Advantage explains how Alberta's pitiful minimum wage is part of a strategy to keep wages low for all Albertans, and challenges myths about who minimum wage earners really are in our province.
- Avoiding Fair Taxation is Alberta's Real Addiction asks: How do we end decades of oil revenue dependency without compromising the services Albertans rely on? Drawing on Parkland Institute's research, this post argues that systemic policies of unfair taxation are behind Alberta's economic woes.
- On the Road to AIMCo's Politicization: The Alberta government's dismissal of AIMCo's board and CEO sparked concerns about political meddling. Then Stephen Harper's appointment as chair was another step toward reshaping AIMCo to serve partisan goals. Against this backdrop, understanding AIMCo's evolution and growing politicization is more critical than ever.
- Why Is Your Educational Assistant on Strike? Ask the UCP shows how, as education support workers went on strike for decent wages, Alberta's government worked behind the scenes to derail any meaningful negotiations between workers and school boards.

PROGRAMMING

In November 2024, Parkland Institute's 28th annual fall conference, **The Road Ahead: Strategies for Building a Better Future**, brought together thinkers, writers, and activists to discuss new ideas and refresh old ideas to fit the challenges brought by rapidly increasing inequality and unsustainability in Alberta, Canada, and the world. The conference had a total of **428 attendees** between inperson and online participants. John Vaillant and Koren Lightning were the keynote speakers.

In March 2025, Parkland partnered with Canadians for Tax Fairness, Oxfam Canada, Public Interest Alberta, and Common Horizon Edmonton to present **Fair Taxes, Affordable Futures: Building an Economy for Everyone**, an in-person town hall that brought together community leaders and experts to explore how taxation policies impact affordability and what we can do to fix our tax system and ensure that public revenues are used to support the people and services that need them most.

Parkland marks the launch of each of its research reports with a public webinar featuring the report's author, who presents the key findings of their work and answers questions from the audience. In the 2024–2025 fiscal year, we hosted the webinars **Rethinking Edmonton's Financial Future** (November), **The Road Ahead for Child Care in Alberta** (February), and **Alberta's Surgical Crisis: Private Profits, Public Losses** (March). A total of **415 attendees** participated in these events.

In addition to the events featured on this page, Parkland Institute spoke directly to Albertans at numerous **presentations** to more than **2,000 people** across the province and online, including general audiences and groups such as doctors, nurses, seniors, union members, scholars and and other engaged Albertans looking to make a difference. Topics discussed included health-care privatization, public services deficit, and Alberta's political history. We also hosted a successful **Gala Dinner** — our most important fundraiser of the year — and, of course, our traditional **Open House** in December.

This fiscal year, over 50,000 people made 60,237 visits to parklandinstitute.ca. Collectively, they viewed our web pages more than **94,166 times**.


