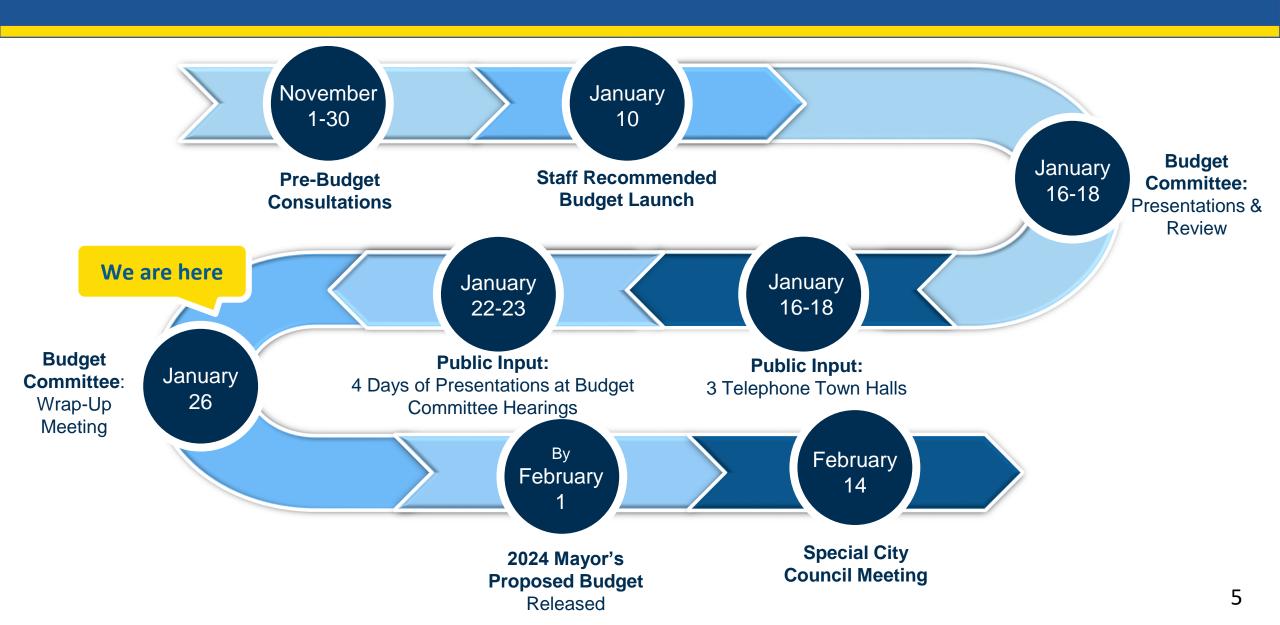

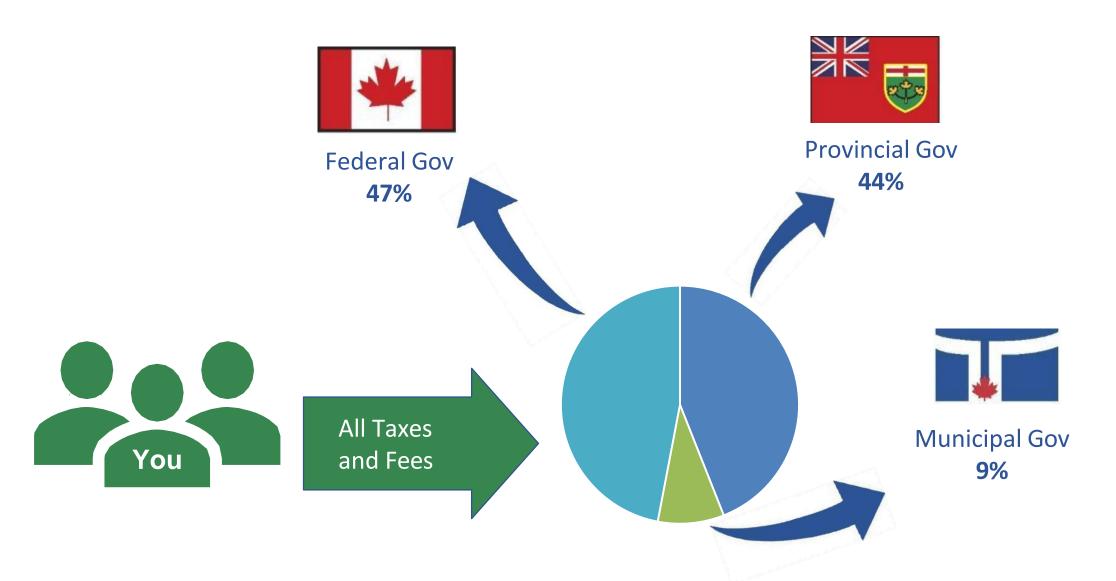

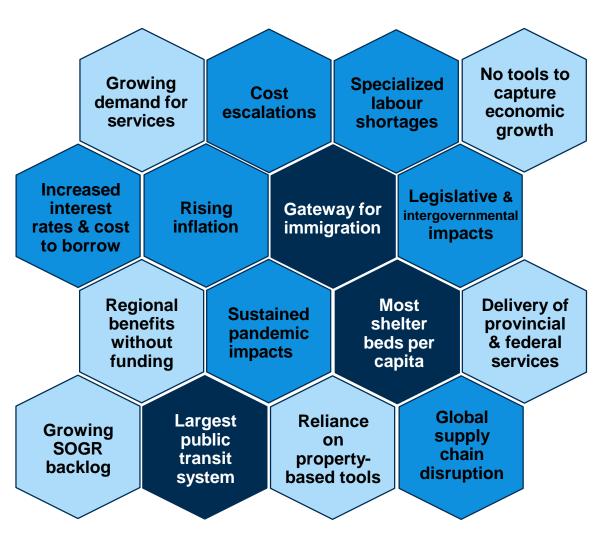




The Challenges for Toronto's Budget are Unique

The City continues to face structural fiscal challenges – ongoing and deeply entrenched.

- The financial environment has worsened
 with new and unprecedented
 financial challenges.
- Toronto faces unique challenges, as the largest city in Canada.

New Fiscal Framework With The Province



\$3.0 billion in financial relief over a 10-year period



- ✓ Upload F.G. Gardiner Expressway & Don Valley Parkway
 - Eliminates the City's largest SOGR liability
 - Unlocks \$1.9 billion in funds to be re-invested in critical infrastructure and infrastructure renewal requirements (available to be leveraged after completion of due diligence process)



✓ Funding for the purchase of 55 new subway trains to replace those in use on Line 2*



✓ Three-year allocation of Building Faster Fund support, based on Toronto exceeding annual housing targets





The City hopes to have access to a federal funding program providing full reimbursement of costs associated with refugee claimant response.

- 2024 Budget expects 4,300 shelter beds to be used for refugee claimants and asylum seekers at an initial cost estimate of \$250 million
 - Represents additional costs beyond 500 dedicated spaces that are provided and funded by the City for refugee claimants
 - Cost estimates are subject to change and will be based on actual demand for shelter services
- The City expects access to a federal funding program in 2024 for reimbursement of costs
 - Absent a federal funding commitment, staff will report back on actions required to maintain a balanced budget
 - The equivalent of an added **6% property tax increase** would be required to support 4,300 shelter beds at an estimated cost of \$250 million

City Budget: Operating and Capital



Operating Budget



- Single Year Plan to deliver City services and programs
- Annual cost of providing services such as:
 - TTC Operations
 - Emergency services: Police, Fire, Paramedics,
 Toronto Community Crisis Service
 - Shelters
 - Road maintenance and sidewalks, bike lanes
 - Recreation programs
 - Waste and recycling collection
 - Child-care
 - Public health
 - Park maintenance
 - Bylaw enforcement

10 Year Capital Plan & Budget



- Multi-Year Plan for renewal and creation of capital assets needed to deliver the City services.
- Total costs of constructing, improving, or extending the useful life of:
 - Building and equipment
 - New road and transit networks
 - Water and wastewater facilities
 - Computers and information systems
 - Other major assets & infrastructure

Critical Investments



The 2024 Budget includes an additional spend of \$152 million in new and enhanced initiatives including:

Shelter & Housing: \$82M

- Keeping unhoused residents safe during winter
- •450 new emergency refugee shelter beds



Transit Services & Sustainability: \$30M

- Transit safety and security
- Reducing emissions from transit vehicles

Community Initiatives: \$20M

- More direct care for long-term care residents
- Longer open hours for Toronto Public Libraries



Community Safety: \$19 M



- Toronto Community Crisis Service expansion
- More paramedics, fire fighters, police and other emergency services staff

Residential impact for the average home:

- \$321 annual increase in 2024
- Equates to monthly increase of \$26.75

3% rate increases for Water & Solid Waste:

- Water: \$30 annual increase in 2024
- Solid Waste: \$9 \$16 annual increase in 2024

City Building Fund



The current City Building Fund (CBF) was initiated by Mayor Tory in 2017 at 0.5%.

- In 2020 it was increased to 1.5%, to be collected until 2025.
- In 2023 Mayor Tory extended the collection period for an additional 10 years to 2035.
- Applied to all property tax classes but at varying rates.
- The proportional increase will mirror the regular tax increase (i.e. 1/2 of the increase or 0.75% for commercial and multi-residential).

The CBF has already delivered almost \$1 billion in critical capital funding for transit and housing projects since its inception.

There is no increase proposed to the City Building Fund.

Agreement that other orders of government should pay their fair share of funding for intergovernmental responsibilities

- 85% provincial government
- 88% federal government
