YOU'RE INVITED TO THE 12TH ANNUAL DISABILITY TAX CREDITS SEMINARS

Join me on March 16, 2019 in New Westminster and on March 23, 2019 in Burnaby and find out how hundreds of your neighbours have benefited from these seminars.

In our community, thousands of people with disabilities may be eligible for an important tax credit that often includes a significant tax refund from the Canadian Revenue Agency. Many residents could be eligible for a tax refund under the Income Tax Act.

Some of you may already know that the Income Tax Act provides a non-refundable Disability Tax Credit to all eligible individuals. My office wants to make sure that every eligible New Westminster-Burnaby resident knows how to access this legitimate entitlement under the Income Tax Act. To that end, we are offering workshops to inform constituents

about the Disability Tax Credit, which can amount to up to \$1200 per year, and can be claimed retroactively for up to 10 years.

While the Income Tax Act stipulates that this is a nonrefundable tax credit, it is often transferable to spouses and other family members if the income of the relative with a disability or infirmity is too low.

2018 in Review: Liberals Choose Rich Corporations Over Everyday People

Layoffs, plant closures and precarious work have left many Canadians on shaky ground. As it stands, more than half of all Canadians are \$200 away from not being able to pay their bills and many will take on even more debt. Instead of bringing in immediate relief for people facing a housing crisis and crushing personal debt, Trudeau's priority in November's fall economic statement was to give billions of dollars in corporate giveaways with no strings attached, such as giving the richest corporations a \$14 billion tax giveaway, including massive write offs for private jets and limousines, but doing nothing for average Canadians struggling to make ends meet. And people can't afford to go back to the same old Conservative party who created so many of these problems we're facing today.

Trudeau's Liberal government's record in 2018 is defined by an unwillingness to help out Canadians struggling to make ends meet, but proves they are more than willing to give massive tax giveaways to the most profitable corporations and richest people in society. Prime Minister Trudeau doesn't seem to understand what people are actually going through and his choices this past year reflect that.

When regular people claim something on their taxes, they are given 90 days to prove that it's a legal claim, whereas it's been two years since the Panama Papers revealed that many of the richest people in Canada have

been stashing billions of dollars in illegal offshore tax havens, and still not a single charge has been laid. It's like playing Monopoly where the richest always have a get-out-of-jail-free card, and everyone else has to roll the dice



The NDP has been calling on the Trudeau government to focus on solutions that will lessen both the personal debt level of Canadian families, and the burden facing small businesses. The Liberal government's Fall Economic Update contained zero funding for housing, nothing to reduce the cost of prescription medicine and tuition fees, failed to close the funding gap for Indigenous peoples' education, and does not save the Ontario Basic Income Pilot Project.

Despite the calls from across the country for real change, when rich corporations come calling for help, the Liberal government rushes to give them what they want – but when Canadians ask for relief from the rising costs of housing, medication costs and unmanageable debt, Justin Trudeau's Liberals tell them to wait.

When push comes to shove, the Liberal government has shown it will side with corporate interests over the interests of Canadians every time.

The pre-budget 2019 hearings held across the country last fall showed the real concerns of Canadians, and they are far different than what the Finance Committee hears in the "Ottawa bubble". The Liberal MPs who form a majority on the committee simply refused to prioritize the concerns of Canadians who took the effort to come out and speak to the committee. But in the testimony that emerged from the dozens of groups that testified came real hope and optimism that Canadians understand where the Trudeau government should be investing.

It's the compelling testimony of these witnesses that led the NDP to offer nearly 100 recommendations to the Finance Committee report. Concerns were raised about the affordable housing crisis, the absence of a national universal, single-payer pharmacare plan, the lack of comprehensive measures for real action on climate change, the lack of action on tax evasion and tax havens, the repeated calls for a Royal Commission into the Tax System, the lack of action with regards to the large, foreign-owned web giants like Facebook and Google and the profound under-funding of critical infrastructure in Indigenous communities.

The report contains too few recommendations for significant funding for First Nations, Inuit and Métis communities and infrastructure. In education particularly, funding should be substantial to put an end to massive inequalities in this area that penalize Indigenous peoples. In general, the recommendations in the FINA report do not appreciate the extent of the inequalities suffered by Indigenous peoples and do not offer any solutions to redress them.

Basically, a whole series of common sense social recommendations from witnesses who were not listened to and the NDP are missing from the Finance Committee pre-budget 2019 report. Extending compassionate care benefits by adding a two-week bereavement period, eliminating tuition fees for post-secondary education, setting the federal minimum wage at \$15 per hour: all these measures and more are missing in the pre-budget report delivered by the majority of the Finance Committee. Resources exist: the recent announcement of \$14 billion in tax cuts for large corporations in the mini-budget attest to this.

We need a federal government with a vision that takes our future seriously, like targeting the growing inequality between the wealthiest and everyone else, eliminating fossil fuel subsidies, investing in clean energy, meeting Canada's emissions reductions targets under the Paris Agreement, closing tax loopholes for the super-rich, and investing the recovered revenue for instance to lower the cost of prescriptions medicine for all Canadians.

It's time this Liberal federal government get their priorities straight and stop wasting taxpayer money on the massive pipeline purchase when they could be putting that money to good use in improving the lives of Canadians from coast to coast to coast and by taking concrete steps with First Nations, Inuit and Métis people towards reconciliation

I need your support to have your voices heard in Parliament. The affordable housing crisis continues to affect the well-being of many members of our community in New Westminster-Burnaby and other regions of Canada.

The mini-budget presented by the finance minister on November 21, 2018, gave nearly five billion dollars next year and fourteen billion dollars overall in Christmas gifts to the corporate sector and not a dime to address the urgent housing crisis.

Instead, the government should put three billion dollars

immediately into building affordable housing and announce an emergency housing plan right across the country to make sure that all Canadians have a roof over their heads as soon as possible. We must keep the pressure on to persuade the Trudeau government to act decisively and address this important matter of health & quality of life.

I therefore invite you to sign the-petition, e-1954 (affordable housing), which I am sponsoring, calling on the Government of Canada to allocate money now for affordable housing to address the housing crisis, aggravated by the current cold wave, linked to climate change, instead of giving billions of dollars to the corporate sector through tax breaks; and

to immediately accelerate funding for affordable housing and announce an emergency housing plan right across the country to ensure that all Canadians have a safe, affordable place to call home, and that no-one is left out in the cold.



I invite you to share this information as broadly as possible by emailing this link to your friends and the community. **This e-petition is open for signature until April 6, 2019, at 12:37**

p.m. (EDT) after which it will no longer be available for signature.

Until then, let's gather as many signatures as possible to help make sure that the government takes this issue seriously. We will need to get at least 500 signatures so that I can present the e-petition in the House and receive a government response within 45 days. The House of Commons

will keep your names and contact information confidential and purge all records after I table the electronic petition in Parliament.
