

# Making Rainbow Families





## **Ways to start your family**

There's no one way to grow a family - and every path is special and unique. Whether your journey includes fertility treatments, surrogacy, adoption, or fostering, what matters most is finding the option that feels right for you.

Here are some of the ways people in Australia start or build their families.

#### **Home Insemination**

Ideal for people with a uterus, regular cycles, and access to a known donor. Simple and low-cost, but legal advice and STI checks are recommended.

#### Intrauterine Insemination (IUI)

A fertility clinic places sperm directly into the uterus around ovulation. Less invasive than IVF and often a first step for many families.

#### In Vitro Fertilisation (IVF)

Used when IUI is not successful or when early intervention is preferred. Involves medication, egg collection, fertilisation in a lab, and embryo transfer.

#### Surrogacy

Used when carrying a pregnancy is not possible. Legal in Australia only if altruistic. Embryos are created via IVF and transferred to the surrogate.

#### **Fostering and Adoption**

Both are legal for LGBTQ+ families in Australia, but can involve discrimination or complex processes. International adoptions have strict criteria.



## **Choosing a Donor**



#### **Anonymous Donor**

Donors accessed through clinics. Safe, with minimal legal complications. Donor details are limited and children can usually access more info when older.

#### **Known Donor**

Can be a friend or someone met online. Lower cost and potential for ongoing relationship, but needs careful planning. Agreements are not legally binding.

#### **Becoming a Donor**

You can donate to someone you know. Understand the health risks and emotional responsibilities involved.

### **How to do home insemination**

- Track your cycle for three months. Use a fertility app, and monitor temperature and cervical mucus.
- At ovulation, use a sterilised container and a needleless syringe or menstrual cup.
- Keep semen warm and inseminate within 30 minutes.
- Lie with hips raised for 15 minutes afterward.
- Discuss expectations with your donor and get STI tests. Consider a written agreement.

## **Legal Considerations**

Family law around donor conception and surrogacy varies across Australian states and territories.

- In most states and territories, known donors do not have legal rights or responsibilities for the child.
- De facto and LGBTQ+ couples may both be recognised as legal parents depending on their state or territory laws.
- Solo parents and those exploring surrogacy are encouraged to seek independent legal advice early in their journey.

- It is illegal in Australia to pay someone for their sperm, eggs, or to be a surrogate.
- However, you can reimburse reasonable outof-pocket expenses such as medical costs, travel, accommodation, counselling, and legal fees related to the process.
