**emails indicate that on 7 October 2010, Andrew sent Epstein details of his official upcoming trips as trade envoy to Singapore, Vietnam, Shenzhen in China and Hong Kong, where he was accompanied by business associates of Epstein.**

**After the trip, on 30 November, he appears to have forwarded official reports of those visits sent by his then-special assistant, Amit Patel, to Epstein, five minutes after receiving them.**

**on Christmas Eve that year, he emailed Epstein a confidential briefing on investment opportunities in the reconstruction of Helmand Province, Afghanistan, which was overseen at the time by British armed forces and funded by UK government money.**

**In a further email dated 9 February 2011, Andrew suggests Epstein might invest in a private equity firm he visited a week before.**

**Official terms of reference for trade envoys state that they "are not civil servants", adding:**

"However, the role of a Trade Envoy carries with it a duty of confidentiality in relation to information received. This may include sensitive, commercial, or political information shared about relevant markets/visits.

"This duty of confidentiality will continue to apply after the expiry of their term of office. In addition, the Official Secrets Acts 1911 and 1989 will apply."
