Who is the Right to Counsel NYC Coalition?

- Tenants, organizers, advocates, legal service providers, fighting to address the eviction crisis and the injustice of Housing Court
- Won the Right to Counsel in 2017 after a 3 year grassroots campaign





The Power of RTC

- 85% of tenants who have RTC stay in their homes
- More tenants fight for their rights because they have RTC: Tenants show up to court more, raise defenses and <u>take proactive</u> <u>steps</u> to defend their rights
- Eviction Drop and Landlords Sue Tenants Less. For example, evictions declined more than 5x faster in RTC zip codes than in similar ones in RTC's 1st year




Right to Counsel in Crisis: Causes + Impact


- With the expiration of the eviction protections + the national labor shortage, there are not enough attorneys to represent tenants at the pace that landlords have set and that the courts have facilitated
- The courts are moving cases forward without RTC.
- The Result: More than 30,000 households have faced alone since 2022. That means about 55% of tenants in court are unrepresented. Most are entitled to RTC.



Rates of Representation By District




Manhattan Representation Rates


Bronx Total Case Numbers



Queens Total Case Numbers



Brooklyn Representation Rate






Brooklyn Total Case Numbers

Our Solutions

• PAUSE ALL CASES UNTIL TENANTS GET RTC

• FULLY FUND RTC

- Local Law 136- to hire an retain adequate number of attorneys
- Local Law 53- funds organizing groups to educate tenants on their rights

• PASS STATEWIDE RIGHT TO COUNSEL (A1493/S2721)

- Covers all tenants across NY State in all cases
- Mandates Adjournments until tenants get RTC
- PASS DEFEND RTC LEGISLATION (A4993/S3254)
 - Mandates adjournments until tenants get RTC

What Can City Council Do?

- Sponsor and Pass our Resolutions!
 - Resolutions 499 and 345
- Fully Fund RTC!
 - Local Law 53: \$3.6 million
 - Local Law 136: \$320 million
- Publicly Support our Demands!
 - Attend our rallies, write about and speak on the crisis of evictions
- Help us win our Statewide Legislation in Albany!
 - Help us lobby your colleagues in the state legislature
