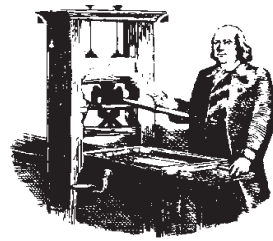

# Sare Takes Drive for Ballot Status to Streets

NEW YORK, April 15—As this issue of the *New Federalist* goes to print, supporters of LaRouche Independent candidate for U.S. Senate from New York Diane Sare are assembling forces across the state to launch the drive to collect 45,000 valid signatures of registered New York voters to place Sare's name on the Nov. 8 midterm election ballot, opposing the incumbent Senator from Wall Street, Chuck Schumer (D-NY). They will take to the streets, shopping centers, post offices, and other locales when the petitioning begins on April 19, the 247th anniversary of the Battle of Lexington and Concord, the battle that opened our successful War for Independence from the British Empire.

As has been covered in previous issues of this paper, this signature requirement is absurdly high—triple the previous requirement—while not adding additional time to gather the signatures. The new standard was quietly inserted in the 2020-21 New York State budget by the Democratic leadership, with ostensible approval from the GOP, to prevent "frivolous" candidates from receiving matching funds, and effectively making ballot access impossible for all but the Democratic and Republican party-nominated candidates. However, since Federal candidates do not receive these matching funds, and since the new \$100 million matching fund jackpot will not be available until the 2024 election cycle, it appears that the true intent of

the onerous new requirements is to silence political debate, and to ensure that incumbent candidates are never held to account for their destructive policies.

In 2022, this is all the more important because we are at a turning point in human history; we are facing a real threat of thermonuclear war, as the Biden Administration and NATO insist on provoking Russia and arming the Ukrainian Nazi forces to the teeth, rather than encouraging a negotiated settlement which respects Russia's legitimate security concerns.

The accompanying economic sanctions are emphatically acts of war, and are wreaking havoc on the world food supply, raising the specter of famine for up to one billion people (see article, page 1), while bringing on hyper-inflationary prices for food, fuel, fertilizer, and other necessities. This is pushing poor and middle-class Americans over the economic cliff.

### Restoring Economic Sanity

Sare, an accomplished musician and choral director, is a 33-year associate of the late economist and former Presidential candidate Lyndon LaRouche. She is campaigning to reverse the monetarist eco-

omic policies that have destroyed the United States and the so-called "western world" ever since Nixon pulled the U.S. dollar from the gold-reserve system on Aug. 15, 1971, a move that collapsed the post-war Bretton Woods monetary system and created a global monetary casino. She advocates

enacting LaRouche's Four Laws (<https://www.sareforsenate.com/economy>) to bankrupt the speculators and restore a commitment to science-driven industrial and agricultural production, as well as developing breakthroughs in advanced forms of energy production, such as fusion power.

As a result of the crisis and of Sare's outspoken commitment to LaRouche's program, her campaign has attracted hundreds of volunteers from every walk of life: all age groups and every corner of the State. They will be deployed by a team of experienced

## EDITORIAL

### The Importance of My Campaign, Now

Whether there will be anyone left alive to vote in the November 8, 2022 midterm elections is an open question. Therefore, one might ask, "What is the significance of a campaign for United States Senate at this time?" My campaign for U.S. Senate vs. the warmonger from Wall Street, Chuck Schumer, is dedicated to ensuring that not only are we alive to vote in November, but, by that time, we should be on the road to the greatest peacetime economic recovery in history.

Neither possible outcome—that of general thermonuclear war combined with starvation and economic collapse on an unimaginable scale, nor the creation of a new security and development architecture that respects the sovereignty of all nations—is an exaggerated possibility. We are at the *punctum saliens* which Lyndon LaRouche warned decades ago would arrive. The post-industrial New Age economy, and the speculative monetarist system that bred it, have come to the lawful end of their existence—there is literally nothing left to loot in the trans-Atlantic world.

### Looting vs. Development

The Global-Britain "Great Reset" crowd would like to be able to loot Russia, China, India, and others, at the point of a nuclear tipped missile, but these nations aren't willing to play

along. With upwards of 1 billion people on the planet currently on the brink of starvation, and millions of people already dying in Afghanistan, Yemen, and elsewhere, President Putin commencement prior to the military action in Ukraine, "we have been pushed back so far, there is nowhere else to retreat." That policy of NATO expansion and its "rules-based order," where Prince Charles, the U.S. State Department, and the military-industrial-media complex make the rules, is what provoked Russia's action in Ukraine, and this action cannot end until an agreement is reached which takes into account Russia's legitimate security concerns. Since Russia clearly has a vast military superiority over Ukraine, unless NATO were to enter the war, a Russian victory is inevitable. The only question is: how much of Ukraine the egomaniacal President Zelensky is willing to sacrifice to appease his western controllers who also control, fund, and arm the Nazi storm troopers—such as the Azov Battalion—who are committing war crime atrocities against Russian prisoners and Ukrainian civilians alike. # Conference Proposes New Security and Development Architecture

NEW YORK, April 17—In 1922, in the aftermath of the self-cannibalization of Europe known as the First World War, the subjugated nation of Germany and a "pariah" new power, called the Soviet Union, secretly negotiated a treaty at the Italian resort city of Rapallo. One hundred years later, on April 9, the International Schiller Institute convened a "Conference for the Creation of a New Security and Development Architecture for All Nations." (Watch the conference at [bit.ly/3rJkErT](https://bit.ly/3rJkErT).) Over 3500 people attended the all-day virtual affair, and the spirit of 1922 Rapallo, and of Westphalia, 1648, was the implied, higher-order reference point.

The Rapallo Treaty, had it been implemented after it was successfully negotiated on April 16, 1922, might well have overturned the predatory banking and financial order that led that very year, to fascism in Italy, and, seemingly inexorably, to 60 million-plus deaths in World War II. But that was not to be. So today, the wor-

thy efforts of many nations to reject the evil sanctions practices of the City Of London and of Wall Street/Washington—responsible for the deaths of more than 14,000 children in Afghanistan since the September pullout of American troops alone—will fail, unless a new world architecture, designed in the interest of all nations, supplants the modern Versailles-like debt-collection system that calls itself "the NATO alliance."

Rapallo, had it been implemented, would have not only liberated Germany and the USSR from the economic thralldom intended for both by the Anglo-French Entente and its newly-"Anglophiled" American partner. (The United States, represented by Alan and John Foster Dulles of Sullivan and Cromwell, who sponsored Hjalmar Schacht, who became head of the German Reichsbank and later the finance minister for Nazi Germany, was in this instance, on the wrong side of history.)

Rapallo was a win-win strategy. The treaty called for Germany to recognize the fledgling Soviet Union and for the latter to cancel the war reparations "owed" to it by Germany which had been stipulated at Versailles. Each committed to the rapid development of the other, exchanging the advanced industrial plant, equipment, and technological know-how of Germany for the vast raw materials, natural resources, and potentially vast food supplies of the Soviet Union. This would have resolved the problems which, less than two decades later, provoked the deadliest war in human history.

The treaty was signed; soon, it was extended to all the Soviet republics, including Ukraine. The

*next war was not inevitable.* Recognizing this, the Anglo-French imperial powers, who wanted subjugation, wanted hyperinflation and austerity, and wanted war, loudly objected. Two months later, Walter Rathenau, the German foreign minister who had been largely responsible for this achievement, was assassinated, and the Rapallo agreement was killed; in its place Germany attempted to fulfill the Versailles-dictated reparations payments by printing money, thereby unleashing a devastating hyper-inflation which crushed the German nation and created the conditions for the rise of fascism.

### No Schemes Will Work

An important theme emerging from the Schiller Institute's day-long conference is that today, no scheme to create competing systems of finance and defense, no version of "digital geopolitics," "cyber-geopolitics" or "old-time geopolitics" can lead to anything

but thermonuclear war. The first three speakers set the tone for the day's deliberations, held in the shadow of impending world war, potentially civilization-destroying pandemics, and a dangerously anti-human "save the planet, kill the people" Green Malthusian disease sweeping the trans-Atlantic world.

Founder and head of the Schiller Institute, Helga Zepp-LaRouche opened the conference with the following words: "Dear conference participants from all over the world! What brings us here together today, with participants from over 60 countries from four continents, is our utmost distress that the very existence of humanity is in grave danger. The aim of our conference is to arouse the awareness of ever-larger social forces around the world, that because of the danger of the presently escalating strategic confrontation, there could soon be a full military engagement

## Sare: End Trans-Atlantic System Before It Kills 1 Bn

NEW YORK, April 12—Independent LaRouche candidate for U.S. Senate from New York Diane Sare said that the startling revelation by several authorities that: unless there is a dramatic change in policy, 1 billion people face death from a combination of famine and disease in the year ahead, demands that we dump the bankrupt and collapsing Trans-Atlantic financial system now, and replace it with

new system, one based on development that can address this grave humanitarian crisis.

While leaders such as David Beasley of the World Food Program have been sounding the alarm bells of this crisis for some time, there has been little or no response from institutions of global finance or the plutocratic billionaires and speculators who have looted the current system. With the war in Ukraine has come the

devastation of one of the world's key suppliers of wheat and other food stock, while the sanctions regime against Russia has cut off enormous supplies of food and fertilizer. This, along with parasitic commodities speculation, has contributed to soaring inflation in food prices and prospects for severely reduced global crop yields.

There has been a similar speculation-driven spike in energy and

## Sare Fights for Veterans' Facilities, Care

On April 4, the anniversary of Dr. Martin Luther King's speech attacking the moral bankruptcy of the Vietnam War, which he delivered at Riverside Church in Manhattan in 1967, exactly one year before his assassination, LaRouche Independent candidate for U.S. Senate Diane Sare joined a group of black veterans for a press conference to demand that veterans receive the facilities space and care they need and deserve. Biden Opposes It

House Passes Pot Legalization; Will Schumer Push His Pot Bill Now?

WASHINGTON, D.C. April 10—Ten days ago the House of Representatives, many of whose members smoke marijuana, passed legislation that would decriminalize pot smoking and help set up a multi-billion-dollar commercial pot industry. The Marijuana Opportunity and Expungement (MORE) Act, which narrowly passed on mostly a party line vote, 220-204, would also remove pot convictions from people’s criminal records.  
The House action immediately raises the question whether Congress’ leading dope pusher, Senate Majority leader Chuck Schumer (D-NY), intends to make good on

his pledge to act on his similar, and more extensive legislation in the Senate this Spring. Sources reported that Schumer was told by President Biden to pull his legislation from the Senate agenda, stating that he feared it would adversely affect other parts of the President’s agenda, which Biden has been unable to move forward, including the whole Build Back Better program. Biden is reported to be angry with Schumer about his failures in promoting the President’s agenda and his inability to get his key legislative items passed.  
**Will Schumer Push On?**  
Sources close to Schumer say that the Senate’s chief pusher plans to defy the President and push

ahead with his legislation, which political analysts say has almost no chance of passing. Given defections on the Democratic side, he might have to secure more than 10 GOP votes to get his pot bill through. And if he should do this, there is every reason to believe that Biden, who has a strong record of opposition to pot legalization, would veto any bill placed on his desk. The President has promised various police unions that he would do this, which is something he also said during the campaign.  
Biden signaled his continued opposition to legalization and commercialization in his 2023 budget, released March 28. It does not extend Justice Department pro-

tections to legal marijuana states, meaning that Federal resources can be used to enforce marijuana laws. It allocates significant funds towards stopping marijuana traffickers operating on vast federal lands, while it also allocates more money for drug prevention efforts than ever before.  
**Sare: Remove Schumer**  
“So, now we have this pothead, Chuck Schumer, potentially defy-

ing his own President, Joe Biden, to push his dope legalization agenda,” said LaRouche Independent candidate for Schumer’s seat, Diane Sare. “If that happens, then it is because Schumer is getting the word from his real bosses, the pot and crack heads of Wall Street, who want to create a new potential multi-score billion-dollar pot industry, where some new profits can be raked in at the cost of the well-being of our children and others who will become slaves to addiction, or worse.”  
“I urge voters to be extra vigilant and to voice their disapproval of this dangerous legislation and to join me in my campaign to remove the Congress’ chief pusher for Wall Street, Chuck Schumer, in the coming election,” Sare concluded.

The Schiller Institute Petition

NEW YORK, April 15—Since February 23, a call by the international Schiller Institute to “Convoke an International Conference to Establish a New Security and Development Architecture for All Nations” has been circulating in the form of a petition in twelve languages worldwide. Over 200 prominent individuals—retired military, medical professionals, journalists, elected officials, academics, farm leaders, scientists, engineers, political leaders from over 50 countries—are among the over 4,000 who have signed the petition.  
The petition reads in part:  
“In light of the escalating Ukraine crisis, people around the world are urgently asking themselves and their political leaders, ‘Where will this all end? Is this heading towards a very big, perhaps even thermo-nuclear, global confrontation? Will Mankind even survive?’  
“Behind this very real danger and the cause of that danger, is the blowout of the entire trans-Atlantic financial system. A nearly \$2 quadrillion speculative bubble of derivatives and debt is already blowing apart. A hyperinflationary process has been unleashed globally, with an accompanying collapse of the physical economies of the Western nations. The City of London and Wall Street, the owners of that bankrupt system, are desperate to destroy any functioning alternative to their system—such as Russia and China’s alliance around the Belt and Road Initiative, which now incorporates nearly 150 nations—and the financial Establishment has openly stated that this is what is at stake. So has Vladimir Putin, who has correctly said that the U.S./U.K./NATO relentless expansion eastward up to Russia’s very borders, is driven by this economic policy, and that it threatens Russia’s national security in ways Russia cannot accept.  
“To stop the drive to world war, humanity must adopt a more fundamental approach, which is to establish an entirely New Paradigm that will ensure the security, and the economic development, of every nation on the planet. The only recent precedent for this in the West, is the 1648 Treaty of Westphalia, which put an end to 150 years of religious wars in Europe. It was crafted only at the point that all parties realized that, if they continued on their current path, there would be no winners and very few survivors. They chose to create a New Paradigm based on the defense of the interest of the other, and on the premise that the security of all was the first requirement for the security of each party.  
“That is the key lesson of the Treaty of Westphalia for today. The world today stands at a similar crossroads. If the current geopolitical policies continue, nuclear war becomes a very real possibility—after which there will be no winners, most probably no survivors.  
“Instead, an international conference must immediately be convoked along the lines of the Peace of Westphalia. The fundamental interest of all of the parties is to ensure that the central economic and security interests of each are taken care of—in other words, an order based on the benefit of the other, on the common good or the General Welfare, and on an underlying love of all Mankind.  
“The economic system must also be drastically reshaped to express this outlook. The renowned American economist Lyndon LaRouche specified in great detail how such a system would work, based on what he called his ‘Four Laws’.”  
The Schiller Institute and its founder Helga Zepp-LaRouche have issued this call to initiate the urgent international discussion that is needed to convoke such a conference, and to stop the so-called “Doomsday Clock” before it strikes midnight. It’s time for individuals and institutions from every nation to step forward and join the mobilization for an international conference to establish a new security and development architecture for all nations.



Amazon Union Victory Exposes AOC as Fraud

**Recycling Workers**  
Sources familiar with Amazon’s labor practices say that the company practices the “recycling” of workers, creating conditions that cause workers to quit or get fired after a period of time, following which they can be replaced by new lower-paid workers. The lack of union protections makes such

While not yet confirmed by the National Labor Relation Board, the vote margin of around 500 votes appears to be unassailable, despite claims of unspecified irregularities by the company. The leader of the union, Christian Smalls, who had been fired by Amazon and waged what the media considered a long-shot effort to create a union, found such claims laughable, given the outright threats and intimidation that had been used against ALU organizers, especially over the last weeks leading up to the vote. According to various press reports, demands include “higher wages, longer breaks, paid sick leave, and paid time off for injuries sustained

practices easier to conceal, which is why the company has waged such a fight to prevent unionization. Their efforts were successful until this vote in Staten Island, labeled by the New York Times as “one of the biggest victories for organized labor in a generation.” Bloomberg fretted, “Amazon Union Win in NYC Holds Potential to Spread Far and Wide.”  
**AOC Backs Out**  
Smalls and his organizers did this without the support of any national union. And according to Smalls, they also did this without any real support at a critical time from AOC, who tried to climb onto the union bandwagon only after the victory. AOC had promised to be a featured speaker at a crucial union rally last summer, only to back out at the last minute, claiming sched-

uling and security concerns. She was then seen not long after at a party drinking and dancing, and later at the Met ball.  
Krystal Ball, a host of the left-leaning “Breaking Points” podcast tore into AOC. She tweeted out a video of Smalls attacking AOC’s duplicity about the rally saying, “Here’s the guy who organized the union drive talking about how you left them high and dry.”  
AOC, then bizarrely tried to claim she was not responsible for going all out for the union because these were not her constituents. That angered Smalls even more, and he tweeted: “Smh @AOC that’s terrible workers from your district definitely commute to Staten Island I know them personally maybe you should do your do diligence.”  
**AOC and Bezos?**  
Sare, who had attended the rally and fully supported the organizing drive, said that AOC’s behavior towards the union could possibly be explained by someone reminding her that Jeff Bezos, the founder of Amazon, who set its labor policy, is also the owner of the {Washington Post}, which has been the principal promoter of AOC and her so-called Squad, giving her national prominence. “Maybe this tells us about who might own AOC. Certainly not her constituents.”  
AOC has tried to counter such insinuations by pointing to the role she played in ending a deal to place Amazon’s second headquarters in New York City. But, some insiders have speculated that Bezos had wanted out of that deal when he realized that former Mayor Bill “the Dude” DeBlasio would be unable to really deliver on any of the promises made to secure it. “Who does AOC really represent,” challenged Sare, who is running against incumbent Chuck Schumer (D-NY). “Herself? Certainly not the people of New York, or her newly unionized constituents.”

Propose New Security, Development Architecture

between NATO and Russia leading to a world war, which, in all likelihood, would mean the annihilation of mankind in a following nuclear winter. The aim of our conference is therefore to demonstrate, in the most powerful way, that there exists an immediately accessible alternative, a new paradigm, which can leave that mortal threat behind us, and begin a new era of human history, in cohesion with the true nature of mankind as the only species known so far [to be] capable of reason.”

**Where Is Our Reason?**  
Humanity’s capability for reason, however, might be questioned, judging from the shameless, self-righteous posturing which substitutes for competent policymaking in the trans-Atlantic world under the pretext of the so-called “Russia-Ukraine crisis.”  
In the days after the conference, former Australian ambassador to Cambodia (1994-97) and Poland (1991-94) and lifelong diplomat Tony Kevin wrote, in an article called, “Lies, Truth, and Forensics in Ukraine: The Case of Bucha”: “It is a daunting task now, 11 days after the news on April 4 of the alleged massacre by Russian soldiers of up to 200 Ukrainian civilians in Bucha—and hundreds more by the Kiev regime’s count—to challenge the Russian atrocity narrative, so firmly is it now lodged in the minds of Western readers... But let me try and introduce the subject this way with some general propositions.  
“I assert that Ukraine’s present government, centered in Kiev and Lvov, is now so extreme-nationalist in its avowed ideology and style of governance that it can fairly be described as a kind of fascist or Nazi regime. Under its governance and under the pressures of an increasingly cruel and desperate war, Ukraine is reverting to savagery. Yes, I know President Zelensky is of Jewish ethnicity—but this is politically irrelevant. The important thing is that he is the puppet and mouthpiece of a thick layer of extreme nationalists—‘Ukronazis’ may be the justified term—who are now strategically embedded into Ukrainian government, the armed forces, and the police at all levels, such that they are in position to drive Ukrainian policy and governance.” (For a related article, see editorial page 3)  
Even more alarmingly, the nations of Europe as well as the United States, Canada, New Zealand and Japan—what is called the “Anglosphere” by some, and “Oceania” by others of a more explicitly Orwellian bent such as British historian David Starkey, are now engaged in a triumphalist, massively expensive, headlong rearmament; a recruitment of more nations to NATO, which should have been disbanded in 1991; and a new, bellicose re-division of the world in the middle of an evolving and little-understood pandemic.

**Russia Speaks**  
Notably, Zepp-LaRouche was immediately followed by H.E. Anatoly Antonov, Russian Ambassador to the United States, who began: “Lately, NATO’s military activity has considerably intensified. About 40 major military exercises are held annually near Russian borders. The forces of the North Atlantic Alliance are exploring the Black and Baltic Seas. By the way, according to the latest estimates of the Stockholm International Peace Research Institute, the combined military expenditures of NATO countries exceed Russia’s defense budget by at least 25 times.”  
Amb. Antonov described the Russian policy-outlook: “Today it is extremely important to achieve the demilitarization and denazification of Ukraine: to consolidate Kyiv nuclear-free status and its commitment to international agreements on the nonproliferation of weapons of mass destruction. We must do everything to prevent the undermining of the NPT [Treaty on the Non-Proliferation of Nuclear Weapons]. There should be no threat to the Russian Federation coming from the Ukrainian territory. This is the objective...”  
He was followed by Sam Pitroda of India, a former cabinet minister, advisor to seven Indian heads of state, and advocate of Gandhian non-violence, who proposed a re-design of the entire present international order. “Today’s security order is based on command and control, as opposed to collaboration, cooperation, co-creation, and communication. Today’s world order is also based on total commitment to power and profits, as opposed to what is good for the planet, and what is good for people... I believe that in the hyper-connected world of today and tomorrow, when all 8 billion people are essentially connected, we need a New Paradigm.”  
The plenary panel, featuring Minister Pitroda appearing on the same panel with Ambassador Antonov and with other speakers from South Africa, China and Europe, demonstrated the Schiller Institute approach—“the coincidence of opposites.” This is a dialogue method in which the objective is to reach a higher understanding—not consensus—among people of demonstrably different views, as to how a policy of security through development could be evolved for the whole world, in time to prevent thermonuclear war. The “new paradigm” must find a way to use economic progress to promote the General Welfare for humanity and humanity’s posterity in every nation in the world.  
**Promote the General Welfare**  
The remainder of the confer-

ence was devoted to identifying the needed scientific, economic, financial, and cultural breakthrough conceptions to accomplish this for the world as a whole. Presenter Princy Mthombeni, the 29-year-old founder of Nuclear4Africa reported: “In South Africa, more than 10 to 24 gigawatts of energy capacity is expected to be decommissioned post 2030. And this is mainly due to aging coal power plants, which is a concern for the country, as this will mean that these will have to be replaced with another baseload power source. In

a country where water scarcity is a major challenge, this makes the option of hydropower almost impossible, and that leaves the country with nuclear power as one of the options.  
“Ladies and gentlemen, it is really interesting to see many African nations recognizing nuclear power as a key player in achieving Africa’s Agenda for Sustainable Development, because, in all honesty, one cannot talk about sustainable development, or even civilization, while millions of people are still living in poverty and are still without access to electricity and clean water. Therefore, nuclear is well-positioned to help address these challenges.”  
No conception of a new security architecture based on economic development can be successful, however, which does not overturn the dominant conceptions of money and credit. As economist Lyndon LaRouche warned: “The popular conception of money by governments and by leading institutions is insane.... The value of money should be determined by a scientific principle, not an accounting principle. And the scientific principle is, what is a physically defensible determination of the will of governments and the ability of governments to perform, in creating credit, over the long-term, for the development of their economies and their productivity? Knowledge of the determination and competence of the government to create value, to create wealth, and to have sufficient wealth to repay the debt you are creating in a timely fashion. This is a physical question, not an accounting question.”

hilate 90% of the world’s popula- tion could provoke the reaction foreseen by poet Percy Bysshe Shelley in his “Masque of An- archy”—the people realize that compared to their oppressors, “We are many, they are few.” Inspired by the combination of President Putin’s action, necessitated by the provocations orchestrated by the Anglo-American elites, and recognizing that the Chinese are “next on the chopping block” (as Senator Schumer and insane lead- ers in the U.S. military establish- ment have clearly stated), dozens of nations have refused to join the criminal sanctions regime against Russia. They have less than nothing to gain by remaining allied to a bankrupt, saber-rattling US/UK/ NATO murder machine.

**Towards a Just, New World Order**

The leaders of Russia, China, India, Pakistan, South Africa, In- donesia and many others have not only refused to join the sanc- tions regime against Russia, but are now moving away from the British controlled petro-dollar as the world’s reserve currency. After the United States stole the money of the central bank of Af- ghanistan, and then stole \$300 bil- lion of Russian foreign currency reserves, why would any nation

want to put its savings into a west- ern bank in U.S. dollars? Taking for granted that nations are going to stick with the globalist “rules based order” and not join forces and create their own new just economic order—especially con- sidering that they represent not only the majority of the world’s population, but the majority of the production of most of the world’s raw materials—is a bit like think- ing that American voters would vote for Hillary Clinton in 2016.

This revolt occurring among leading nations of the world must be joined by a similar revolution from within the United States. The War in Your Pocket, Continued

*The following is another in our series of reports on psychological warfare being waged against the population of the United States and the world. We will present another report in our next edition. They are titled “The War in Your Pocket,” referring to the fact that the main device used in your brainwash- ing is your smartphone. For the first time in history, a war is being brought to the eyes of the world in real-time, but not in reality.*

On April 2, media sources in the west carried a video released by the Ukrainian National Police depicting victims of atrocities al- legedly committed against civil- ians by the Russian Army. The raw video taken from a moving vehicle showed the victims as they appeared in the streets of the Bucha suburb of Kiev, from which the Russians had recently withdrawn. The images were lurid and disturbing, and the video, in part and in whole, rapidly became the highest circulated media on the internet. Cries went up from Ukrainian government officials demanding that a war crimes in- vestigation be undertaken by UN authorities against the Russians, while a shocked President Joe Biden called for similar action and reiterated his branding of Russian President Putin as war criminal.

Various commentators drew parallels to the Nazis, while the absurd British Prime Minister Bo- ris Johnson said that Putin could now be fairly compared to Hitler. He called for more support from NATO and the United States for the “courageous” Ukrainian free- dom fighters resisting Putin’s Nazi aggression.

Now, take a deep breath, and think for a moment, stepping back from this highly emotional, mass brainwashing campaign. Why would the Russians slaughter un-

armed, and in some cases bound, civilians? How would that ben- efit their cause? Anticipating such questions, the pundits claimed that these were the acts of an in- vading army seeking to annihilate Ukraine and its people. But that is not the goal of this “Special Mili- tary Operation” as the Russians call it, and never could be.

**Is the Opposite True?**

Instead, we have what could very well be the exact opposite of what is alleged by the British-NA- TO brainwashers. A *deliberately staged* video, intended to fuel the anti-Russian brainwashing campaign and to win over world public opinion. Who might be re- sponsible? Well, when something looks like it was done by Nazis, why not look at some of the real Nazis on the scene: the ones who wear swastika armbands the the followers of the pro-Hitler Ukrai- nian, Stefan Bandera. The several thousand members of the Azov Battalion are real honest-to-good- ness Nazis, carrying US-supplied weapons. Think of them as the equivalent of Hitler’s Waffen-SS units. There are units of the Azov Battalion that have been trained in terror warfare and who have exhibited documented savagery against ethnic Russian popula- tions in the Ukraine for some time; they have brutally killed thousands in the eastern Ukraine, including the Donbass region.

There are video interviews, not widely circulated on the net be- cause they contradict the “party line” on the war, in which Ukrai- nians have reported that Azov members have killed civilians, and in some cases used the bodies as props for interviews with fawn- ing western media, claiming that “Putin’s savages” have done this. Civilians have also complained that Azov terrorists attack Rus- sians and then use innocent by-

standers and residents as human shields, a tactic of the Waffen SS.

The images in the Bucha video are intended to both terrify the viewer and appeal to his or her emotions. They are so disturb- ing, especially when presented on the intimate screen of one’s cell phone, as to produce an emotional response that overwhelms actual critical thought—precisely what is desired by the brainwashers. That can last a long time, if there is no alternative narrative present- ed to shatter the brainwash effect, through cognitive dissonance.

But there are some people who see through the heavy fog of war propaganda. One of those is Scott Ritter, the former UN arms con- trol inspector, who had the cour- age to challenge the brainwashing narrative at that time about Sad- dam’s weapons of mass destruc- tion. Here he speaks of the video revealing atrocities committed (allegedly by Russian forces) against the civilian population of Bucha in Ukraine.

**Visceral ‘Shock and Awe’**

“The video has been released in its present form, it appears, with the express intent of producing a visceral “shock and awe” moment for the viewer,” Ritter wrote April 6. “If this was indeed the case, then those who released it—the Ukrainian National Police—have succeeded beyond their wildest imagination. Or that of their advi- sors, as the case may be.”

He does not say who those ad- visors might be, but we can: the same masters of deception and brainwashing that we identified in our last edition, the British psy-warriors of GCHC’s Joint Threat Research Information Group (JTRIG) and their Ameri- can counterparts in the NSA/CIA complex.

On March 23, 1983, in an address to the nation, President Ronald Reagan suddenly announced that it was his intention to end the long years of nuclear nightmare and ask our scientists to come up with a way “to render nuclear missiles impotent and obsolete”—that it was better to save life, than wage a thermonuclear war that might kill everyone. The President said that he would offer to develop this technology with our adversary, the Soviet Union, as well as use it to develop the civilian economies. This was the Strategic Defense Initiative, with its promise to cre- ate the ability to use a multi-tiered, space-based system of powerful high-speed lasers (beam weapons)

to shoot down nuclear missiles, including in the boost phase. Not known at the time, Lyndon La- Rouche, one of the theoretical de- signers of the SDI, along with Dr. Edward Teller, the father of the H- bomb, were negotiating on behalf of the President to try to win Soviet acceptance of the President’s offer. Unfortunately, the Soviets under Premier Andropov rejected the offer in favor of trying to develop their own version, a move which LaRouche warned would collapse the Soviet economy and doom the future existence of the Soviet Union—a warning which events were to prove true.

Some 39 years later, on March 24, 2022, an organizer identified as “Chris from Florida” asked during the LaRouche Fireside Chat, “What can I do in the present grave world crisis? How can I be effective?” Dennis Speed, long-time LaRouche associate and political

leader, answered Chris as follows [his remarks have been slightly ed- ited]:

“OK. We got you. The basic conception is that we know that as of Jan. 6 of last year, it became evident to a very large number of people—tens of millions—that something different had happened in the country.

“We know this. And we knew that this meant different forms of action had to be taken. With that said, the problem is that in order to do that, you require a certain kind of planning and you require a cer- tain kind of candidates, who have to be independent, in my view—that is, independent of the Demo- crat and Republican parties. The

reason you have to be independent is because you have to get a back- light, so to speak, on who, exact- ly, is committing treason against whom.

“Many call it a duopoly, but it’s really a single party. The major- ity of Americans are either alien- ated from that, or have never even engaged. The problem with the young people, is not that they can’t be caused to be interested, but the issue for them is: “Where’s my fu- ture? What does any of this actu- ally have to do with me?”

“How do we deal with this? I use the term Committees of Cor- respondence—referring to what was organized before the Ameri- can Revolution. These committees were organized by different people in different sections of the colonies in different ways. Massachusetts had one form of it; Maryland had something different. Ben Franklin was the sort-of center of it because

he had created the American postal system. He created the postal sys- tem so they could message one another. Of course, today, we have all sorts of things, many of which are not free: YouTube, and this and that. We know people who have been banned from all of these.

**Gas Prices**

“But, there is a way that we can correspond. But what do we want to do? One thing that has happened in the last month, which is very im- portant, is that people are now, in California, paying \$7.50 for a gal- lon of gas. No way do those peo- ple believe that that is because of Vladimir Putin, because they know that the United States has oil, has gas, and is not getting its oil and gas from Russia.

“Some people are sophisticated enough to know that the prices were going up a year ago. They went up 48% over 2020-21. But that didn’t just appear at all pumps at the same time.

In other words, we are now put- ting [on the order of] \$100 dollars in our gasoline tanks, to fill up.

There is no way that Ameri- cans believe that that is caused by somebody in Russia. I don’t care what they say; I know that they don’t believe it. Now, when you get that—and this is something that we’ve needed, in terms of the present circumstances—where it gets past the politics, the simple politics, of whether you’re a Re- publican or Democrat, red, blur, of any of that stuff—that stuff is sub- ordinated.

“Diane Sare, is running for U.S. Senate from New York; and Joel Dejean is running for U.S. Congress from Texas’s 38th C.D. Other people should start doing this.... We’re talking about a pa- triotic faction in the U.S. But we have to recognize that that patriot faction doesn’t have one way that it looks: It’s black, its white, it’s independent, some of it’s Republi- can, some of it’s Democrat, some of it’s, “I’ve never voted in my life.”

See, that’s what it is. Right? So, what we do is—the reason for the history we give, is that the history is always a way, for us, of taking ourselves out of the heat of the mo- ment and see what’s actually hap-

pening.

**Russia and China**

“For example, let’s take a look at the real issue with Russia and China. On Feb. 4, Russia and China put out a 5,000 word Joint Statement saying OK, people, we have an alliance between us deeper than a regular treaty, and we don’t like the fact that there are groups of people who have military alliances who think they are going to con- tinue to run the world and make incursions on us.

“They said a couple of other things, but the reason they could say this is because China has now, after a couple of decades, become the major economy in the world, because the United States has been looted—by bankers, by vari- ous forms of predators from Wall Street and the City of London.

“About 10-15% of people have been corrupted into a cer- tain amount of that. What do these people think? They think they have an ‘investment.’ They think they’re going to get something out of it. So, they have gone along with that. But now, we’ve gotten to the point that after we did that \$7 trillion last year in the various kinds of manip- ulations around the Coronavirus, now the U.S. owes more money than any government, any nation in history. Either we give up that whole system, repudiate that entire system, or there’s no way that this country can survive.

This does not require a change in our government; it requires an acknowledgement of the powers of the American citizen contained in the Declaration of Independence and the Constitution.

“What does the Declaration of Independence say?

“‘When a long train of abuses and usurpations, pursuing invari- ably the same Object evinces a design to reduce them under ab- solute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.’

“We know that, because of the Preamble to the Constitution, which says:

‘... provide for the common defense, promote the general Wel- fare..., do ordain and establish this Constitution....

“My point is this: The Ameri- can citizen has more power than anybody and most legislators in other countries in the world. But they never get together to use it.

**The SDI**

“What you’re on, tonight, what you’re a part of, tonight, what we’re doing, is we are a move- ment—it goes back a long time and has gone through a lot of different changes—which once upon a time, changed American policy and had the President of the United States one night 39 years ago last night, at 7:25 pm—all of a sudden break into a whole discussion. We’re all sitting there. I remember vividly, because we had all been told to watch Reagan’s TV broadcast. We had all been given his speech, or what looked like his speech—the transcript given out beforehand. We didn’t see anything in it that was remarkable. He started at 7:00, and it got to be 7:25, and all of a sudden, the President starts in about ‘wouldn’t it be wonderful if we didn’t have to go to war with the Soviet Union, and we might be able to come up with a way to render nuclear weapons ‘impotent and obsolete’. Tonight, I’m asking that our scientists give us a way to do that.’

“I’m sitting there watching the TV. I was not a Ronald Reagan fan, in any way. I was not. I remember Ronald Reagan putting the fire- hoses on the kids at Berkeley, and so on. We used to call him “Ronald Raygun.” Reagan starts into this, and BAM! All of a sudden, there’s a new policy. That part had been taken out of his speech. That’s why it wasn’t in the written copies.

“I can say this now, because so much time has gone by: One of our people, together with a man by the

name of Judge William P. Clark, Jr. who was the National Security Advisor at the time, and a third in- dividual, who also had been in our organization, wrote that section. It was taken out by Secretary of State, James Baker III, who is still alive down in Texas. Reagan (or perhaps Clark, I don’t know) put it back in, and just went with it. No- body knew it was going to happen. Baker didn’t know, Secretary of Defense Casper Weinberger didn’t know. Everybody was baffled.

“The next day, the only people in the United States who were be- ing consulted on what the policy was, were our people. I’m not telling you that we were walk- ing around proud that we were the only people. Back then there were only five or so TV stations. I’m telling you that NBC-TV had to come to us to find out what the policy was. At the time, we had something called the Fusion Energy Foundation. Paul Gal- lagher, as spokesperson for the FEF, was suddenly on the tele- vision. We had illustrations on the whole policy because we had been talking about the policy for two years. We had big mock-ups and such. This [was] before the internet. Stills. The media came to our offices. We were then in New York City, so it was easy for them to get to us.

“We ended up briefing the country for two days, because no- body in Reagan’s cabinet felt that they could speak to the policy, be- cause they didn’t know where it came from.

“This is what you have come in to. You landed in the right place! That’s the way that you can deploy with us. We know how to do this and we ask that you be part of it.”

organizers in a military fashion, to meet the requirements to gather at least 500 signatures in 13 of the State’s Congressional Districts and 45,000 overall. Sare has said she will need 90,000 signatures to deal with expected challenges from the party establishment. All the signatures will be gathered under the stringent state rules, and then carefully checked before they are filed. Organizers are confident that any challenges from the party apparatus will be defeated. Sare intends to ultimately deploy hundreds of people per day throughout the state during the 6-week petitioning period. Her campaign has been hold-

cies, including the possibility that the Democrat Party apparatchiks might try to disrupt the petitioning. In a mass online meeting with volunteers April 2, Sare told the gathering that they should be prepared to “fire a shot heard round the world” and that by doing what many consider impossible, they will show that people intend to fight to save this country and its Constitution. “I know it will be difficult,” she said of the task, “but I know we can succeed.”  
**Organizing Upstate**

fuel prices, though most Americans have not bought into the lie peddled by the Biden Administration and the media that this is caused by Russian President Vladimir Putin. Last week sources reported that in several states, armed groups of truckers and others forced gas station managers to lower prices; these reports have been kept out of the media, although one knowledgeable Beltway source reported that this prompted a panicked Joe Biden to take temporary steps to slow the price increases such as releasing supplies from U.S. reserves, but this and other sources report that the slowdown will not last long. Prices at the gas pump could be as high as \$6/gallon by July 4.

**Schumer a Wall Street Shill**  
Sare argued that her opponent, Sen. Chuck Schumer (D-NY) “owes his career to Wall Street and the City of London. He has ignored the devastating plight of millions who are starving, including in our

South Bronx in New York City.” What is needed and has been needed for some time, said Sare, is a totally new system: one that will cancel the usurious speculative debts and financial swindles—such as derivatives—of the old system, while creating trillions of dollars in directed credit for global development initiatives of the type that the LaRouche movement has advocated for more than a half century, and many of which are now being implemented through China’s Belt and Road Initiative. Such programs seek to eliminate the structural poverty and immiseration that were built into the post Bretton Woods global casino created when President Nixon decoupled the dollar from its gold reserve peg on Aug. 15, 1971.

**We Need the IDB**  
We will need a global development bank, Sare continued, modeled on the 1975 proposal by statesman and economist Lyndon LaRouche for the creation of an International Development Bank

economies to maximize individual profit or shareholder values. It is not monetary profit for the individual that we seek, but the expansion of social profit, that we invest for the betterment of all.”

To accomplish this, we must return to stable currency arrangements, with a gold-reserve-based currency system, as existed prior to Aug. 15, 1971, which will allow for stable long-term investment, Sare said. “The LaRouche movement has issued a transitional plan to accomplish this, building around a system that could be created by Russia, China and India, and then bringing in the U.S. (see article this page). We must educate the American people about the real traditions of the American System of physical economy, as designed by Alexander Hamilton, and developed further by Lincoln’s economist, Henry C. Carey, which revolved around the Constitutional principle of promoting the General Welfare, and which FDR used in the last century to enable the New Deal recovery program and the war mobilization. It is this tradition of the American System that Lyndon LaRouche revived to solve the ongoing crisis, which has reached a tipping point right now.”

“We will need emergency measures, as were discussed at the recent April 9 Schiller Institute video conference (see article page 1), to deal with the global food and energy crisis”, said Sare. “To ignore these needs shows us to be morally unfit to survive. I am certain that we can mobilize the great power of the American people and gain allies around the world for this effort to reverse the effects of disease and starvation. The world, if properly organized, can easily support 25 billion people—including at least 1 billion in the United States—in conditions of increased productivity and creative potential.

“I can say with certainty that

unless we devote ourselves to such sweeping, but lawful changes, away from the policies of the last more than half century,” Sare said, “this planet will be plunged into chaos and war, from which we will not recover for some time, if we recover at all. I echo the words of President Franklin Roosevelt in 1936, in summoning the American people to confront the challenge of the Great Depression and the looming war against the bankers’ fascism to come: ‘To some generations much is given. Of other generations much is expected. This generation of Americans has a rendezvous with destiny.’”

NEW YORK, April 15—The Schiller Institute released a policy proposal March 28, titled, “The LaRouche Plan for a New International Economic Architecture,” circulated in tandem with an international petition, asking international leaders to confer on fundamentals of security for all nations. ## Dem Party Revs Up Fraud Machine

NEW YORK, April 16—In a foretaste of what they might have in store for LaRouche Independent candidate Diane Sare’s petitions, the Democrat Party’s fraud machine, for which it is already well known, is running full blast against candidates it would rather exclude from the coming primary vote.

According to a report published in *The City* April 15, “The Kings (Brooklyn) County Democratic Party filed challenges to try to knock fellow Democrats off the June primary ballot that were fraudulently signed,” according to the grassroots organization, Rep Your Block. The organization has sworn affidavits for at least two of the signed challenges, which state that the signatures are not those of the alleged signers. They say that other challenges are also likely similarly fraudulent. As the challenges were submitted to the Board

of Elections, the fraud constitutes a felony. A spokesman for the Party did not specifically deny the claims about the signatures being faked, but rather incredibly denied that any fraud was intended.

The party is trying to keep an iron-fisted control over who is on the County committee and wants to keep people who might be trouble for the apparatchiks of the party off the ballot. **Dem Party = Fraud**

and the Russian military was established immediately, without any fact-based data to back it up, and subsequently echoed in all forms of media—mainstream and social alike,” Ritter stated. “Anyone who dared question the established ‘Russia did it’ narrative was shouted down and belittled as a ‘Russian shill,’ or worse.

“That these conclusions are the byproduct of mass hysteria is beside the point—why seek to be objective when the narrative fits every stereotype that had been carefully assembled beforehand by the same people parroting the Bucha story today?” he continues. “Social preconditioning of an audience unused to critical thinking is an essential step in getting this audience to accept at face value

anything that is put before it, regardless of how egregiously the facts of the story strain credulity. And let’s be clear—the Ukrainian narrative of the events in Bucha seems to stretch credibility.

**Constructing a Lie**  
He points out that there was no such narrative about atrocities and war crimes when the Ukrainians reoccupied Bucha on March 30. The Mayor made no statements about mass killings by the Russians, although the so-called evidence in the video would have been apparent to those entering. Ritter wonders why the British chief prosecutor of the International Court Karim Khan, who has said he will pursue a war crimes investigation in the Ukraine, has not immediately dispatched forensic teams to investigate what took

place in Bucha and to “oversee autopsies on the victims to establish the time of death, mechanism of death, and whether the victims had died where they were allegedly found, or if their bodies had been moved there from another location.”

Ritter suggests that Khan should explore the links between the Azov Battalion and the National Police, and orders to the latter reportedly authorizing the brutal slaughter of Ukrainian “collaborators with the Russians.” “The results of such an investigation would more than likely conflict with the narrative being pursued by the Ukrainian government and echoed in the West by compliant media outlets and politicians alike,” Ritter concludes. “This is the prime reason why Khan is not currently on the

ground in Bucha. One can assume that if and when Khan is eventually given access to evidence about the Bucha killings, it will have been manipulated by the Ukrainian National Police to such an extent that disproving the allegations will be virtually impossible.”

As we have explained, it is possible to see through the brainwashing and the lies, to the truth, however inconvenient it may be for some people in our elites.
