## The European Union at 100

Is the best yet to come?

LIKE anybody nearing a 50th birthday, the European Union needs a makeover. But as this special report has suggested, the past two years' talk of a deep crisis is overblown. The union is functioning as well (or as badly) as it did before French and Dutch voters rejected the constitution.

July 17, 2022—This past week, the New York Board of Elections held hearings to review evidence collected by Sare for Senate volunteers, together with Libertarian Party activists, proving that petitions filed by the Independence Party for a slate of candidates headed by Republican gubernatorial candidate Cong. Lee Zeldin, were filled with fraudulent signature pages. The New York Board of Elections was forced to admit that these Independence Party petitions fell far short of the required 45,000 signatures, due to the exposure of almost 12,000 signatures being photocopies of other signatures.

However, since Lee Zeldin, and the rest of the Republican Party slate, were already on the Republican Party ballot line, who decided to go with this crazy gambit? The requirement of getting 45,000 valid New York State voters' signatures, an outrageously high requirement, was imposed on any non-Democrat or Republican candidate for statewide office, by an act of the Democratic majority New York State Assembly, and signed into law by Andrew Cuomo late last year. Only the Diane Sare for Senate team of dedicated volunteers working non-stop state-wide for 40 days and nights were able to achieve, and surpass, the onerous 45,000 signature requirement.

Is this whole situation just a falling out amongst election thieves? Is this simply a further proof of the corruption of the US electoral system? Was this all just part of the permanent “re-election” of Senator Chuck Schumer?

Or, is there something far more sinister going on?

Let us call your attention to a “special report” published in the *London Economist*, on March 17, 2007 entitled “The European Union at 100.” Please take careful note of the date. This was written almost a year before the 2008 Presidential campaigns began (also, as an obvious insult to the Irish on St Patrick’s Day). Here’s an excerpt from article, written as if from year 2057:

The other cause for quiet satisfaction has been the EU's foreign policy. In the dangerous second decade of the century, when Vladimir Putin returned for a third term as Russian president and stood poised to invade Ukraine, it was the EU that pushed the Obama administration to threaten massive nuclear retaliation. The Ukraine crisis became a triumph for the EU foreign minister, Carl Bildt, prompting the decision to go for a further big round of enlargement. It was ironic that, less than a decade later, Russia itself lodged its first formal application for membership.

Here you have the principle organ of the British imperial faction “forecasting” the election of Barack Obama, and the so-called Ukraine Crisis, as well as the threat of a nuclear confrontation between NATO (the European Union) and Putin’s Russia. Was this just a wild guess of futurology, or was it, perhaps, a declaration of truly Satanic intent. It is certain that Barack Obama fulfilled the wishes of this British Imperial oligarchy, for two terms, and had Hillary Clinton not been defeated by Donald Trump, the nuclear showdown over Ukraine would have begun four years earlier.

However, the Trump election was only to be a very temporary set-back for this Imperial Oligarchy. As you may remember, Senator Chuck Schumer, on an interview with Rachel Maddow, said that Trump was very stupid for trying to clean up the Intelligence agencies which had lied us into Endless Wars, since, as Chuck said, “They have six ways from Sunday to get back at you!” He probably meant to say, “They have MI-6 ways from Sunday...” One only need recall the role of Christopher Steele and Sir Richard Dearlove (former head of MI-6) in orchestrating the Russia-gate witch hunt of Robert Mueller. Or, you may remember that the British Ambassador to the US, Baron Kim Darroch was forced to resign after being caught bragging of the British intent to “flood the zone” of advisors to President Trump, in order to sabotage any of Trump’s policies not in line with the British Imperium.
