A HAPPY 4TH - AB 951 ENACTED by Warren Truitt, President

Just in time for the 4th of July, Governor Schwarzenegger signed AB 951 as an Urgency Bill, prohibiting alcoholic beverages, whether open or closed, on non-motorized vessels along the American River between the Hazel and Watt Avenue Bridges during three summer holiday periods - Memorial Day, the 4th of July, and Labor Day.

AB 951 is a bill that SARA pushed for and testified on behalf of, as a necessary measure to quell alcohol-fueled violent and inappropriate behavior, and unbelievable trashing of the American River and Parkway during the summer holidays. The bill was carried by Assembly Member Dave Jones of Sacramento, who did an excellent job of presenting and shepherding the bill through both houses of the California State Legislature.

SARA volunteers, as well as Coalition partners from the American River Parkway Foundation and the American River Natural History Association, manned two sites - the Goethe Park raft takeout and the beach area at Ancil Hoffman Park on the 4th of July, providing trash bags and trash removal assistance to debarking rafters.

In sharp contrast to the last few years, the 4th was peaceful, fun and safe with over half of the rafters on the water appearing to be families. In addition, the volume of trash collected was approximately 10% of the amount collected on July 4, 2006.

The goal of returning the river to families and reducing the level of trash were both accomplished on the 4th this year.

MARKIS USE PERMIT UPDATE by Pat Waterbury

Members of SARA and readers of this publication know the campaign to preserve the Parkway continues endlessly. Threats to the integrity of the Parkway Plan and its zoning ordinance - Parkway Corridor Combining Zone - (PCCZ) are numerous and constant, like the ongoing Markis/Lien project in Carmichael. Within the next few months, the Planning Commission will decide whether to grant a 35-foot setback to the two Markis/Lien houses (totaling more than 12,000 sq ft) on the Riverwood bluffs in Carmichael, where a 70-foot setback is required.

Because of SARA's successful legal challenge to the County (litigation paid for by many SARA members in addition to other Parkway supporters), the judge ordered the County to commission an environmental impact report (EIR). The EIR was performed by the Markis/Lien engineers; it is the opinion of SARA that the draft EIR is inaccurate, misleading, negligent, and dangerous to the Parkway.

Parkway supporters can defend the integrity of the Parkway Plan and its zoning code, and can make a difference in the resolution of this issue by writing to their supervisors. The County is required to deal with all of the letters, questions, and challenges presented by the public during the comment period. When that has been completed, a final EIR will be published, followed by a hearing and final decision before the Planning Commission.

The American River - Going, going, gone? by Jack Sohl

One needs only to observe the very high flows of over 4000 cfs (cubic feet per second) being released from Folsom Dam over the last several weeks to understand that all is not well in the Lower American River (LAR). Water flowing into Folsom Reservoir is about 900 cfs, and storage is close to 50% of capacity...this situation will only get worse as we get further into the summer months.

In a more normal year, we would see releases of 1500-2500 cfs and in-flow in the 1000-2000 cfs range. The skimpy snow pack and rainfall this winter and spring are certainly major contributors to the problems the river faces in coming months, but there are other considerations.

Very likely, by early October, flows will be around 1000 cfs, and a water temperature too high to allow successful spawning of salmon, and later by steelhead. So why is so much water being sent down the river, into the delta, and south down the central valley? Could it possibly be the political clout of the huge agricultural corporations and large southern California water purveyors? Federal and state agencies are charged with protecting the public interests.

The Federal Clean Water Act requires that the people are to be protected from "unwise and unreasonable" uses of Federal & State waters.

Federal and State Environmental Protection Agencies are responsible for ensuring that the lands and waters are not degraded—yet the needs of fish, wildlife and recreational values are given low priorities when it comes to water distribution. We need responsible actions by the agencies. Even worse news may be coming.

Fourteen thousand, (yes, that's 14,000) new homes have been approved for a development in western Placer county (the Vineyard Project)—and at this time there is *no water source approved*. Likewise, Folsom is planning to approve the building of 4500 new homes south of Highway 50—again with *no approved water supply*. Regardless, if water is taken from either the Sacramento or American rivers, or from underground sources to meet the needs of new development, the American River will be negatively impacted.

The river's water distribution requirements are currently over subscribed. Will we experience the *Ex-American River*? SARA, the Water Forum, and other environmental organizations will do their best to prevent this from happening – but we'll need your support.
