Tell us about yourself.

I've practiced law for 15 years. My career started in Washington D.C., where I sued the government on illegal rulemaking by alleging violations of the Administrative Procedures Act. The past 3+ years have been spent working tirelessly to uphold and protect the Washington and United Sates Constitutions by challenging unconstitutional laws adopted by our Legislature with a non-profit organization I founded, Silent Majority Foundation (SMF).

I'm Silent Majority Foundation's General Counsel (lead attorney) and board president, and I pride myself on leading the SMF team with a constitutionally based vision. Out team is working tirelessly to ensure that our rights remain protected against state/government overreach. I will continue to fight these issues as the next Attorney General.

I am the mayor of Pasco, WA (just under 80,000 population), and I've been a council member for 6 years. For the past 6 years, I've fought to keep the City focused in its lane by seeking to ensure we're providing the proper services to the people of Pasco (i.e., roads, safety, etc.) and not on social issues.

Lastly, I am the only Republican in the race, and I foresee no other viable Republican candidate joining the race at this time.

Describe your duty to the office you are running for and how you will achieve success.

Our rights come from God, or the Divine Creator as the WA Constitution states. Our job is to legally oppose governmental interference and infringement of these rights. I've done this throughout my career by suing government on such actions.

Do you consider yourself a constitutional originalist or do you prescribe to it as a living document? Please explain.

I'm an originalist, although even originalists have to recognize that the document is a living document as the amendment process allows for modifications. That said, I don't believe that that the constitution can be legally changed on social whims as most adherents to the "living document" would believe. I believe that the document created by our Founders is the best product we will get, so we ALWAYS need to go back to the original text when reviewing constitutional issues.

What is the purpose of government? If elected, how will you perform your duties based on that "purpose?"

Government is intended to protect the People from outside harmful influences. My job will be to ensure that I deploy resources to legally protect those rights, be it individuals, corporations, or governmental organizations (Washington or outside). I will not uphold unconstitutional laws, and, when necessary, I'll sue governments that infringe on these rights.

When does life begin and at what point does the government have a duty to protect it?

I believe it begins at conception and that the government has the duty to protect life.
