By rule, the Search/Nomination Committee must review every candidate for **Endorsement** or for **Delegate** or **Alternate** to any higher body.

Accordingly, if you intend to seek any such position, you must visit our website at [www.sd45.org/convention](http://www.sd45.org/convention) and follow the instructions set forth in the **Call for Nominees** to notify the committee as soon as possible, but **no later than Monday, March 2, 2026**, and plan to follow any instructions that follow.

**SD45's Constitution & Bylaws provide that only current BPOU Delegates and Alternates may be elected to serve as a Delegate or Alternate to a Higher-Level Convention. (Article VI, Section 7)**

We intend to post information regarding all candidates for positions on that webpage in advance of the meeting.

Attendees are heavily encouraged to pay electronically, even at the door, so please pre-pay as soon as possible.

To the extent space becomes limited, entry will be granted in the following priority: Delegates, seated Alternates, remaining Alternates, and Guests. Family member Guests under 18 years of age may be seated with their respective Delegate or Alternate.
