

# South Shore Joint Initiative Annual General Meeting

Wednesday, June 12, 2024, 7 pm, Picton Library & Zoom

## Minutes

- J. Hirsch called the meeting to order and welcomed everyone. The quorum was confirmed. Read out the 2024 Agenda. Valerie Hussy motioned to accept the agenda, seconded by Elizabeth Etue.
- The minutes of the 2023 Annual General Meeting of SSJI were circulated via email before the AGM date. Ian Barker motioned to accept the minutes, and Janna McCarthy seconded it.
- J. Hirsch presented SSJI's background, including its vision and mission. Illustrated the importance of saving the South Shore and explained the area's boundaries, along with SSJI partners and supporters. (Appendix 1: J. Hirsch 2024 AGM presentation)
  - J. Hirsch introduced five pillars and talked about the first Pillar, Conservation Reserve

  - C. Anderson gave an update on the Hudgin Log House Project (Appendix 2: C. Anderson HH report 2024 AGM)
  - J. Hirsch read a report by John Lowry, Biodiversity Pillar leader (Appendix 3: Biodiversity AGM Report 2024)
    - Question from the audience: What is the status of the National Marine Conservation Reserve?
    - Answer by John Hirsch: NMCA was not approved by the Municipal Council. Nature Canada seems to have temporarily put it on the back burner.
  - J. Hirsch read a report by Amy Bodman, Commercial Fishery leader (Appendix 4: Commercial Fishery Oral History Project Report for 2024 AGM Amy Bodman)
  - Geoff Craig, South Shore Footpath Project leader, presented (Appendix 5: G Craig SSFP AGM 2024)
    - Question from Zoom audience: Are there insurance requirements for the footpath? Who would be liable if there is an injury?
    - Answer by Geoff Craig: SSJI has increased the insurance and will cover the liability arising from the footpath.
  - Cheryl Anderson reported on the fifth pillar, Fundraising and Events (Appendix 6: C Anderson Fundraising and Event report for the AGM)
