NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

In-person requests: A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).

Written requests: Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.

Website alternative: Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.

Permissible charges: Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.

Penalties: An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

Private foundation exempt: The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.

Donor Information: Please note that donor information is not open to public inspection and has been excluded from this copy.

Mobilization and advocacy: In partnership with Tearfund, Tearfund USA serves hundreds of churches and thousands of individuals in the US through educational, discipleship, and advocacy programs to mobilize action, giving, prayer, and learning addressing poverty and injustice. Advocacy efforts this past year were around the UN Climate Summit in Glasgow, Scotland. We joined the global church in calling on leaders at the meeting to make commitments to protecting forests, reducing dependence on fossil fuels, and finance climate adaptation. Collectively the global Tearfund advocacy movement collected over 22,000 signatures from over 26 nations.

Church and community transformation (CCT): In partnership with Tearfund, Tearfund USA mobilized church and community transformation, resulting in the resourcing, training and scale-up of 1,750 churches around the world. Highlights: in Burkina Faso, 20 CCT trainers were trained and 10 new groups formed, resulting in the launch of 43 savings groups (SG). In Southeast Asia, 95 CCT trainings occurred and 400 new churches were formed, impacting 323 communities. In Guatemala, CCT trainings impacted 83 families, improving their lifestyle through the creation of poultry units that generate food for their families in conditions of poverty, and in Honduras, 82 entrepreneurs have participated in the process of Pastoral and Entrepreneurial Training, and have finalized their business plans which are now ready to receive

Conflict, Crisis and Refugees: Tearfund USA and our partners responded to the unprecedented crisis of refugees and displaced people by meeting the emergency needs of countries in crisis such as Ukraine and its neighboring countries: Poland, Romania and Slovakia. Tearfund's local partners have been working relentlessly to provide food, safe water, shelter, and trauma counseling to those fleeing conflict. In recent years, we have responded to the Covid-19 pandemic, the Beirut explosion and supported Syrian refugees who have resettled in Lebanon.
