In the wake of the COVID-19 pandemic and its disproportionate effects on communities of color, the Latino Caucus encourages the gaming community and the Special Committee on the Chicago Casino to demand an equity-centric minority participation plan that not only meets, but exceeds the minimum participation provisions set forth in the Illinois Gaming Act.

Although the Latino communities tend to shoulder the brunt of social costs related to multi-billion dollar industries, such as video gambling, online sports wagering, and cannabis legalization, opportunities for meaningful participation by Latinos in management and ownership are virtually non-existent.

As representatives of the largest ethnic racial constituency in Chicago, we encourage the Special Committee to consider the economic windfall this opportunity presents to the licensee and ensure sustainable long-term benefit to the Latino community. This is an opportunity to showcase our community's unique talents within this highly profitable endeavor for decades to come and promote our City as a global entertainment beacon and gaming capital of the Midwest.

The Caucus also calls for equitable Latino representation on the Special Committee on the Chicago Casino, which is not currently commensurate of the city's racial ethnic demographics. This is extremely important because these representatives will form the equitable approach for granting the privilege to operate a casino in our city.

## CORRESPONANCE FROM THE 78 COMMUNITY ADVISORY COUNCIL

The 78 Community Advisory Council is made up of 13 members who were selected by the Mayor's Office in 2019 after the sale and passage of the megadevelopment PD and TIF. We are reaching out to you in your capacity as the Chairman of the "Special Committee on the Chicago Casino", with grave concerns on some decisions made that are in serious conflict with the voice and desires of the community that we represent.

This communication is in specific regards with The 78 recently being selected to be a finalist bidder to secure the casino development rights within the City of Chicago and recent actions of the City Council which does disservice to ensure the voice of all is heard. We conducted a neighborhood survey with close to 500 responses with **an overwhelming majority opposed** to the development of a casino on the site. We would note that about 80% of respondents said they were somewhat or highly opposed to the casino on the site with 72% highly unsupportive. We are happy to share the survey responses and feedback with the Committee.

We are disappointed that the Special Committee has selected a limited number of members of City Council to participate in this committee. It would be understandable to include those that can provide guidance or perspective to facilitate a successful concept that would benefit the city. However, it would also seem compelling to include and elevate the voice of stakeholders in the process, including the aldermen whose wards in which a casino location is a frontrunner in the conversation. The 78 site currently falls within the 25th Ward, which is represented by Alderman Byron Sigcho-Lopez. We note that Alderman Sigcho-Lopez is not a member of this Special Committee and we, as stakeholders in the successful development of The 78 are **outraged and are compelled to invoke skepticism** with any decision made by this Special Committee that fails to include the specific voice of the Alderman who would shepard the outcome if The 78 were deemed to be the final selected site for the location of the Casino.

The 78 holds the potential to be a remarkable and additive development to the surrounding neighborhoods and the City of Chicago. Members of the 78 CAC volunteered our time and efforts to the CAC since 2020 have done so in the spirit to see that the development of this 62 acre parcel of land is visionary and draws critical acclaim of what can positively happen when a community collaborates with developers to facilitate urban planning.

Instead, from our perspective, the turn of events for the past six months is shameful and in stark contrast with how the early designs were promoting community involvement with the development of The 78. Given this type of feedback, it is important to have a real and thoughtful community process for each site and that this decision ultimately is not rushed.

Failure to include a representative voice such as the impacted alderperson for the possible casino site in question is a mere confirmation that there is no accountability intended for the process, and our efforts on the CAC were mere illusory and a fool's errand. Please ensure that the voice of the nearby Chinatown, Pilsen and South Loop residents are included in decision making.

#### RE: Chicago Casino Evaluation Report - Tribune Site / RNRA Response

Dear Mayor Lightfoot and Members of the Special City Council Committee on the Chicago Casino:

On behalf of the River North Residents Association (RNRA), we respectfully submit our initial response to the assessment of the Bally's Tribune casino bid as reflected in the Casino Evaluation Report of March 22, 2022. RNRA is a longstanding non-profit community organization representing approximately 23,000 area residents. Nearly 11,000 people live in the neighborhood immediately adjacent to the Tribune site across the Chicago River.

In RNRA's letter dated December 3, 2021 (copy enclosed), several fundamental concerns were expressed about the potential impact of this development on quality of life in our community. In this context, we evaluated the City's assessment of Proposal 02, Bally's Tribune, as to the suitability of this site for the demands and intensity of the 24/7 uses being proposed – a 1 million square-foot development including a casino with 4,000 reserved gaming positions, a 3,000-seat theater, an outdoor music venue, up to a 500-room hotel, exhibition space, multiple restaurants, a food hall and a museum – in an increasingly high-density, predominantly residential area. RNRA's critique reflects three key areas of concern.

#### **Development Financing & Expertise**

- The report makes clear there are potential challenges with the hedge-fund controlled company's ability to secure financing as it attempts to take Bally's from public to private status. In comparison to the other short-listed bids, the Bally's financing information is vague and includes the caveat that its commitment letters "do not take into account the proposed going-private transaction" as well as the statement that taking Bally's private will create a "more leveraged" company. Please provide a more detailed explanation of the financing plan, that addresses how this project will be adequately and sustainably funded, regardless of whether the proposed buyout of Bally's outstanding shares by Standard General is successful.
- The average population in the 13 cities where Bally's presently operates its 15 casinos is approximately 110,000. Based on its current casino property portfolio, Bally's does not appear to have experience with developing and operating a multi-use project of this magnitude and complexity in a dense urban setting like the Tribune site. What gives the approval authorities confidence that this firm will be able to successfully execute and manage a proposed \$1.74 billion development in the third largest city in the U.S.?

#### Transportation Impacts & Development Capacity of Area

• The report acknowledges the existing traffic congestion on Chicago, Grand and Halsted and references the City's ongoing capital improvement project to reconstruct the Chicago/Halsted viaduct and widen the Chicago Avenue bridge to address existing infrastructure demands. In view of the new mixed-use residential developments that are presently approved or under construction fronting Chicago and Halsted, and the added development intensity proposed for the Tribune site, has a traffic study been conducted that evaluates the combined area-wide impacts of these projects? If so, will this study be made public?



#### Summary Statement on Bally's Casino Proposal / Tribune Site

Established in 1997, the River North Residents Association is a non-profit community organization working with residents, local businesses, government officials and other partners to protect and enhance the quality of life in the River North Neighborhood. Our membership currently includes 86 properties, representing approximately 23,000 area residents.

The River North Residents Association does not have a reputation for being "anti-development". For 25 years, our organization has worked collaboratively with elected officials and developers to evaluate, and recommend improvements, to dozens of proposed projects in our community. Our objective is always to ensure that developments are designed and constructed in such a way that the surrounding community is enhanced and the short and long-term impact on all stakeholders is appropriately considered.

With respect to large-scale development on the Tribune Publishing site at Halsted and Chicago Avenue, RNRA understands and shares the general goals of job creation, economic development, and infrastructure improvement, particularly as the city emerges from two years of pandemic-induced recession.

The proposed Bally casino complex is simply the wrong project for this location.

On December 3, 2021, RNRA sent a letter to 27th Ward Alderman Walter Burnett, 42nd Ward Alderman Brendan Reilly, and 2nd Ward Alderman Brian Hopkins, describing the significant negative impacts that a such a large-scale entertainment complex would have on traffic, public safety and quality of life for thousands of residents in the densely populated surrounding area. Like all large community organizations, RNRA is not a monolithic group, but we have received a great deal of input from members expressing these concerns.

Nearly 6,000 additional living units, 75,000 square feet of commercial space and other mixed-use development has already been approved or is under construction near the Freedom Center site, which will further increase density over the next few years. Adding a 1 million square-foot development including a casino with 4,000 reserved gaming positions, a 3,000-seat theater, an outdoor music venue, up to a 500-room hotel, exhibition space, multiple restaurants, a food hall and a museum will not improve conditions. The additional strain on existing infrastructure, noise, bright lighting and traffic congestion, not to mention the probable negative effect on local property values, are completely unreasonable burdens to place on the surrounding residential communities.

The city has prepared a 102-page Evaluation Report, providing a detailed overview of each of the original five casino proposals. RNRA has reviewed the report and questions several of its findings with respect to the assessment of Proposal 02, Bally's Tribune. We respectfully request that the concerns outlined in this critique be addressed publicly and given appropriate consideration in the City's analysis *before* determination of the final site for a Chicago casino.

If the proposed development for this site involved a hotel, condominium buildings or rental apartments with restaurants, office or retail, and green space, RNRA and other neighborhood organizations would likely be eager to work with the city and developers on the project. But the proposed casino complex is ill-conceived, and many residential communities on the near north side will persistently oppose it.

- The report includes a rendering, at the top of page 31, showing three additional large residential towers between the south end of the casino complex and the Grand Avenue bridge. These are labeled "L" (480,000 GSF), "A-1" (668,000 GSF), and "A-2" (448,000 GSF). At present, RNRA has received no detailed information about these developments, which, if constructed, would add considerably to the density and further exacerbate congestion. Has research been conducted that demonstrates that the planned improvements to existing infrastructure will be sufficient to alleviate current congestion, plus the impacts of all approved, proposed, and potential development? If so, will it be made public?
- The report does not address the amount, source and availability of public funding needed to complete these improvements. *Is this information available to the public?*
- The report is also silent about whether Bally's will offset all or part of the cost of the taxpayer-funded
  infrastructure enhancements that will substantially benefit their project. Will Bally's be required to share in this
  expense and if so, to what extent?

#### Local Financial Impacts

- The report states that 78% of Bally's projected gaming revenue is estimated to come from local customers, but the revenue analysis does not include any information about the impact on the city if the majority of discretionary spending by Bally's casino customer base will be diverted from existing Chicago area businesses and recreation/entertainment venues. Are estimates of the net economic impact of this development available?
- Bally's proposal commits to the interior buildout of just 100 hotel rooms in phase I, with the future buildout of an additional 400 rooms on a "best efforts" basis. According to the proposal, the difference in annual tax revenue between 100 and 500 hotel rooms is projected to be \$15 million by year six. Given this caveat, and the Tribune site's close proximity to many existing hotels, the report's revenue assumptions need further clarification. What is likelihood that the additional 400 hotel rooms will ever be built out, and when?
- The evaluation report does not address the fact that the Tribune publishing site is located in Enterprise Zone Four (EZ-4), and the temporary gaming facility is located in the Chicago/Kingsbury Tax Incremental Finance District (C/K TIF). Will Bally's be seeking any TIF and/or EZ benefits in the course of this development?
- Casinos often negatively impact nearby residential property values. There are numerous residential buildings, and thousands of units, along the river, Chicago, Superior, Huron and Erie, all within the C/K TIF. Has any research been conducted on the impact of the proposed casino on real estate values in the surrounding residential communities? If so, please share the results publicly.

We respectfully request that our concerns be addressed and given appropriate consideration in the City's analysis before determination of the final site for a Chicago casino. That stretch of Chicago Avenue is already severely congested, and this will make it much worse. Also, we already pay some of the highest taxes in this city and deal with crime daily; I don't want it to become worse. If I try to sell my condo, I don't want the property value to go down - no one will want to live around here anymore!!

The casino will bring more traffic and crime to the area, which is residential area. There will be a mass exodus by those living in the area which will hurt the property values. I love this neighborhood but if the casino is approved I will most likely look to sell and move out of the area, which will be a common theme for my neighbors.

I live in the area and do not wish to reside near a casino with the known negative impacts that it will include.

I am not opposed to there being a new development being built at this site. However, I don't believe a casino is the right development for this area.

Why is the city not putting this in a non residential area that would benefit from development

A casino does not belong in a residential area. The congestion will adversely affect the area and overtax the existing infrastructure. We don't need or want millions of strangers and their cars, noise and crime coming into our neighborhood.

The place is already congested and traffic to the area is going to be awful

It should remain a residential neighborhood

Casino's bring all sorts of crime and negative elements to a neighborhood that was just starting to be livable before the pandemic and now we can barely walk outside without being carjacked or robbed. this neighborhood is too residential and this type of complex belongs in the loop or somewhere else not on this site.

We already have increased crime in River North.

I cannot see this being made any better by adding a casino to this neighbour hood. It is so moly not the right venue and will not enhance life here but will definitely diminish it. It may well be the reason I finally leave the area, after spending 15 of my retirement years here. Going out for dinner in the late evenings is already too dangerous and uncertain here: a casino will only make things worse.

We already have a methadone clinic.

Young kids

It could also fail and become an eye sore like many other casinos. The infrastructure here will not support the traffic and it would be right in the middle of the west town neighborhood which is just now turning over. Poor location. What happened to the park?

I've lived in River North for 24 yrs and will honestly leave if a casino goes up here. The crime has gotten out of control here abd it will only bring on more. The noise, traffic concern me too . This is the wrong place for a casino .

Having a casino in such close proximity to residences and school is a disaster for property value. Crime, traffic, everything that comes with it is horrible.

River North has already experienced increases in crime and noise and traffic with all of the late night bars in our area (Clutch bring one closest to us). This just adds more stress to an already congested area. Families live in this area and it's already difficult to ride bikes and even walk around without fear of being hit by a car.

We don't want to be associated with the being the neighborhood "across from the casino"

Dysfunctional City

In every city that has gambling it has been shown it falls on the backs of the poorest and increases crime.

Completely against the casino and will force us to move out of the neighborhood. No interest in having our family in the same proximity as a casino.

This is primarily a residential area. We already have crime in River North which has not been addressed.

Chicago Avenue and Halsted Avenue with small bridges over the north branch of the Chicago River simply cannot withstand they traffic. In addition, its proximity to hotels is not good. The Lakefront proposals are far more viable with plentiful existing parking, and public transit access.

A casino in a residential area is not a good criteria for existing residents as well as new residents.

An uptick in crime and violence is the last thing river north residents need

The area is surrounded by residential properties. It is already highly congested and the infrastructure in the area will not support it. This is a really bad location choice for a casino. It will attract people who cannot afford to be there and totally change the flavor of the neighborhood. Why would you want to put a casino there? The city is managing to the lowest common denominator with casinos and cannabis! What does that say about the history of this once beautiful world class city that it is no longer. It is riddled with crime and guns and this will just add to the downfall of the city. Why not put the casino at the old McCormick center that is now vacant. There are no residential areas surrounding it and the infrastructure is already there. I hope the city can rise above these low life ideas and proper in a more cultured and thoughtful way. I say NO to casinos in the city where they are currently proposed. Please listen to the people, the residents and workers in the area who are voters and care about their community!

The traffic is terrible in our area, the bridges on Chicago and Grand barely support our neighborhood now. Our neighborhood is still reeling from the past few years of crime and gangs hanging out in Montgomery park and Erie. Still have great concern over safety. Crime and other illegal activities do gravitate to casinos. Let's focus on business that support the residents of River North. This is NOT supportive.

This is a residential and small business area and should be developed in that direction. I'm not opposed to multiple buildings being developed on that site versus one large casino open 24 hours. Ballys touted that as a selling point - reduced number of units. But those units will be similar to our area and not attract thousands of visitors daily and all night long.

Living directly east of the location (other side of the river), we can already hear Chicago Tribune trucks entering/exiting the lot. Since this proposal is for a 24 hour casino, we're worried about the additional noise since much of the area is planned to be outside (courtyard style) instead of indoors like the casino in Rosemont.

Additionally, worried about placing a casino and pedestrian bridge from the casino which leads directly to a child's playground (near Erie Cafe).

River North' & chicago Ave are already very congested. The new lifetime fitness & Whole Foods haven't opened on Chicago Ave and that will cause gridlock. a casino will make it worse. I don't want that or increased crime with the extended nightlife in the area. It's already challenging to get across Halsted.

Vague about how undeveloped areas would be used, operating hours of casino, and traffic

I live directly across from the project at 500 West Superior. This is a quiet residential area that I chose because it was just that. This project will put our neighborhood in the middle of a tourist-centric circus. At the meeting last night, the Chairman of Ballys repeatedly said it was going to bring 60 million people into the city. There will be concerts and events for theaters that seat 3000 and 5000. It is simply not possible that such an influx of people can be accommodated on Chicago Avenue and the 90/94 circle. Whatever analysis they are using that says this can be handled by a new bridge and traffic lights has to be skewed. We had a traffic advisory just for the community meeting last night. There is out door space for outdoor concerts,Äît will be loud and disruptive. They are going to connect to our park where our families and residents enjoy time outside. People will come from Michigan Avenue and those hotels through our neighborhoods. And all of this will be on a daily 24/7 basis. The Tribune location is just the wrong spot. It will destroy the tenor of our neighborhood and what makes it special.

Will leave Chicago if in the neighborhood

The proposed development is adjacent to a thriving, family friendly neighborhood. The proposal and pictures are lovely but it does not belong here.

Gambling is inconsistent w community development... there is no positive about it and projected tax revenues is entirely offset by the negative impact it has on the surrounding community. I'm patently against gambling of any type.

This casino will destroy River North. Casinos are designed to concentrate and keep all of the business inside of the casino. Surrounding neighborhood businesses will collapse and crime outside of the casino will multiply exponentially. Politicians and greed have put the pension system in the needless down spiral it is in today, and they are willing to make a deal with the devil to keep their pockets fat at the expense of the people who call River North home. Chicago has become a caricature of the once great city it was years ago. The excuse of someone else will develop anyways and the blatant pandering to blacks and other minorities was one of the most disgusting things I've seen from the used car salesman panel Bally's provided. We all see through your smoke and mirrors and especially black Chicagoans that continue to have their intelligence insulted by a group of people salivating to build this communities demise.

Bally's analysis of traffic compares its use to the anticipated use documented in the PD approved in 2018. It is unacceptable to plan a development of this size based on 4-5 year old traffic studies. It is essential to evaluate the existing traffic conditions PLUS the anticipated traffic from the PD approved last year for Goose Island to properly evaluate the traffic impact of Bally's proposal on existing infrastructure.

It's basically a quiet neighborhood over here. That would completely change.

The previous page explains my reasons here they are prioritized 1. Lower property value 2. More crime. 3./4. More vehicle and pedestrian traffic in a residential area 5. More noise

Studies show both increase in crime and decrease in property value. We don't need a casino.

I oppose for all the reasons stated by the association. Having a casino in a highly populated residential area will negatively affect our neighborhood and quality of life. I moved to this area of River North across from the river and Tribune, because it was away from the chaos and traffic of restaurants and businesses in the heart of River North. To put a casino here would completely change the neighborhood vibe and i think drive a lot of people to sell and move. I was already looking to move to the suburbs because of the crime that has not been addressed. We had two shootings two weeks ago. One at 4 pm in the afternoon on a Wednesday and one on Friday at 6 pm. Which I heard loud and clear from my balcony. Perhaps address our current safety issues as opposed to adding to it with a large Casino complex.

Studies show on average 5% loss in property value in the vicinity of a casino, this equates to Ballys stealing hundreds of millions of dollars from the community

Will not be a children friendly community and I have a daughter

Increased traffic and noise, will disrupt daily living

l am anti-casino

Our neighborhood is already congested and impossible at times to get around. We are a major through way for traffic getting on and off the expressway at Ohio street. This casino would not only impact our neighborhood but will spread across the entire downtown area. Crime is already at a high in Chicago!!! We do not need a casino to increase those crime rates.

As a businessman who has attended an infinite number of pitch presentations, it was shocking how last nights presentation was so woefully prepared and articulated. At no point during the session did they demonstrate that they understood the neighborhood, the severe & detrimental impact on crime and safety, or the harmful strain on our overall community that this casino would cause. This could not be a stronger NO!

the river north community is profoundly residential - many families live here with small children. we are still dealing with the increase in life threatening crimes and now have to contend with a casino one block away - a venue looking to attract thousands on a daily basis? the crime, traffic, noise, aesthetic and our property values will all be negatively impacted - significantly. to put a casino in this hugely residential area is an atrocity - particularly when an overwhelming majority of those of us who live here are vehemently opposed.

I am opposed to casino coming into Chicago in general. Gambling is a vice and should be curtailed as much as possible.

This area does not need any additional traffic bottlenecks. Also, I think it would be naive to believe there will not be an increase in crime. Crime is already out of control. More people and money can only encourage crime.

Casino in a dense urban area with otherwise no exposure to a large scale - impact to existing residents in terms of property values, traffic and congestion, noise and light pollution from operations, no mass transit option, river front impact from construction and operations etc

No need for more chaos in a residential area

This residential area of River North/West Town is chosen by most residents due to it's quiet, residential feel in close proximity to the city. A casino would ruin traffic patterns, cause increased crime, and would strain all of the wonderful parks & walking paths in the area.

As a property manager of 5 buildings in River North, I fear for our residents' safety as we are struggling to keep up with the overall security of the building given the increase in crime. We are dealing with constant carjackings, break-ins, noise from nearby clubs and the list goes on. A casino will not improve the City's current condition. River North is no longer a safe neighborhood. You can no longer walk without fearing your surroundings. There are no consequences to crime at this time and while that's political, this is bound to get worse. A casino is a simple, open invitation to criminals, of any kind.

A casino would cheapen the area, my home, and make it extremely difficult to travel on the roads around the area that are already strained. I would strongly consider leaving the area, and the city of Chicago, should this casino be built. In an area where crime is already increasing, I would be concerned for the safety of my family and would avoid patronizing business around that area.

Increased crime and lack of infrastructure to support the addition.

Increased traffic and home devaluation are my main concerns.

River North is an historic, attractive residential, family friendly community that supports the city's tax base with thousands of multimillion dollar homes and condominium. The area is home to leading design industry businesses, retail stores, and high end restaurants. We already see the large bars attract attract drunk crowds, traffic, disregard for street signs as they blow through our stop signs and red light, vandalism, and sidewalks littered with broken glass and vomit that our residents and local businesses need to pay to clean up each week. The parity goers show no consideration to the community the crowds attract a criminal element with gun shots heard last summer EVERY WEEK on some streets and assault, car jackings, and shootings throughout the neighborhood being common occurrences. On multiple occasion calls to 911 result in no responses, even to gun shots, even when we have video of the shooting from our building security camera, so we no longer waste our time to call 911. A large casino that attracts thousands more people who don't live here to pass through and party here will ruin whatever hope we have of reclaiming our neighborhood.

This would be a devastating change to our neighborhood and will continue to push high tax paying citizens out of Chicago.

Have them build the casino on the south side near mc commick place. Much better location.

Concerned about increase in crime.

I saw the presentation via the live feed on April 6th. While it looks like the plans are impressive, casinos don't historically bring in many well paying jobs and will potentially increase crime given the entertainment nature of the venue.

After attending the Bally meeting, the presenters, along with the City did not do a good enough job articulating the reasons why. The traffic stats were presented never talked about the actual number of vehicles. The city can't seem to control crime. No stats were provided about noise. No stats were provided about impact to property values.

No casino should be built in a heavily residential area. Significant concerns about crime especially given the increased crime over the past years in river north and the impact of an entertainment venue on property values. We already have issues stemming from the bars on the weekends with crime, noise and littering, a casino will only make things worse

I'm in One River Place and decided to stick it out through the pandemic with my young family because our love for this neighborhood. I'd have heavy regret of not bailing sooner should they decide to move forward with the Casino across the River

The city is already in ruins this would cause more destruction

The whole project simply does not fit in this part of town. We know it will result in increased noise, traffic, pollution and crime. This would be a 24/7 operation! This is not an answer to the pension problem as the City already has voted to increase real estate taxes to match I flatiron!

Traffic is already extremely heavy on our main thoroughfares without adding such a large development. And the lights/noise will make life near the complex incredibly difficult.

Chicago Avenue, particularly at the bridge, is virtual gridlock. Grand Avenue will rapidly disappear as an alternate route. It's the equivalent of putting a major venue on a secondary intersection without adequate public transportation or road network.

We are already dealing with increased crime, do not need to add more in this area as the police coverage is already limited. Also a bridge to go through ward park is a terrible idea, that is a family friendly area well respected by residents and should not be having casino customers tracking through, terrible idea.

The current safety issues are reaching a boiling point and I do not believe the city has the resources to police properly nor should it be required to. A private casino entity right downtown is strikingly similar to decisions made in Detroit which had catastrophic results to the downtown resident population. In theory this would bring money, but I cannot see any other benefit. An addition this massive should bring cultural benefits as well.

The growing construction in River North over the last 5 years has already put a strain on the neighborhoods resources. There is not appropriate sewage infrastructure to support the build which is already causing problems. The roads would need to be completely redesigned to support the traffic. Chicago Ave and Halsted would quickly become one of the worst intersections in all of Chicago. As a homeowner, my property value would plummet. There are many other more open and expansive areas in chicago that are in need of development. This is not one of them.

River North does not have the infrastructure to handle the additional traffic, both foot and vehicular. The casino will be nothing but a strain and blight on the River North neighborhood. PLEASE find some other place to put it.

The casino is proposed directly next to a highly dense, highly residential neighborhood with multiple daycares, a children's park. And they want a land bridge connecting the casino to the children's park?!? That point alone shows how NOT thought through Bally's proposal was and I was horrified by the presentation at the community meeting and the lack of specific details included and inability to directly answer any of the tough questions posed. I've been in this neighborhood for 15 years, a casino is not the right fit and it would cause my family to leave.

I have three small children. We go to the Montgomery Ward park almost every day. I am extremely concerned about the noise level, and more importantly, the crime the casino will bring to our area. Our park is one of the few quieter sanctuaries in the city where we can enjoy time looking at the water or sitting on the grass. The construction of the casino will be an immediate noise and visual obstruction, detracting from the natural beauty we now have along the river and in the park. I will not feel safe bringing my kids to the park anymore. Sadly, we are planning to move after living in the Montgomery Park area for 10 years if this location is decided for the casino.

Additionally, we own several units in the surrounding area. Property values will decline if this casino is built. Traffic has already increased with the current construction projects, and this will bring a more permanent, constant congestion to the area.

I live at LaSalle and Hubbard and know this neighborhood's club scene will be negatively impacted with increased patronage due to casino proximity. This area is already affected by noise, crime, and traffic congestion,Äîand adding to it will make the weekends (and now possibly weeknights) even more intolerable. Enough! Please!

This neighborhood is heavily residential. A casino would be weird

It is right at the center of two very busy roads already. There is no way this is not going to cause significant congestion that impacts residents way beyond River North.

Our neighborhood currently is safe and quite. If there is a casino it will ruin the grounds.

There are more appropriate sites in Chicago. This site would have a negative impact on the residents in this neighborhood.

Just bought a townhouse in the Groupon building neighborhood 2 years ago, we expected development in the area, but we did not expect Chicago's first casino to be right next to hour home. This is a very family oriented neighborhood and a casino isn't what we are looking for in a development.

We do not need to increase crime in an area that already has tremendous amount of car jacking and shootings.

This is a key corridor for residential communities and Ward Park is for families. Not an appropriate place for this type of business.

The infrastructure is incapable of supporting the project. River North lacks the road network to adequately service the Casino without making our neighborhoods unlivable.

Placing a casino is a highly populated, family-oriented, residential location is a terrible idea.

Much better use for this land in a much more equitable manner for all citizens can be created. Casino will engender criminal element detrimental to safety, also increase economic hardship on those with little disposable income who will be lured to gamble and lose hard earned money.

Too congested there

Chicago avenue at halsted serves as a major artery in and out of the city. Placing a large entertainment venue on that corner will have a devastating impact on traffic.

Casino would be a disaster in our area. It should go to places that need urban development and are underserved like Mckormick place

Escalating crime scene: The River North area has seen an increase in crime since the pandemic. While this is the responsibility of the city to curb the rise, we should oppose any projects that can add fuel to the fire. A Casino, bringing more people with money to the area, would make it impossible for the understaffed city police to keep crime off the area. It would make an already risky situation worse. No one has presented any independent study on the implications of casino and crime around a 5 mile radius of the site.

Imploding property value will be a direct outcome of crime. There was no evidence provided on the implications of this project on the project value in the area; or any casino and the property value around it. "I think it will be good for the community" was Sim Koo's statement. I am happy he thinks that way - but I need more evidence than that. Implications if it fails: The picture presented is based on a projected growth in the business. If that does not play out, we will have a massive failing infrastructure ripe for gangs to hang out and change the landscape of residential neighborhood - killing walkability and everything River North represents.

The town hall was a total waste of everyone's time. It seems no stakeholder - Bally's, contractors, the city, etc etc - feels the obligation to provide clear evidence to the residents. In God we trust, everyone else bring data!

If I were to construct a neighborhood that is diverse, the diversity would not include a casino

Casino developments belong in an area that does not affect current residents

Our property values have been going down in the area due to crime. A casino would exacerbate this issue based on numverous assessments and articles/research conducted elsewhere. This won't help. Putting a casino in the middle of a residential area/neighborhood is not a good solution. Also, the traffic in the area across bridges is already bad and this would only make it worse

The traffic studies are all in comparison to the PD that was approved 5 years ago yet has not been built (and as Bally's stated) there is no other development proposed if the casino is not built. It is misleading to state that traffic will be improved (they couldn't even hold the community meeting without a traffic warning for the neighborhood). Again, this is a residential neighborhood, it is inappropriate to place an entertainment site right in our backyard. Bally's stated that heavy pedestrian traffic would be a good thing, but I doubt they would agree if it meant thousands of tourists walking through their neighborhood every day. The casino business is meant to operate 24/7 and this is an area with young families and children, no matter how much Bally's claims they want to better the community the very act of building a casino in this site goes against that. If the city wants to develop the area, go ahead with the PD. Build literally anything except a casino.

A casino would devalue River North, bring unwanted activity to the neighborhood, and diminish residential quality of life.

The increase in both residential and office developments in the RNRC area have taxed our infrastructure to the hilt. Traffic has become unbearable and noise has definitely increased. And yet property taxes have skyrocketed, while resell values have decreased. More burden on local property owners would be an egregious offense.

This would be huge deterrent to neighborhood.

area is already congested and this would just add too many people in neighborhood plus safety and security issues.

Traffic is already horrible, adding a casino will increase it even more so. The crime will increase bringing in people from all over.

Neighborhood better developed via residential additions vs large commercial

This pocket of River North is one of the most ideal places to live in Chicago. It's an opportunity to be downtown, without the hustle and bustle, the traffic, and the noise. To eliminate such an incredible part of the city with a Casino would be truly disappointing to the city. Please put this Casino in a location that would appreciate the attention. River North was an oasis of beauty in a big city, in particular the area near Kingsbury park. I initially purchased my property 19 years ago because of the suburb feeling in a big city. The grass, trees and space was so beautiful to me, the proximity to the loop made the commute a dream, the proximity to shopping, incredible food, museums and the lake had me feeling so lucky that all of my hard work had finally paid off. I lived somewhere I loved!

The river near Kingsbury park was my favorite part. It was peaceful and the park offered stillness and beauty right in the heart of a big city. It was a wonderful oasis, a perfect place to lounge outside in peace while enjoying the skyline and marveling in the wonders of progress, the family events such as movie in the park or dog friendly amenities made it such a fun perfect place to live.

I would much rather see extensive development the river to encourage first class recreation, education, nature and stillness than an obnoxious casino. Are you kidding me with this?

The road system into the area is already strained and the casino would only worsen it. Additionally, crime appears to follow casinos once they are built. Whether it be something as simple as additional litter, to public intoxication, to organized crime.

This will ruin neighborhoods with increase crime, noise and congestions.

Wrong neighborhood for all the reasons above. For job creation, the casino should be in a location that most need jobs. We recently visited Boston and its casino out of curiosity. That casino is not downtown but in an industrial area that needs to be developed. It was not built in an existing neighborhood. It will crate trouble, traffic issues, devalue homes. We don't have enough police right now to do there jobs right. Thanks alot Lori

I lived thru Detroit's promise of casinos bringing wealth & jobs to the city. The compromise of our safety for \$\$\$ was evident.

This would be HORRIBLE for the neighborhood

The proposed site is 2 blocks from my kids daycare. 4 blocks from my house. The traffic on this part of the road is already terrible and this will worsen it. It will also worsen the quality of life, my kids and I take walks on this stretch of the road. This will cause us to leave the city. Please put the casino somewhere else. Prioritize families, not gambling.

This location needs development and growth but a casino would trash it up!! Both aesthetically and from a crime standpoint!

I lived downtown Cleveland 10 years ago when this same exact process happened. A casino came in, promised jobs and all these nice things. For the first two years it was great - clean, expensive, and people went. Then when all the wealthy people got tired of it - the casino had to lower the table stakes from \$20 to \$5 to keep people coming, and it became a hang out for the low income people who bring crime, guns, and trash with them.

Terrible solution to fix the mess this mayor has made. She will further destroy the beautiful city we love and the wonderful River North neighborhood. Bad Decision!

There are sufficient independent studies that show that casinos have negative effects related to the areas of my concerns.

A densely populated residential area in an urban city center is not an appropriate location for a casino for all of the reasons listed in this survey.

Safety is a major issue and this is bound to increase risk. We have children at a school nearby and this will be detrimental and distracting to their educational progress.

This is a residential area with already too much crime. There are children and park need that will be affected and the area will loose families.

This is a family neighborhood with lots of children in a densely populated area. Adding the casino would make it unsafe, overcrowded, and increase traffic congestion.

Reduction of property value

This is our neighborhood, we want to feel safe and be free from MORE noise, traffic and crime. We will definitely move if this casino goes in.

Strongly oppose, will sell and move if this moves forward

I own a home in this area and I have a 1yr old daughter. I feel like this is the last safe space in Chicago where it feels more like a suburban neighborhood rather than downtown. It's special. We spend time at the ward park, and it's filled with families. This is not the area to introduce a casino that will, without a doubt, introduce more traffic, more crime, more pedestrians, and more out of town visitors who will not respect our neighborhood. Protect our river north families and do not allow this casino at the tribune center. A more commercial area would be more appropriate.

Pick a different site that is not in the middle of a neighborhood. A casino does not fit - plain and simple

River North neighborhood is a residential one. We have day cares, schools and children parks around, a casino is therefore a complete no.

River North already has issues with bars, night clubs, weed dispensaries etc. I don't want a casino added into that mix. It belongs in a less populated area but in a relatively crime free section of the city, like the museum campus, where people who wish to gamble can do so without worrying about traveling into a high crime area.

A socio-culture disaster in the making and a violation of the community; schools; and churches in the area

I believe the casino will increase violence; as as single female, I would not feel safe to have this built in my backyard. I have ticked all the options that apply-those are my reasons and more.

A casino does not fit in this neighborhood in any way. The negative impacts are FAR greater than any positives.

There is already too much congestion and traffic in the area. Please do not add more people and cars. A casino in the area will reduce property values and increase crime.

This is a residential area and not a place for a casino. Also can't handle the traffic now

Living just across the river from the proposed site makes me very anxious on so many levels for the residential areas right there already checked in the survey. It will impact our homes.

This is a horrible idea the will ruin all the work that has been done to protect the river front.

Crime in our neighborhood has increased over the past few years as it is. If a casino is built this will bring even more crime to our area, reducing property values and forcing current affluent residents to move. If current residents move, this will also negatively impact the demand for entertainment such as fine dining and luxury stores in our area.

Traffic is already extremely challenging during an extended rush hour. A 24/7 casino will result in 24/7 traffic congestion. There will be no down times when traffic is tolerable.

I marked my reasons in this survey.

This is a residential area with many residents. Introducing a casino will result in an increase of crime and a negative economic impact of this area

I do not believe it is prudent to insert a casino

into a residential neighborhood. It would completely obliterate the quality of life in River North for all of the reasons stated on this survey. It would make more sense to place it in the other proposed location where it would be closer to the center of the City and would be more accessible and convenient for transportation. It is apparent the City officials are willing to fast track this development and sacrifice the residents in River North in order to receive the revenue expeditiously because the site is essentially ready for construction. Please consider the residents and the ambiance of the City and do not cheapen either with improper placement of this Casino.

River North is a quiet and safe place to live. If a casino comes into the neighborhood those values will be destroyed. Traffic will become unbearable and crime will increase, making this neighborhood less desirable and forcing longtime residents to move out. A casino in River North is a appalling idea.

Increase traffic and crime

I think that crime and traffic are the main issues

There is already too much entertainment activity, bring crime into this area at night

The area is already strained. infrastructure, crime, density, etc. Negative area economics.

Traffic, crime, reduced property value, parking on residential streets by employees and visitors

Existing infrastructure can't support the prosposed casino, also doesn't make sense to have it in a residential area.

The crime is ready at an all time high in this rea, you have public housing boarded up near there and my property values are already decreasing. Can't drive down Chicago avenue very easily as it is.

Although I cannot control the city's entire thoughts on a casino, I think this area is completely wrong for a casino. With rise in crime already taking place, I think this would only increase. The noise, lights, traffic of vehicles and people would decrease the value of our property as well as the great neighborhood feel we have.

I strongly oppose this being built at this location and in the city all together.

Primary concern is the city's ability to control crime associated with increased tourism and large public spaces. Also concerned that increased traffic will negatively impact nearby residents.

There is a lack of infrastructure there with roads and bridges to accommodate this congestion.

We are already experiencing higher safety issues and don't seem to have the resources/infrastructure to support those - let alone adding new risks.

As a neighborhood resident and parent, I feel bringing a casino to River North will considerably impact the health and safety of my family. Additionally, the increased traffic a casino/ entertainment facility would bring will only exacerbate this already congested intersection (Chicago Ave x Halstead St).

The presence of the casino would destroy this neighborhood as we know it.

This will reduce property values by at least 20%

River North is one of the highest, if not the highest tax paying areas of the city. This proposal will inherently devalue prime waterfront properties and will be taking up great waterfront space for a business model aimed at keeping people inside. Crime has already been significantly worse over the last 2 years, and adding a casino would only contribute to this becoming more of an issue. Does the city want to ensure every single person in River North wants to move elsewhere? Because then building this casino would be a great start. This is the dumbest plan of all time.

This is not what our neighborhood needs. Our safety and the area are struggling enough without that added element of gambling, drinking and behavior that casinos encourage.

The River North neighborhood is congested on an average day, there is no capacity for additional traffic. Additionally, I am concerned for my personal safety. Walking in the neighborhood is a joy, used to do that all the time, now only during daylight hours for safety reasons. The casino would add a safety concern that would prevent me from walking during the day time. There is no space and this is of not benefit to the River North community.

We live on Erie

This project is not a good fit for the area. The pedestrian bridge would not serve any advantage to our neighborhood. Please relocate Casino to the other location where its impact would not be as destructive to a residential community.

Do not feel safe if this goes through

With already increased traffic and crime in the River North area, there is greater concern and risk for more traffic, crime and violence.

The Tribune site is not an appropriate location for a casino. I do not support a casino in Chicago period, but especially not in my backyard. This will bring unwanted congestion, noise, and more crime to River North/River West neighborhoods. My property values will suffer and if this goes forward I will have to sell my home. If I am forced to sell, I will relocate to another city. I have a high income and my job is not tied to Chicago.

This location is not suited for development of a high density entertainment zone. The cities initial proposal PD1426 is for high density commercial and residential. There is no evidence provided by Ballys or the city that the Entertainment zone of a casino / theater / concert hall will have no impact on current levels of Traffic, Crime, noise pollution. I grew up in Vegas. All of these will be issues. I generally like Ballys as the company for Chicagos first casino. However this is not the location for it. Their proposal should shift over to the 78 proposal location currently being offered to RSG.

Already experiencing terrible noise and crime from Clutch Bar below our condo. It's negatively impacted our lives and ability to sleep. A huge casino project will exacerbate these problems and create many new challenges to enjoying our right to a peaceful existence. We love city living and chose our location but this casino should not build here!

This is a high-end, residential and mixed use area.

I live across the street at 720 N. Larrabee on the top floor and face West looking directly at the site. I would have to deal with all the construction noise and when it was done, I would have to live with seeing signage and loud noise. It would profoundly affect my resale value for the worse. This is a DEFINITE NO for me!!

I moved from the East Loop to get away from all the construction and traffic and bought in River North for the quiet neighborhood feel. Building a casino across from me would ruin this neighborhood and change the whole vibe. PLEASE...I"M BEGGING YOU...DO NOT BUILD IN OUR NEIGHBORHOOD!!!

I'm a property owner directly across from the proposed site. I see negative impacts of public pedestrian traffic around Ward Park now with large crowds, late night gatherings, even shootings; the proposed bridge inviting more non residents into the area 24 hrs a day sounds like a huge problem.

#### Residential area

The area is already congested with people and vehicles causing ridiculous traffic. The reduce lane closures for bus and bikes veritably doesn't help.

Adding a Casino will not only create extremely longer travel times but it will also increase crime as we have needless to say witnessed int he last 2 years.

#### Too close

Focus on reviving retail and experiential events instead of gambling and adult activities on the Mag mile

Densely populated area does not need even more traffic, pollution, crime, etc. place the casino elsewhere.

This is a congested neighborhood with continuing residential development. Additional burdens on the infrastructure are unwarranted. Lack of confidence that private and government oversight will be attentive to new security challenges and local impact.

With all the recent development in River North, the infrastructure is already strained. There is more traffic, more snarls, and more angry drivers. Additionally, we have seen an uptick in crime in River North; the addition of a noisy, baudy establishment, such as a casino, would exponentially increase the traffic, noise, and crime.

I live a couple of blocks away and this is a beautiful residential area that will get married by a business that spawns crime and other less savory behavior.

With recent developments in the area, the strain on infrastructure, traffic, public resources is already showing. Opening a major attraction in already congested area will lead to worsening of the quality and safety of lives in River North. NO to casino construction

The impact on traffic on Chicago Avenue traffic will be detrimental. Especially the bridge.

Casino would bring too much congestion of automobiles and pedestrians to the area. This would bring a mega commercial development into a more eclectic neighborhood....destroying its local vibe.

I have huge concerns about this project being considered near my home and neighborhood.

negative impact on home values, crime and congestion in surrounding neighborhoods

I moved to this area because it was quaint, tight knit with families and professionals, and not noisy. Since Covid, the increased crime in this area is horrific and has caused psychological and economic strain on individuals, families, and the community. This area is not made for a casino. Casinos will bring in a reason for increased crime in which the police cannot even handle the crime we have already that is up 35% in the last year. The people proposing the casino do not live here and will not have to deal with it. I know many individuals who will removing out of the city if this happens and I maybe one of them. In this area we already have to deal with the riff raf of Cabrini Green area that account for the most crime just two blocks down. If the casino is built, that crime will begin to rise significantly. There are other less populated open areas in the city in which this can be built.

I live at 360 W. Illinois. Our neighborhood traffic is already way past capacity with all the new buildings including Wolf Point. I can't imagine it getting any better if the casino opens. Also, as it stands now, I currently do not feel safe in my neighborhood and I feel the Casino will bring more crime to the neighborhood.

The casino will attract crime, which is especially concerning for River North given that crime has trended northward in the city over the last few years. Crime was already unprecedented in River North last year. If a casino exacerbates that problem, residents will leave. What does Chicago think will happen to downtown's recovery if River North residents (who are largely working professionals in the city) flee and no longer commute to downtown offices right across the river? It'll be completely regressive for the entire area, not just River North. This is obviously a horrible location for a casino.

I am very pro Chicago casino, but of all the proposals the Tribune one makes the least sense (mostly due to very close proximity to a quiet residential area). Ways they can save this proposal—1) Commit to security outside the casino like in the park and surrounding streets 2) Adjust outdoor venue to partially indoors with limits on how late music can be played and at what volume 3) Provide local residents some monetary discount as their property values will undoubtedly drop 4) Cater more towards non-gamblers

The proposed casino site is located in the middle of a dense residential neighborhood. The Tribune site is also just a few blocks away from two CPS elementary schools.

It is going to increase crime in the neighborhood as it's proven by previous examples.

The traffic on Chicago Ave is already a nightmare. Please, please, please don't make it worse by putting the casino on the Tribune site.

A casino in this quiet, classy, upscale residential neighborhood would be a NIGHTMARE! Awful idea on all levels!!! why not put it at McCormick Place.

Living directly across the River from the proposed casino is a strong concern. Increased traffic, bright lights, noise, potential crime increase. Very limiting infrastructure, the current roads are only 2 lanes. There isn't a direct exit or entrance to the freeway. Therefore the congestion on the narrow surface streets will be terrible. Please do not approve this development.

Casinos should not be located in high density residential neighborhoods. High traffic (pedestrian and vehicle) in evenings and weekends will have significant negative impact on the safety, security, and access/use of public spaces by families with children. This is especially true for families with little children - and as witnessed by the increased number of preschools in the area is a larger and larger number.

Already Way over crowded traffic on Grand and Chicago. Will bring in additional crime to area and devalue property value

A casino is not appropriate in the middle of such a large and dense residential area.

The city is asking residents of the neighborhoods around this side to lose property value for all the reasons noted without any form of compensation. The economic benefit comes at a cost to many citizens nearby.

The infrastructure cannot support this location. Chicago and Grand cannot accommodate the traffic to the site. Connecting the site to Montgomery Park with a pedestrian bridge would only encourage patrons to park and party in the already dense neighborhood east of the river. There is no adequate public transportation to the site.

Traffic Crime

Crime & traffic

As a home owner in this area the big draw is that you are close to the city but it much quieter. That is the reason we moved away from other areas of River North and the city. For that reason I anticipate that this will have an extremely negative impact on our home value because many people buying in this area are looking for similar qualities. During the meeting this was a question that was avoided and not answered which was frustrating. With this size entertainment concept comes the extreme concern for safety. As a women who often is by herself I am always aware of my surroundings but this makes me very nervous for my safety and I hate the anticipation that I might not feel safe walking around in my own neighborhood. It is understood the value that this casino would bring to the City of Chicago but it is disharenting the thought and consideration to this neighborhood that has been neglected by the city. Overall I was not impressed by the selling points that they are trying to make and this development would be a big mistake.

Lack of hotels and shopping in the immediate area portends much traffic activity to access these items resulting in much traffic activity and a bias toward "local" casino participation. This will do nothing to attracting new revenue to the City of Chicago but rather limiting the circulation and velocity of money "internally" vastly reducing ancillary benefit to the River North community and the City of Chicago. THIS PROJECT BELONGS IN AN AREA OF ALREADY EXISTING ACTIVITY (HOTELS, SHOPPING, ENTERTAINMENT AND EASE OF ACCESS) rather than a quiet, existing, residential high-density neighborhood.

The only benefit for considering this location is solely for the casino enterprise...nothing for the city of Chicago, nothing for merchants, nor the commerce of Chicago but a potential blight on an otherwise quiet, enjoyable neighborhood.

THE SWELLING OF TRAFFIC CONGESTION FROM THE OHIO INGRESS/EGRESS RAMPS NEEDS TO BE VERY CLEARLY STUDIED AS THAT WILL BE A MOST SERIOUS IMPACT!

The presenters on 4-6-22 treated the river like an ordinary road. It's a fragile natural resource, part of a blue-green corridor that needs careful attention or it will be destroyed. It should be named a state or national park to protect it from greedy development.

The Bally's location is a purely residential & commercial/industrial neighborhood. It makes no sense for a tourist-centric casino hotel.

Also it brings down the River North brand. Now we have high income tourists and the casino crowd is a different demographic.

This casino will absolutely bring a crime element into this neighborhood along with traffic issues, infrastructure issues, etc. This will turn this neighborhood into a ghost town in 10 years

This is not something that would Benefit the neighborhood and would significantly increase potential for crime, drunken driving, traffic etc. In a place where there's many families with kids and a school around the block!

It's very scary walking around the neighborhood today. I've seen and heard shootings across the street. Gambling attracts an element of people that are looking to take advantage of others. I think criminals will see the casino and its patrons as a predatory opportunity

It makes absolutely no sense to put a casino right in the middle of a neighborhood. I live 3 blocks from the site. The traffic is already brutal here and it would get exponentially worse. I would need to learn more about the potential for crime but I don't really think that's a huge issue. But putting a mega development right next to a highly dense residential area would be awful. It would kill property values (who the hell wants to live next to a casino). Pick a spot in the city that already has the traffic infrastructure (or where it can easily be built) that is not as close to residential. Over by McCormick (which already had infrastructure) or the lesser populated 78 area seem to make a ton more sense. This will be catastrophic for the neighborhood.

Look at Atlantic City, nothing good will come from this.

The area immediately east of the proposed development (across the river) is a strong residential community that will be negatively impacted on many fronts if the Bally's project is approved.

The neighborhood is 4 times (if not more) dangerous than when I moved here 20 years Ago. Crime is out of control. Especially armed robberies, assaults and carjackings. Who feels safe coming out of a casino with money where all this crime is happening? Makes no sense to me and will be the reason I sell my condo. So sad. Wanted to live here forever. :(

A casino in a residential area is crazy for so many reasons. Don't drive out the taxpayers!!

Chicago, specifically river north, has experienced an unprecedented rise in multiple types of violent crimes that threaten our community. I am absolutely certain that this casino placement would worsen crime at all hours of the day. We'd have an increase in drunk drivers and pedestrians at all hours of the day, which would cause an even greater uptake in accidents. The Montgomery Ward Park is a family park for our community to enjoy and instead it would be filled with people coming from gambling, possibly inebriated and possibly upset from losses. I strongly urge the city of Chicago to understand the position it would put river north in through placement of this casino in the Chicago Tribune's place. River north brings a lot of high income and taxpayer dollars, and I am certain that the city would lose that if a casino was built in our backyard. You'd have a mass exodus of families and property value would drastically decline. We love River North and want to stay there but we could not support the city's decision to place a casino in our community. We would move elsewhere and encourage our many neighbors to do the same.

The main reason we purchased a condo in this area is the quiet neighborhood, more residential and less retail/commercial. A casino complex would drastically change the neighborhood. Crime has already spiked in River North and Mag Mile, and a casino complex in addition would tax the police department beyond their capabilities.

Attended the public hearing and the presenting team neglected to provide any factual information regarding how this will truly benefit the neighboring community.

The proposed project being considered is all about money. Money for the city, money for Bally's investor, money in the near term for local contractors, and fails to consider the long-term effect on the neighborhood and highest and best developable use for the tribune site.

Lack of keeping neighborhoods a priority

You will be turning a quiet neighborhood to a loud, busy, overly commercialized community.

A residential neighborhood is not the tight place for this at already terrible intersection. This neighborhood should not have to bear the brunt of unffunded pension liabilities of the whole city. There is no benefit to the neighborhood.

This should not be going into a residential area where there are small children/pets and parks. Please reconsider the location....

Road infrastructure cannot handle the traffic - small Chicago and Grand avenue bridges are already an issue. Noise and crime in River North is already too high and this will only make it worse. There is little to no benefit to the local residents - only downside.

A casino development in an already congested area is a horrible idea. Not only will this bring more car and foot traffic it will also drastically impact the quality of life for those who live near the proposed site. Crime, noise, and light pollution are just the tip of the ice berg regarding issues with having a casino this close to a residential neighborhood. For the amount this area has to pay in property taxes, a casino is NOT a welcomed addition to the neighborhood. Knowing Chicago, you will do this anyway regardless of what your residents think or express.

Halsted/Grand and Halsted/Chicago intersections and their surrounding areas cannot accommodate more vehicle and pedestrian traffic. Further development would hamper traffic greatly in and out of the River North and Loop neighborhoods.

Increased traffic to an already crowded area is to be expected.

There's no room for this in our neighborhood

Really oppose this as I selected this neighborhood because of its relative quiet nature and being located away from most activity. I also oppose the Casino ANYWHERE in the city and especially not here. Ahead of entertainment, consider addressing investment in public transit and increased crime rates in the city!

I own a condo in close proximity to the proposed casino. Traffic currently is bad and this would only make things significantly worse!! We also don't need the foot traffic in the area as it is primarily homes and not businesses. Our little quiet niche would not be so quiet anymore.

I feel this is a terrible idea for this location

The crime and traffic will increase and the bright lights will destroy the beauty of this city. This will all cause property values to decrease!!

Reduce property value, increase traffic

The casino complex would be an extreme drain on transportation in that area, on the already narrow 2 lane traffic; namely the Chicago Ave bridge. The highway is maybe a half mile away, and I cannot imagine getting through that triangle intersection with Milwaukee will be feasible anymore.

The casino itself also does not fit with the advances the River North/West neighborhoods have made in the last 20 odd years - adding parks, expanding river walks, bringing in the Water Taxi, converting loftspace into residences and congregation zones. There is also no hotel nearby to handle casino overflow, thus leading to a significant rise of Airbnb usage (and in turn causing HOA/property tax issues).

Also, the Tribune building is in 2 parts - how the casino complex is constructed will probably negate anyone's ability to cross that intersection again as pedestrians jaywalk across Chicago Ave, which is a very likely outcome.

It just doesn't make sense!!!

CPD 18th District already stretched. Canalized E W traffic tends to overflow to Kinzie (think riot time when other bridges were raised).

This neighborhood is primarily residential, with a good deal of traffic congestion already. Bringing more cars and traffic into the neighborhood will just increase the congestion ane inconvenience for the area. Crime, especially gun violence and carjacking have increased in the area, and more people crowded into the area is bound to increase crime in the area. While their projections about safely, property values, tax increases all pointed to the benefits of having the project in this neighborhood, we have had a number of missed "projections" and unfulfilled promises by other developers in the area. It is bad enough to have increase in population, but a transient population of people constantly coming and going seems to me to be an even worse situation

I lived in a city where a casino was the main attraction of the downtown area. I witnessed first hand the negative impact a casino causes on the community. Traffic, loitering, crime, and the general demographic attracted to casinos is not something Chicago should subject itself to. There's a casino near the airport already, no need to congest and worsen downtown.

The Tribune location does not lend itself to a convenient and positive casino experience for either guests or the neighboring area. There are heavy residential zones in and around the Tribune site that would be heavily negatively impacted from such a large draw of vehicular and pedestrian traffic. The area also offers little support to a casino compared to a downtown or river walk location that already has stronger infrastructure to support the increases as well as increase potential economic gains from a more robust commercial zone.

This is a neighborhood, congested, definitely NOT THE RIGHT LOCATION!!!

crime is already out of control in Chicago, why add temptation for more unsavory people coming to the area

Quiet quaint river north community. Pretty much the only pocket left like this in this neighborhood. This will absolutely ruin this neighborhood with rift raft

This would be a horrible idea for this area. There is so much potential for renovating the old tribune center to make our area the most desirable in Chicago. The moment you put in a casino you will drastically decrease the value of this area harming all of our residents. No one wants to live in a location next to a casino. Chicago already has a huge turnover problem, and if this goes up in this areas you will see most residents decide to leave! PLEASE do not harm residents who have paid good money to live here for selfish reasons by our politicians. The data is out there, this is a horrible idea. If you want a casino put it somewhere away from where people live.

I have lived in this neighborhood for 15 yrs; the neighborhood is quite and i worry about noise

I don't think I need to explain to anyone why building a giant casino in a largely residential area is a bad idea. Honestly, the whole thought of a casino swooping in to save Chicago from its decades of poor governance is pretty pathetic. Don't get me wrong: it's a creative way to offload the consequences of our exorbitant pension debt onto the residents of the community (taking the hit on increased traffic, decreased safety and home values) in exchange for a chance at some quick cash relief. But do you really think the residents will continue to pay this price for long? I certainly don't plan to.

This may seem like a magic solution to increase the city's income, but I think executing this plan would result in a slew of unintended consequences. How could it not?? Does anyone really know what this would do to the city? I don't. And I certainly don't trust the same people that dug us into this financial hole to understand the complex consequences of this plan. The only clear winner in this would be Bally's. I'm sure they'd be pinching themselves at their luck if Chicago ends up being so desperate that we accepted their vague plans and promises and give them our blessing to make a massive amount of money off Chicago residents in the hopes they can save us from ourselves. Unfortunately, you can't fix past mistakes with a newer, bigger, stupider idea. I'm curious what the next magic solution will be to revive the city once this one goes up in flames, but sadly I doubt I'll still be here to find out at that point.

If we were to build a casino anywhere why wouldn't we put it next to a convention center?? Convention-goers would be a built in starting audience. They often have evenings free and would be able to bring money into Chicago instead of the Tribune plan which projects that 80% of revenue will come from Chicago's own residents.

Crime fighting would decrease in black and brown communities as police assets would be diverted

Straining police, EMS, infrastructure and small businesses

Like many things that are offered to be built or improved in Chicago, they normally fall short of what they consider positive action. The neighborhood is currently relatively calm and quiet at night, this will drastically change with the addition of a gigantic entertainment venue and hotel. I could go on and on but will keep this as brief as possible. Thank you.

Terrible location. This is residential with strong property values. This will bring crime, traffic and noise that will deteriorate the neighborhood and property values. We will move out of the city if the casino is built at this site.

My family has lived in the area for 10 years. One of the reasons we love the area is that it had a wholesome, quiet, family feel. The addition of a casino goes against all the reasons we love the area. It will bring many people to the area who do not live there, invites crime, and noise. Not ideal for a family with young children. Not only will the casino cause our family to leave the area, but it will cause other families to avoid moving into the area in the future. Overtime, the property values will decline and then bars/restaurants/other businesses in the area will not be supported as they currently are. The area has potential to decline in wealth, education, etc.

I look directly over the river and the proposed space and the noise, lights, traffic and increase in potential crime is a deal breaker as far as property value and where I would want to live.

I think a larger venue should have been available so everyone that wanted to attend in person could do so. There is obviously interest and concern about this site and you lose the feel of the meeting when remote.

I listened to the presentations that were live streamed and felt it was extremely controlling and not conducive to online viewers to send in questions and voice their feedback. More than 1/3 of the time was was taken up by presentations that were repetitive and the speakers appeared as though they were trying to justify a decision that appeared to have been already made for the site. It was all about the economics it would bring to the city and nothing about the negative effect on the quality of life for residents. There is a lot of research on the negative effects of a casino and no one mentioned this. Also, how many of these people or their employees actually live in the neighborhoods surrounding a casino? Probably none.

The women moderator for questions was distracting, insulting and condescending and acted like a prison warden. She stated she had a teaching background and I fear for any students she ever had based on her demeanor. She seemed to forget that the audience was comprised of many professional adults who were probably more educated and experienced than she was. It was totally unnecessary. Perhaps she took this stance because there is obviously a lot of opposition that the presenters don't seem to want to hear. I sincerely hope the mayor and casino committee take the feedback seriously.

This area is already completely congested with vehicular traffic requiring paid traffic mgmt during rush hour. The crime is up with drive by shootings, care jacking, robberies, etc, and the added casino is just an additional opportunity for all of those to increase.

#### Traffic and crime

To place a casino right smack in the middle of densely populated, already congested neighborhood is utterly ludacris. River North is home to young families and pet owners who live here because of the greenspace and walkability. The potential traffic and additional people in the area will turn this into an undesirable area for people to live.

This is a family oriented neighborhood. bringing in a casino could bring in bad company and behaviors we don't want our children exposed to. Please have this casino far away from residential neighborhoods.

Don't want increased crime and vices; want this to be for people who live here not others.

A casino should be on the out skirts of the city

Safety is a primary reason I live in River North. If the casino is built I think we'll see an increase in crime and I think you'll see a mass exodus from the neighborhood of people who value safety like myself.

I am concerned about the overall "feel" of a casino in general - granted, I don't patronize them regularly but I visited the one in Des Plaines a few years ago. It was mostly populated by people who didn't appear to be in the highest income bracket, including one in a motorized wheelchair complete with breathing apparatus. Depressing and, as far as I'm concerned, the last people who need to be taking such risks. The TV commercials for these spots paint an entirely different picture of the reality, I think. I've been in a few in Vegas (1977) and one in Phoenix (2012). Certainly the promise of jobs is alluring - particularly for what remains of Cabrini and immediate surrounding area - 6-month training at \$50K salary/benefits? Can't beat that! Bottom line - I live several blocks southeast of the proposed site so not sure it would affect me much.

Pedestrians walking in the neighborhood with a lot of cash entering the casino or departing the casino will be a magnate for crime.

As well as increased vehicular traffic congestion and pollution for the residents of River North.

I'm concerned the bright lights and noise will have a negative impact on the river habitat. The neighborhood traffic is already horrendous due to the number of cars getting on and off the expressway. Traffic frequently backs up on Chicago Ave.

I bought last August because River North is a lovely quiet pocket in the city/ please put it on the South Side where conventions take place NOT in a nice neighborhood!!!!! Would hate all the traffic - walking too- drinking - loud- etc!!!! I would want to sell - and my property would go down!

River North is quiet area despite it's density & a casino here would only worsen things

Crime is already NOT under control in this area. I don't see how this development will do anything to decrease the crime which makes the neighborhood less attractive to live in and also will result in poor customer association for the Bally's casino as an organization.

This casino has no place in our neighborhood. This is a family oriented area with high property values that bring in a large amount of property tax revenue to the city.

The economic impact of Bally's Casino coming to River West and affecting River North detrimentally with increased traffic congestion, pollution, increased crime and reducing property values. It is well documented from numerous CNN articles going back to 2013 studying the negative effects of a casino coming to city neighborhoods.

We already have more than enough traffic, sirens, crime, and people. We certainly don't need to add more of any of those. And a casino would totally change the nature of the area—not for the better!

We have enough crime & traffic in the area.

There is already enough traffic, sirens (because of a large level I trauma hospital) and people in the area.

I live across the river from the proposed site and this negatively impacts the quality of life in this neighborhood.

I live at the One River Place building across the river from this site and this directly impacts me.

Being a RN resident myself, and seeing the huge amount of crime and traffic we already have in our neighborhoods, the last thing we need is a casino! Home values will 100% suffer significantly, as I am a real estate agent and hear buyers' huge hesitation with purchasing in RN and surrounding neighborhood because of the potential casino. Tribune site is not the right place for the casino!

I am a homeowner at City Club Townhomes and have 2 children that attend Sonnets Academy on Erie.

We are very concerned about the pedestrian bridge part of the proposal that would allow easy foot access from the casino into Montgomery Ward Park. Our children play in that park as part of the daycare program and we as a family visit that park often, because it's a safe, family, friendly environment.

We are very concerned about the outdoor music venue that will increase the noise level along the river. Our residential, family friendly neighborhood is quiet at night, which is much appreciated. So will our Ward park movie nights now be competing with the musical acts at the casino?! (just a small example).

We are concerned about traffic in our neighborhood. Chicago Avenue is already completely packed during rush hour and that is before the 2 developments on Chicago Ave are even completed, let alone adding a casino.

We are also very concerned about our property values. We bought in this neighborhood because it is residential and family friendly. If a casino was already present in that location we would not have purchased a home here. Our townhome complex is designed to be family friendly and we will all struggle to attract family buyers if there is a casino 2 blocks away.

With the increase of non residents visiting the casino we are worried about the increase in crime. We are already experiencing an increase in crime. When you bring in more people that do not reside in the area, they have no loyalty or commitment to maintaining a safe and secure environment. It's also open 24/7, with alcohol, which also lends itself to an increase in crime.

We are vehemently opposed to this casino location and I appreciate this organization taking an active role in this. Please let us know if there's anything more that we can do as residents to stop this from happening.

#### Increased tour bus traffic

There is a reason why the Strip in Vegas isn't coming led with a residential area. The commingling of a neighborhood environment with that of a casino draw negative impacts to those in this area.

This is a residential an affluent area - it does not seem advantageous to anyone living nearby

I'm leaving in the building across the river, it will block the opened view I have on the west side and completely devaluate the value of my apartment. Without considering the lights and noise we will constantly have in front of our windows. People from this area have kids and we came to this area for this very reason. The casino would completely change the dynamic of this neighborhood and I don't think for the best. On top of this, this will imply a lot of traffic in this area and the road aren't sized to receive that much traffic.

The negative impact to the community, crime, and property values strongly outweigh the small job creation impact and tax revenue.

Due to the nature of this being a residential area east of the planned temporary and permanent space, (not mixed use) there will be more noise and lights. Architectual design shows a huge screen and that alone is concerning. The design does not match the area aesthetics and sticks out like a sore thumb. Whatsoever noise bounces off of buildings here.

This type of project is not meant for a neighborhood. It will absolutely devalue neighborhood, create crime, crush traffic, and change the neighborhood from a quiet desirable place to live to a place we would absolutely move out of.

I am a resident with a family and a small child, with a church community that has a strong connection with the neighborhood and the people. We do not want large transient groups of party goers attracting criminal behavior and causing scenes, especially in an area with a population of vulnerable people. In addition, the police have enough on their hands trying to handle the existing crime problem. We need less vice, not more.

Traffic is already extremely congested, and adding casino traffic will only further exacerbate this problem. In addition, this may increase drunk driving incidents as more people gather in one confined area for long periods of time drinking. Property values frequently decline near the building site of a casino, so this is also a huge concern for local residents. We already have an issue with high crime rates in River North and not enough police / law enforcement officers patrolling the area, and I fear this would only take these important persons away from current areas of River North to staff the new casino development area.

This is already a very busy crime-ridden area. We're already afraid to go out of our homes at night.

The neighborhood does not have the infrastructure to support a casino.

Crime is rampant in our city already. Our government is unable to do anything about it as it is. Casinos tend to attract crime and we just cannot afford for that to happen.

It just doesn't feel like a fit. And the potential problems outweigh the benefits like the Riverwalk extension.

A casino that would be open 24/7 is not a good fit for a residential community. In addition, being right across from a densely populated residential community will not beneficial for the inhabitants. There will be increased traffic, pedestrians, noise, and the lighting from the complex will be obtrusive into our apartments. Also, if the bridge goes in which it should not, casino goers will probably park on our side of the river which will decrease the available parking which is already limited. Furthermore, Ward Park is a big destination for families in the area due to the playground and grass space. It is not suitable for such a complex to be so close to a family based area.

This has a negative impact on all of Chicago

Pretty straightforward

The location is terrible. There is only one bridge letting you into and out of river north and it's already horrific. This build would destroy our ability to get around not to mention the other reasons listed.

This is a highly residential, quiet family area, which was a major consideration when I moved here. The city has done everything possible to erode the family friendly, crime free area. I am not in favor of the pot dispensaries, increased crime from political policies and lack of safety for the residents of this area, just to increase taxes for the city to continue to squander. I do not want to see large casino lights and constant traffic, and increased crime to destroy the life we have built here. If you build this casino here, I will have to move away from family and medical care.

The area around the proposed Bally's casino site is much too heavily populated to be considered for a logical location.

As a home owner as I see no benefit in having a casino on the Tribune lot. It's not a well suited business for a quiet / family oriented area of the city. I choose to live in this part of river north because it offers a small bit of peace and quiet next to the park and river away from the hustle and bustle of the city

the Bally's Casino project will add crime to an area that already has had a tremendous surge in crime in over the past 2+ years

I live in the neighborhood. Having a casino would invite all kinds of negative activity: more traffic, more drunks, more noise, more rowdy behavior. Let's find a more positive use for the property.

No good can come to River North via the introduction of a casino

Casino's have a seedy element. We have plenty of casinos around the Chicagoland area that people can go to already. We do not need to be a Gambling mecca. We have an amazing waterfront and park system that we should enhance - and neighborhoods need more support for shopping and dining and entertainment development. We need crime to be controlled more before we decide to add an element that will just increase criminal activity.

I believe the wrong element would be constantly present

I attended the 4/6 Town Hall meeting. Bally's representatives side-stepped the questions. It was nothing more than a choreographed dog and pony show, with the Bally people reading from a memorized script. The Bally people could care less about the quality and concerns of the neighborhood or its residents.

Increased traffic of people who gamble

I oppose the proposed Casino as this is adjacent to one of the most unique areas in the city.

River North has the unique distinction of being a quiet residential area adjacent to a vibrant downtown and yet enjoys upscale restaurants and lounges that make this area highly desirable.

The casino has nothing to do with improving the environment or the neighborhood. It has no social or cultural advantage. It's sole purpose is to make money. A very poor use of one of the last build-able vacant land 10 minutes from Chicago's famed Gold Coast.

The city should encourage projects that raise the cultural and economic incentives for high paying jobs with upscale venues that attract a return to tourism to the city; not attractions that encourage potential for crime and decrease in property values with will negatively affect the city's residential development and real estate tax base.

It's a proven fact that crime will increase around the casino. There should never be a casino in a residential area. Our lives will be severely impacted in a negative way.

I moved to River North to enjoy my peace.

This is so disruptive and we already have enough crime & traffic. We are not Vegas

This will negatively impact my neighborhood in many ways: it will increase noise levels, bright lighting, traffic (vehicle & foot). Additionally, it will create a strain on the existing infrastructure and decrease property values. This is a quiet neighborhood with many families, and having this in our backyards will be devastating.

History will tell you in other Cities what happens in the areas where Casinos are established. Lower property values, crime, traffic, decline in neighborhoods and communities

Increased crime and reduced property values. I have live across from the site on the river fro 15 years.

We have been in this neighborhood for 10 years and recently had a baby. Crime in the area has already increased. A casino will most definitely destroy the family friendly atmosphere of this pocket of river north.

The River North Area has seen increasing violence in the last few years, and I believe that this will bring more of that to the area.

Great increase in unruly persons, a magnet for problems, to say nothing of decreasing property values in a well developed area.

The city has proven woefully unable to manage the increased noise, crime, trash and general disruption of residential areas from the increased clubs and bars in River North. Adding a casino to the already declining situation would be appalling. The fact that the resident association found out about the proposal from news reports is evidence that there is little likelihood the high risk of negative impacts will be addressed. The continuing disregard to the residential areas of River North and their voice and legitimate needs will result in decline of home values, loss of businesses, and eventual exodus of residents from the area

The current crime in the area has increased greatly. The police are not able to handle the crime in the area. Tourist are prayed upon and this will just bring in more people looking to steal for people visiting. We have heavy traffic and I do not see it being possible to handle more. I do not believe any security the casino would bring in would help once people are a block from the casino.

The money will never be spent where they tell us it will be and the crime will lower the value of our homes even more.

I don't oppose the casinos in concept,, I oppose the fact that they will never build the infrastructure needed to support it to keep the traffic out of our residential neighborhood just across the river. There will always be challenges unless, for example, they pay to replace and widen the Chicago Ave and grand ave bridges and create a direct on/off from the Kennedy on the West.

Most concerned about potential crime, especially in a city where police resources are strained already

I have read many articles on the blight a casino brings into a neighborhood. Chicago already experiences high crime and bringing in more outsiders into the neighborhood will only feed the potential for crime. I see the potential for victims of violent crimes against them, because the assumption they have money to spend to gamble. The value of the homes have already been diminished by the carjacking, robberies, and lotting. The tourists trade for the downtown will not be enhanced by a casino. We have not recovered from the pandemic. I am strongly opposed to this idea.

The neighborhood is quiet, a peaceful combination of residents and businesses. It is the quiet part of river north and should remain so.

There is a reason no one wants this in their back yard. Casinos are not a value added. We will move.

It is too big for the space

Multiple studies have proven that casinos devalue surrounding residential properties. I do not want my condo to decrease in value. The plan includes a pedestrian bridge linked to Ward park. This would be a disaster for the small, family-friendly park.

The infrastructure is not currently conducive to increased vehicular traffic. Altering the infrastructure would reduce neighborhood feeling of nearby neighborhoods as well as make the area even less bike/pedestrian friendly than it currently is. Blue line behavior is already alarming. Even the construction required to redo the Kennedy expressway exit/entrance would be a nightmare. Neighborhood already has loud late night pedestrians and more are not needed. While residential development would be great in the area with businesses to support the additional residents, making the area a "destination" area would ruin a large swath of city. If this goes forward, recommend closing Chicago Ave bridge permanently.

We already have a crime/safety problem in River North, and building a casino will attract A LOT of non-residents to the area, which will likely draw more crime. Not only will that pose more safety issues, but it will also drive down our already decreased real estate values.

The existing infrastructure cannot handle the proposed increased traffic and strain on sewer systems, garbage, etc.

1) Traffic—streets were narrowed and turn lanes removed in area when Target was and New City complex were built causing traffic issues. A casino will only exacerbate. 2) The streets in area are not maintained—several potholes that will only worsen with more traffic. 3) Our property taxes have increased over 50% in the last 5 years because of assessed property value which will greatly decrease if a casino is built. 4) Casinos are 24/7 with bright lights changing the landscape of the area and, again, driving down property values. 5) A casino invites 2 addictions—both of which can trigger desperation. This desperation can lead to higher crime. 6) Crime—the police are not able to manage the current crime in our area, much less police additional crime. 7) Dangerous driving—currently people consistently blow through the stop signs in area (especially at Kingsbury and Oak) and drive the wrong way down the 1000 block of Kinsgbury. 2 dogs have been hit by cars at this corner—1 killed. More traffic and more unfamiliarity with area will only escalate these incidents. As such, the River Village area is currently a family friendly area, and this will deter families further affecting our property values.

The proposed casino will not fit into the fabric of the area. The are has turned to mostly residential. The existing infrastructure will not be able to accommodate.

I have a hard time getting in and out of my building now as it is. Pedestrians and cars make it a difficult place to live. Cars blow the lights at Grand and Kingsbury and are always honking their horns all hour of the night. I can't see how Grand Ave, and the bridge can support this.

I am a property owner for last 18 years and crime keeps on increasing and with casino if will continue to grow. The area can't handle traffic on chicago or halsted aves.

River North has already seen a marked increase in crime. The LAST thing we need is a casino!

Increased crime, poor traffic access, increased traffic, increased pedestrian activity, not the correct use of this wonderful Multi-Family Site.

It seems there would be better locations in Chicago for a casino.

Halsted and Chicago is already very congested plus the development at the Greyhound building is going to add to that issue.

The music festival held across the river is a good taste of what life would be like on a nightly basis. Tons of loud drunk people spilling out into the streets. Jammed up traffic. Right now this area is actually a pretty quiet place to live.

The infrastructure in this neighborhood already cannot handle the existing traffic,

let alone the additional strain this devwlopment would add. In addition this would detract from the family centered neighborhood that currently exists in this area, and will further encourage people to leave the city to live in the suburbs.

In light of all three proposed sites, 78 seems to be most well planned including educational opportunities for children & technology training.

This area is full of small children and dogs and young families. It is not the right area for a casino. It changes the neighborhood entirely. Put the casino with other hotels and conference centers - not in a residential community.

I chose this neighborhood to raise my children as it is a is mini suburb in the middle of the city. Quiet, light traffic, little transient foot traffic, a serene riverwalk for my children to play/ ride their bike/scooter/skate safely. A Casino will disrupt the residential neighborhood ecosystem.

Living in this neighborhood for 18 years, schools have merged to provide better education and equal opportunities. Casinos have no place in neighborhood where there are families living. The Windy City Smoke Out used to be in that area and the music and crowds were so loud. I was happy that was only 3 days a year and even more thankful when they moved it to the United Center. I

Traffic is already horrible. There is a park across the river from it as well as homes that will be disturbed by lights and noise.

I live across from the Tribune building and would leave every year when the Windy City Smoke Out would be in town because of the excess noise and crowds. I was elated when they moved this out to the UC. This area of river north is one of the few, quiet, family friendly neighborhoods left in the downtown area, and taxpayers in this area value these features over everything else when they choose to live here over other parts of the city. Additionally most Chicagoans are already anxious and aggravated about the increase in crime that has yet to be addressed by our city officials. I don't know why you would want to drive more of your (large) taxpaying citizens out of one of the few more family friendly downtown areas left.

I am opposed to this and find it disgusting that the city would find it acceptable that Ballys chose this location. A casino was built close to my home when I was a child. I remember increased traffic made my parents' commutes worse and made it harder to move around in the surrounding area quickly. As a child who biked to friends' houses nearby, I was nearly hit by drunk drivers twice in what had been a quiet neighborhood with little through-traffic before. I also remember crime rates increased dramatically in my neighborhood after the casino opened. It would cause more traffic, noise and bring down property values

I believe gambling has a negative effect on the most vulnerable, resulting in addiction as well as financial devastation. While I know we need to find sources of revenue, this feels like an icky way to do it.

The traffic is already horrendous. The area lacks the infrastructure to support the casino. Crime is already bad and will get worse

Already so many more apartment complexes going up in the neighborhood that I don't think the neighborhood can support.

There are so many wonderful things are community could use...a casino is not one of them

Makes no sense to put a gambling casino on the internationally known Michigan Ave. Best located on Related 78 just south of Roosevelt.

The area will be way too overcrowded

Will bring too much traffic into the neighborhood.

We already have enough niggers fucking up this neighborhood and now you're going to build what amounts to a pile of nigger sugar on the picnic blanket that is River North. That's why I'm against it.

I am worried that this neighborhood will be unlivable. I've been to Vegas, I don't want that anywhere around my condo.

While I am not against a large standalone facility where people drive and park, go inside to gamble or eat (I am thinking Rosemont's casino).. and then drive away ...this seems more fitted to a major complex that you see along a suburban highway. This is more like a "campus" with hotel, outdoor concert venue, etc. The already densely populated area will be severely impacted. I think this is more than a case of Not-In-My-Backyard. This is shoehoming a very large structure that anticipates high traffic and destination-type events...and I am strongly opposed to something of this magnitude in that area. The traffic alone, as every night, the Kennedy is already backed up, and Ohio Street, Orleans Street, Grand Avenue, etc. That will only increase and make an already difficult commute for people even more difficult.

The original planned development was meant to stimulate business development and collaboration - the true American dream. Casinos do not bring neighborhoods together. this is not the right place for this project

This is a quiet neighborhood with next to a kids park. This is not an area that has loud clubs. In fact the one club that opened in the neighborhood had to close due to noise and crime. Additionally casinos lower property values by 10%. Which not only harms me but harms the cities property tax revenue base

The developers report on traffic, I believe, is not accurate. The current infrastructure cannot handle the peak hours. Unless there is significant changes to the streets, I do not believe the experience of living in the area will be pleasant.

The presentation by Bally's and the City of Chicago was disingenuos at best - as illustrated by the comparative 'value' of building a casino versus what could 'potentially be built due to approvals granted for PD #1426. Comparing residential/office/multi use occupants to hotel/casino occupants is laughable. This structure will devalue our property values and only contribute to more residents leaving the City and the state of Illinois.

The activity present with such a complex would break an already strained infrastructure in our neighborhood. The presence of additional traffic, noise, light pollution and police activity would become our everyday/all day environment. This type of operation does not belong in such a densely populated area.

## Gamboling addictions

My major concern is about the ability of the existing infrastructure, namely Halsted Street and Chicago Avenue, to handle the increased traffic from the casino. Anyone who has travelled to this intersection during rush hour or on the weekends will find themselves stuck behind a ton of cars that are backed up from the Grand Avenue, Halsted and Milwaukee Avenue intersection to the south or Chicago Avenue headed east.

In addition, there are no good public transportation options except for 2 bus routes and no good way to connect to Metra and the CTA which means that the most likely way for visitors to get to the casino is by car.

Finally, River North and River West is already swamped in crime that is mostly caused by visitors and tourists in the area. The Chicago Police Department can barely handle the crime on Hubbard Street on the weekends. They are under resourced as it is and I doubt their ability to handle the increased crime that will happen if the casino is located on the Tribune site - despite their very best intentions and efforts.

I live across the street from Montgomery Ward park- in a special part of one of the world's great cities. The Bally's proposal will ruin the neighborhood. The infrastructure and traffic problems simply cannot be resolved with a nod, smile and promise of "improvements". A bridge to a casino across the river at Erie would be an absolute nightmare-shattering the character of this locale forever. The other two finalists have much easier access and better transportation infrastructure already in place. Each is a far better fit for creating a massive entertainment district. Building Chicago's casino at the Tribune site will be an utter disaster.

I vehemently oppose it.

This is the worse possible location for a casino. It is basically a residential area, with residential infrastructure, and throughways. The area is completely unfit for any additional traffic as it is already strained under the current load. The risk presented by bringing in an untold number of strangers on a daily basis to an area that already suffers a crime rate that is reprehensible is simply negligent. Expect law suits against the city to abound.

I live a few blocks away from the site. Traffic and crime are already bad and getting worse. I strongly believe the casino would only make both issues worse than they are today.

This neighborhood is already getting gunshots every day we don't need more late night foot traffic from outside the neighbor. I'm scared for my life.

I've seen what casino projects do to a community first hand and it does not belong in River North.

The traffic and infrastructure of the bridges and flow on Halsted is already a significant problem. Additionally I have been to many urban casino complex developments which claim to be better for the area and they are crime ridden and poorly maintained with excessive problems. Our building at 500 West Superior is already contending with 3 different episodes in a year of significant gunfire through our windows that the city has no idea how to address and now they think adding this will be ok??? It's not an entertainment venue corner, period. Additionally, ballys as an operator is not strong and will not execute as they claim. I was privy to their investor proposals and there was nothing professional or promising about their plan and a bad indication of their ability to execute.

Main is concern for crime and potential drunk and belligerent people

Worries about crime and unruly people. We have a quiet, residential, family-oriented community, and want to keep it that way.

West River North is quite - the increase in crime recently has already destroyed values and this will draw more crime to the area.

very concerned about traffic and crime as its a huge problem here

i am trying to raise my family in one of the last desirable neighborhoods in the city. if this happens, i am moving out of the state.

I can't think of anything worse for the city and our neighborhood than a casino. The amount of vehicular and pedestrian traffic will adversely affect our lives. The crime will UNQUESTIONABLY get worse than it already is. We are having a hard enough time curbing crime in our once safe neighborhood. If we put a casino nearby, our property values will PLUMMET!!!!

Casinos has massive negative externalities. If this casino must be built, build it as far away from a residential area as possible.

This is a terrible idea and doesn't benefit the residents of the area.

Crime is already a concern in the neighborhood. Attracting people from all over the state to come and drink and gamble in excess seems it will only make that problem worse.

Also, this is predominantly a residential area. Bright lights and loud noises are detrimental to residentially zoned areas.

River North is an economically robust and continually growing neighborhood with high property values. A casino may have a positive economic impact in a distressed area but not one that is already as desirable as ours. We all live here because we want to be in a prosperous NEIGHBORHOOD. I went through the Bottled Blonde wars, which had a significant negative impact on property values for nearby buildings, and that was a small club. There was so much vandalism, public urination, unbelievable noise, fights, gunfire, drug dealing, drug use, major traffic tie ups, etc., etc., we were afraid to go out to walk our dogs.

River North has enough crime and violence (gun shots going through condo building windows) with the clubs off of Orleans/Hudson/Erie open until 2am

Traffic on Halsted is horrible as it is - a huge casino is going to cause further traffic issues all day and night.

Complete disconnect with the nature of the immediately adjacent residential areas.

The area isn't remotely capable of handling additional traffic and would be a blight on the surrounding neighborhood due to noise and light pollution.

I've lived in River North since 1995, I am a pioneer in the area and have watched every building being constructed in the neighborhood, along with the accompanying congestion. This neighborhood cannot sustain such an explosive expansion.

- 1. People who go to casinos stay inside a building. It seems to be waste of land along the river to put a casino where gamblers will not take advantage of the river location.
- 2. Local streets are now jammed during rush hour. This will certainly add more traffic.
- 3. Access to the location is not good. There is no easy way to get from the highway to the location and I bet the developers will rely upon state and local governments to upgrade infrastructure leading into the casino.
- 4. There needs to be a way to make a better apples to apples comparison. The developer says that the future alternative use of the site will bring more traffic. But the future use being residential is very different. Residents spend in the local neighborhood. People going to a casino do not spend in the local community. A portion of new residents will take public transit or work from home. Every single person going to the casino will either get there by bus, taxi, Uber, or private vehicle (unlikely that a % will walk).
- 5. The experience of Atlantic City should be an example. How much did people who went to the casinos spend money in the neighborhood and what was the associated local economic benefit?
- 6. The City of Chicago should not put the burden of a casino on the backs of two residential neighborhoods just to reap the tax proceeds that can then be used for any expense the City has but not necessarily to improve conditions in the neighborhood.

The neighborhood is largely residential and family oriented. The existing zoning allowing residential and office on the Tribune site is compatible with what already exists. A casino is not.

Strongly opposed to the traffic, noise, and light pollution. A casino does not fit with a quiet residential neighborhood.

A Casino DOES NOT belong in a residential neighborhood. period. If Mayor Lightfoot insists on having a casino in the city - there are other non-residential areas that should have been considered. I am strongly opposed as this project will negatively impact our quality of life which all of us who live in the surrounding neighborhoods work so hard to protect. This is where we live! and our kids go to school and we walk our dogs.... the negative impact of this development is monumental for all the reasons in the previous question and more. The casino will be operating 24/7 - this is not an event that happens once a year or even several times a year. Our quiet neighborhoods will be bombarded with noise, traffic, a transient population of thousands of visitors, trash, crime, pollution and more. The negative environmental impact to our river and it's banks is also a very major concern.

Traffic impact to Orleans Street and Chicago Avenue. Bright Lights. Noise.

Have owned property there for years and walking in neighborhood has been safe even though uptick in crime recently

The west part of river north is almost entirely residential. Building a casino would be incredibly disruptive to the thousands of residents in the area and destroy property values in the area.

Measures to eliminate or mitigate violent crime, particularly along Chicago Ave have been failures. Adding a casino to the mix is a prescription for disaster. The exodus from River North will cause economic harm to Chicago far exceeding any financial benefit from a casino. Why would anyone believe for one minute that crime. Does City Hall have any clue as to how many people in West Town and River North are already thinking of leaving ?? Control crime first. Then talk about growth in the area. I really don't want to say good bye to an area I love, but this would do it.

Also will there also be development by Bally's/Other on the NE corner of Halsted & Chicago Ave, which will cause further congestion, at a minimum? I do understand these sites will be developed no matter what, but we should always endeavor to minimize congestion/noise and keep the area safe. At the 4/6 Town Hall, Bally's said traffic would be spread out more evenly through the day as opposed to an office building. While this is true to some degree, at least we know the traffic patterns of an office building; the weekend traffic with a casino would be awful, not to mention if popular concerts are held either indoors or outdoors. The boat traffic would increase and I just imagine this becoming a "party zone", not to mention the increased crime/safety issue. This area really is a very family oriented, quiet area of River North—we have a children's park right here! They are not building by a community college, as they referenced in their presentation; to me that was not a good comparison.

Casinos obviously promote gambling, and gambling has many negative social impacts such as crime, personal bankruptcy, family problems, etc. The revenue is not worth it!

This is a mixed use but largely a residential neighborhood. Noise will be significant. Traffic is already at capacity and this will cause significant additional problems. Crime is already bad and it will increase. The proposed bridge element will also connect a commercial casino development to a family park and neighborhood, causing the linkage, noise, crime, etc. to be heightened.

It is a very poorly planned project in the wrong area.

This is not the type of development that belongs in a residential neighborhood. The additional traffic – both street and river – will be a nightmare, especially due to the 3-lane limit on the east side of the river on Chicago Ave.

Building an entertainment venue in the midst of an established and prime residential neighborhood is illogical. The appropriate location for this new development is along the lake and close to Soldier Field.

Casino should be nearer the loop so that visitors will be more likely to visit it. I favor the creation of a casino in Chicago, but not in the middle of a residential area. Near McCormick place would be the best location.

We already have more than our fair share of crime....given the existing low rise public housing that seems to have a great deal of gun violence with no action and no proposed solutions. Add gambling....and I fear the neighborhoods surrounding the proposed Bally's site will be almost unlivable.

The area is already bad with all the car jackings and robbery, this will only bring in more criminals.

Going to over populate an already heavy populated area, bring more crime and unwanted people to area.

I strongly oppose a casino at this site. We are mainly a residential area. We are a community that takes pride in our small part of Chicago. A casino does not belong here. Property values will fall for residents. People will not want to live here. Families will not want to live here. Put the casino near McCormick Place where it belongs. Stop disrupting neighborhoods. I do not want a casino here.

At best, the benefits of new casinos is mixed. There are many costs, and often they are not offset by the gains.

As a homeowner in Old Town/River North only living a few blocks away who walks these streets every day I can tell you that a casino is a horrible idea to put in a residential area. We have at least 3 schools within a few blocks from the Bally's location, these kids are out playing in the streets in neighborhoods. This is not a business sector or a rural area, these are residential neighborhoods with families. This is already an area that has crime, from shootings to auto theft to drug dealings. Bringing in a casino is telling all those criminals that there are now a lot of people carrying cash around the area. This will drastically increase the crime in the area, which is something that everyone in Chicago should want to see decrease and should actively be working to decrease it, not make it worse. Furthermore, as this is a residential area, many of these families are homeowners. Casinos have statistically decreased the property value of surrounding homes from 3 to 10%. Bally's is not going to compensate the homeowners for their lost in property value. Traffic in the area is already extremely strained. Crime in the neighborhood has continued to get worse and a casino will only continue to foster an environment where crime thrives. I recognize that the casino will have security and cameras on-site, but a development of this size will ripple crime and other ancillary effects for a very large radius in the River North neighborhood. I STRONGLY OPPOSE this development and will consider leaving the City of Chicago, which has been my home for over a decade, if this casino is approved.

Crime and drunks

We've been residential property owners in River North for 20 years and have watched the quiet & charm of this historic neighborhood be replaced by flashy new construction and most open spaces (including uncovered parking lots) have vanished. The huge influx of rentals has brought a community with little regard for property, property values and no sense of pride in the atmosphere. Furthermore, the city's disregard for the beautiful brick structurally sound buildings that are pulled down rather than re-using makes the numerous architectural tours in this area a farce. Vehicular traffic is a nightmare, the crosswalks & sidewalks are no longer safe.

It's hard to feel a sense of calm well-being whilst outdoors. There are many neighborhoods in the city that are under developed and would benefit from an employer moving in. This area is not the answer.

I feel the development will cause the property values to decrease, for who wants to be around increase noise, traffic and congestion. The reason why I like the neighborhood now is because it's quiet, and it's strictly residential. I feel it should be closer to McCormick Place so it can benefit from all the attendees from the major shows that occur there every year without impacting a dense residential area. If the casino structures are not properly designed to prevent bird strikes, the complex of buildings with their extensive glass and lighting located directly on the Chicago River will kill thousands of federally protected migratory birds over decades to come. An existing building in this area -500 W. Superior - is documented to kill hundreds of birds every year.

The city needs to reduce expenses instead of finding new revenue sources. Too many people who can afford it the least typically frequent casinos.

This proposal from the mayor is ill thought out, and does not considered long-term consequences to quality of life and the subsequent economic downturn that would result.

Too much crime in the area already. This will bring even more people to the area that may exacerbate the problem. The bridges and roads are congested enough already too.

River North already has a lot of crime for a high-end neighborhood, and the LAST thing we need is to attract the gamblers from all over. This is just degrading the neighborhood!

River North has developed an increase in crime over the past several years. Bringing such a development can only serve to further increase crime, further strain the already nearly invisible police presence, increase traffic (and likely carjacking crimes) and late-night auto noise.

I bought my unit 19 years and 10 months ago. I was one of the first residents in the 758 N Larrabee (Old Montgomery Ward) Building. I took a HUGE gamble purchasing my 1 bedroom 1.5 bath condo when there were few buildings around and Cabrini highrises were just 0.8 miles north. I have enjoyed city living, but with privacy as my unit faces the Chicago Tribune building. In fact, I lived there for 5 years before I even bought window treatments because who actually would even be able to see into my unit? I have seen much growth to the area in the almost 20 years of my ownership. And while the projects have moved out if the area, there is new crime. A HUGE concern for me is increased amount of crime that will flood the area. Additionally, as I was drawn to the quiet, peacefulness of living 2 stories above the river, that quiet, peacefulness will abruptly come to an end with a new outdoor music venue, neon lights, etc. This is a very poor and unfair choice to the River North residents who have spent SUBSTANTIAL savings to live in a nice area!

It's a casino, not much else to say

I do not want a casino in my backyard. The increased noise, lights, traffic congestion and crime will make it impossible to live here. I will have to sell my home.

The city cannot handle this. We don't have enough police today let alone the chaos and negative element a casino would bring. Chicago was a beautiful city. To bring this into an already crowded space is short sighted and pathetically desperate. Elevate your thinking don't grab fast cash without realizing the expenses that come with it or you will immortalize yourselves like the infamous parking meters, traffic cameras and there crux of the problem-pensions

Casinos bring crime, high traffic and a lot problems associated with casinos

I like living in a neighborhood, not Las Vegas!

Not opposed to casino per se just not the right location

This is not a good location for a casino for reasons as stated. It is already too congested and there are better locations for this project in other areas of the city.

Will crowd our area

River North is a neighborhood. During the Windy City Smoke Out, the uptick in traffic alone was difficult for the neighborhood. Having a casino move in would create log jams. We also have many one way streets in the area that would confuse tourists. We are away from many of the nightlife/hotels on michigan avenue, which would likely lead to attendees drinking and driving. Finally, there is almost always a spike in crime. This is a neighborhood not an entertainment district.

Infrastructure around the site is already overstressed. Planned roadway improvements, in particular those on Halsted and Chicago, simply will not support the demand created by the proposed casino complex.

It is unnecessary. The river north area is beautiful as it is. There is no need to attract 100x the people to this area as it would likely ruin the positive development that has occurred over the last 25 years

Chicago doesn't need a casino. There are already casinos in the suburbs. No one that lives in the city wants this. Chicago already has bad traffic, lots of tourist, and crime (depending on area). We don't need to add to make things more chaotic.

## Live in the neighborhood

I am terribly concerned the existing infrastructure of the neighborhood will not accommodate increased traffic flow. I am also concerned a casino will invite more criminal activity compromising my safety in the neighborhood and affecting our property values.

Residents are already moving out of the city for the suburbs with the added congestion and crime in the river north area. Adding a casino will have an adverse impact on several quality of life facets of those living in the river north area. I am strongly opposed to the construction of this casino and would move should this casino be approved.

Halsted and chicago is extremely busy as it is and current infrastructure does not support having additional vehicular traffic. We all know casinos bring more crime to the area. This is a RESIDENTIAL area and not fit for casino site.

Illogical to introduce a casino in an already up and coming area and hinder its development

Halsted is one of the most congested corridors in West Town due to the lack of a major north/south road connecting the North/clybourn/Lincoln Park areas and Fulton Market. Without a plan to significantly expand Halsted into a major thoroughfare like Ashland (including a new bridge by K2) this location (particularly during events) will greatly exacerbate the issue, making the area almost unlivable.

This is area is becoming too over developed without the infrastructure to support the increased traffic. Crime has significantly increased in the 10yrs I've lived in the west loop. The city should focus on addressing current crime problems before bringing in another large development. And last, there has to be other areas within the city limits that can accommodate this: Soldier Field, McCormick Place, south shore of Lake Shore. Or what about near ORD airport. That area already has highway and CTA plus Metra lines.

bad impact on the community

We enjoy our safe, quiet and tucked away neighborhood from the hustle bustle of the city and congestion. This would be a horrible strain on us in all capacities mentioned.

The renderings for the project showed a brightly lit building facing the Riverwalk. This is not good for those who live in buildings facing the river south of Chicago Avenue. Although the plan shows three access points, Chicago Avenue would likely experience most of the traffic increase in the area. Chicago Avenue is already congested and can't be expanded beyond what is there already. I watched the presentation on the live stream. The presentation was very good.

In my opinion it could have positive and negative results.

It destroys the lives of poorer families

Casinos bring an unsavory element to the city. This casino is right in the middle of an established, quiet, upscale neighborhood. I don't want the property values to decrease due to noise, crime, and traffic. The area already has many condo and apartment buildings and is congested. We don't need further stress on the infrastructure.

This area of the city is already a draw for people who don't live in the area. Choose an area in the city that doesn't already attract a lot of non-residents.

I think there are better property options outside of this area

This is a poor location for a casino. It is not close to transit and is not walkable from the main tourist centers. It is not the right fit for this neighborhood.

I do not agree that any casino anywhere near the already packed area is a good idea. Continuing the upward trend of violence will force more movement out of chicago very quickly.

As one of the only main north-south streets that crosses over the highway and the river it would in effect eliminate being able to get on the north side easily. i am dead set against it and i am sceptical it will make money at that site. we don't want the casino and certainly not an empty one.

Avenue and Halstead Street is actually being considered and a finalist. Simply put my family and I, will leave Chicago if this comes to fruition. The western portion of River North is a residential neighborhood whose charm and livability will be destroyed by such a 24/7 project. The additional noise and increased tourist related river, pedestrian and vehicular traffic will devastate the already dense residential infrastructure. Montgomery Ward Park is already at capacity on the weekends and on all nice weather days. It cannot handle the increased traffic from the proposed pedestrian bridge and outflow from the Casino Complex as concertgoers and gamblers leave the casino at all hours - but especially at night when families are putting their children and babies to bed. The increased crime and decrease in property values will damage the neighborhood. Shame on all of those willing to destroy people's homes and family's sense of comfort and peacefulness for a garish casino, where the vast majority of people lose money, not make money. How overly simplified can an argument be that a casino will only benefit the local economy, when the vast majority of folks lose money when they visit the establishment!

The traffic impact will be horrific. Currently at rush hour, W Grand Ave, Halstead Ave, Kingsbury and Chicago Ave are at gridlock. I am a real estate broker and attorney and have extensive real estate knowledge. Also own property in River North and South Loop

Halsted, Chicago, the intersection of Halsted/Grand/Milwaukee, and Lake Street cannot handle the traffic coming and going from the casino. Increasing vehicular traffic along Lake and Randolph Street via 90/94 ramps will put more pedestrians at risk. The increased traffic will impact small Chicago businesses as people will be less likely to venture outside of their local neighborhoods due to traffic congestion. The casino needs to go into the 78 because the developer can plan all of the infrastructure around it!

It is shortsighted to insert an entertainment center like a CASINO COMPLEX on an area that is and will soon be further surrounded by more residential buildings. Commercial business to create a convenient supply of goods and services for thousands of residents ARE ESSENTIAL.

I pay very high Property taxes and my quality of life is getting lower and lower. Furthermore, my property value will be negatively impacted with a project like this one. My alley has needed urgent repair for many years.

The Mayor and the Aldermen need to be more responsible! Their priorities are not in the right order. We already have more than enough problems with crime, noise, motorcycles running after midnight, undesirable pedestrian traffic is becoming troublesome (i.e. Verilife site in Superior St).

I live in close proximity to the proposed site

Low quality development in an already troubled area.

Too much traffic!

The street of the west loop are already overcrowded. Halsted/Chicago to Randolph can take 30 minutes to drive our streets are constantly littered with excessive garbage that the city does nothing to clean up or stop already. There is no parking already.

I am not against city having casino. However, Bally's proposal is terrible. They did not consult with local residents even River North Association has raised concerns a while back. Their traffic estimation undermine the intelligence of local residents - it compared with another development proposal which we will never validate and indicates little on how much it might be worsen than current ones.

If this goes through, I will be forced to move and start over at the worst possible time for my age. I'm furious about this situation and strongly oppose the Bally's Casino Complex.

We are already seeing a drop in our property values while other downtown neighborhoods values are holding or increasing. I've been in the neighborhood since 2002 and am seeing an obvious decline to the point where I don't feel comfortable anymore walking around after 6 o'clock near my own home. A casino will only make matters worse. I'm from Southern New Jersey and have seen this happen in Atlantic City and, more recently, Philadelphia.

I am a new mother and we chose to live in this part of river north because it is calm, quiet, and residential. I would never have chosen to live in this area if a casino was anywhere near by given the traffic, crime, noise, safety concerns, and general badness it would bring to our area. Areas around casinos have historically seen a boost in short term gain but long term impact has been proven to be a large negative impact to residential areas.

I just moved here... I do NOT want my property value to go down

Ohio Street junction is already completely over leveraged. Those of us living in River North can rarely leave by car without planning to sit in substantial traffic. A destination resort requiring Ohio Street junction as its logical access point would bring the neighborhood to a halt.

One only needs look at Atlantic City to see what gambling does to an established urban setting (unless LVNV which was built to be a gambling destination from the ground up). River North & West Loop have had a slow long uphill climb. This project would make it all for nothing.

As a current homeowner across the river from the proposed site, I can see a fairly sizable decrease in property values in the surrounding areas. Personally, if I was a potential buyer, I would steer clear of units for sale in the general vicinity of a casino as that sense of "neighborhood & community" would be vastly reduced. What is now a rare quiet pocket of River North would no longer be feasible to maintain.

Our area across the river is especially valuable because it is removed from all the noise of river north. We currently have a very quiet building which is why I chose this location as a physician with busy work hours. I have very limited times to sleep and could never live in a building where I hear the noise of outside. When the windy city smoke out was at that location, noise carried dramatically to our building. That was tolerable because it was just a weekend. From my understanding, the other options for the casino location would not dramatically change existing quiet areas.

Cannot see any POSITIVE/BENEFICAL reasons to put a gambling casino at the old Trib bldg

This is a terrible idea. Violence will just be right around the corner where I live and ruining our district.

- 1. Crime will almost certainly increase.
- 2. The current infrastructure already cannot handle the current traffic situation. This will exacerbate the problem.
- 3. One of the best parts of this neighborhood is the neighborly feel of community, kids, and quiet. This will be greatly impacted by lights and loud noises.

I tend to get carried away if I have easy access to a casino. With Ballys right down the street, I could easily develop a gambling problem

Why increase more crime in this area. Casino goers are not the best type of people to represent coming into a residential district.

This is a densely populated residential neighborhood. A casino has no place in River North, period.

I am already frustrated with poor city services including lack of police presence in our neighborhood. We continue to send more and more of our tax dollars to be spent elsewhere while the minimal services we get continue to be substandard. Bally's will claim they will be a good neighbor, they will claim they will provide jobs (not to most of the residents in the area), and they will trot out garbage studies on the lack of crime around casinos. What they won't tell you is how the casino will push crime further into our neighborhood, how a 24/7 operation will negatively impact traffic, pollution, and quality of life for the rest of us.

This will increase crime and bring undesirable people into the neighborhood and cops already have their hands tied behind their backs because of our terrible mayor's policies. How will they be able to stop crime?

The detrimental impact on property brought on by noise, bright lights and expected general commotion from a casino in the expected location will undoubtedly outweigh any real or perceived benefits. Strongly oppose.

The part of River North on the river, just south of Chicago, is a quiet part of River North, and those of us who live here like it this way. I have high concerns of people who have been drinking at the casino wandering (or driving) over into the Ward Park area (and, frankly, loitering there at night). I have high concerns over the volume of an outdoor music venue - I have lived near one in the past and it was horrible. I have high concerns over bright lights. I have high concerns over this destroying property values.

This part of River North is a quiet, family-oriented place. It is where the best children's playground and dog park for miles is – and the idea of putting that so close to a casino is highly concerning.

I have lived in the neighborhood on Kingsbury Street and Oak for 15 years. The reason I choose this neighborhood was it is quiet and secluded. In the years of living here we have seen the neighborhood rise in popularity and real estate increase. I am in favor of adding new business, such as small restaurants or shops, where locals can support. The proposal to add a casino to this neighborhood actually frightens me due to the scale, and what that means in the amount of people, traffic and realistically potential crime. The Chicago/Halsted, Larrabee streets are already main through ways that carry a lot of traffic, adding too that will cause more stress to the area. The reality of more people means more people on the streets and foot traffic to a niche area where people feel comfortable walking and taking their children and dogs out. It will compromise what this neighborhood means for so many. We can't over look the disturbance, and how this would encourage crime I know one of the proposed sites is near McCormick which feels like an appropriate location, given it's near a large convention arena that would probably be a draw for more companies to hold their meetings. I worry about the affects this casino would create for the residents and business that surround this area.

Every area I've ever been to with a casino is not a nice area to live in. Stop this project before our neighborhood suffers! No way.

Locate casino near lake, convention center, or the old air field

There has already been an extreme uptick in crime in our neighborhood over the last 2 years, casino will increase this. Alderman said the "silent" majority would support, who is the silent majority? I don't know anyone in our neighborhood who is in support of this casino. Our property value has already dropped for the possibility of it happening. This is a kids neighborhood with park and public outside space.

This area of River North is appealing because of its quietness and friendly residential atmosphere. A casino isn't the right fit for the neighborhood.

I think it is a terrible idea that will bring noise, traffic and bright lights and it is not a good fit for this area/neighborhood of Chicago.

First keep in mind that this is already an extremely congested area for traffic flow in and out of the city at peak times. Any major complex here would only compound that problem.

There seems no benefit (other than the casino itself) in driving more traffic to this area as it does nothing to benefit Chicago as a destination. With other, less dense and more accessible areas closer to hotels and attractions (such as McCormick Place) the traffic flow would be less transient and thus less dense.

Second, the area around Chicago and Halsted is and should continue to be a growing residential area.

In having close, local access to the city, developing a safe residential area should be at the forefront for the cities future. There are few areas close to down-town and River North with so much positive potential for development. Development of this area in the correct way has the ability to bring new 'citizens' and income to the city.

A casino not only has the potential to 'kill' any residential growth in the area due to proximity, it may add to the already dismal crime rates in the area.

It would be good for the city to look to it's future growth rather than short-term gains. A badly placed (or indeed correctly placed) casino is not going to save the city. It only has the potential to hinder future positive growth and thus the future of the city itself.

The overall idea of a casino should be to bring in outside dollars into the city and not to tax the current residents either directly, by standard of life or property depreciation. If a casino has to happen it should be close to the area where the prospective out-of-town 'punters' will stay in order to cause minimal disruption. Chicago and Halsted is not that area.

I am a woman who lives alone, the possible and likely increase in crime could threaten my life. Additionally the disruption to daily life, as well as ability to commute could ruin the point of the park being a quiet haven within the city.

The corner at Halsted and Chicago is one of the most congested in the city. Both the Halsted and Chicago buses run so slowly at times, it would be faster to walk. Adding a casino complex to such a high density residential area that already has condos going up all over the place will make this area unlivable for the residents in West Loop, River North, and others. Surely there much be a better site in the city than this!

Im not opposed to a casino in Chicago. But I am 100% opposed to one in this location.

I am an owner and original resident of 700 N Larrabee St and have lived in the building since it opened in 2006/07. To say that I am appalled at the thought of a casino in my "backyard" would be an understatement. What I also find appalling are the lies and misinformation that the Bally's executives presented at the town half (which was nothing more than a sales pitch) to the residents of River West, River North, et al. on 4/6/22.

I wholeheartedly support progress and development of a neighborhood. The Hudson (750 N Hudson Ave) and its commercial space were valued added for the community. Current construction at 808 N Cleveland Ave, 751 N Hudson Ave, and 411 W Chicago Ave all of which will have residential and commercial space will add value for the community. The original planned (and approved) development for the Tribune sites (multiple residential/commercial high-rises and green spaces) would add value and safety for the community.

A casino would only add 1) unsustainable vehicular traffic, 2) unwanted pedestrian traffic, 3) drastically increased noise levels (for a relatively quiet neighborhood), and 4) unimaginable new levels of crime (in a city already experiencing a surge of atrocities).

I've lived in high-rises since 1997 (various properties in Chicago since 2001). I understand "downtown" neighborhoods changing to meet future needs of a city. A casino in River West (border of River North) would singlehandedly destroy the safety, property values, and quality of life that we have strived for and taken pride in as residents of these communities.

The Bally's casino project in River West/River North should not,Äîmust not,Äîbe approved.

The area is a neighborhood and this would greatly impact it with traffic, and crime. The area is already being impacted by increasing crime. This project would change the entire area and create issues for residents. A casino doesn't not belong in neighborhoods.

A major portion of my life's earnings is in the condo at 700 N Larrabee. I am retired. I have earned all I will ever earn. It would be a major hit to my retirement security for the property value of my condo to diminish. River North is a well established residential area with young family's playing in the park. People walking their dogs. Going to and from work and play. We are not a tourist destination, nor do we want to be. The Tribune property will become a compatible residential/commercial development within a few years. Please don't put the blight of a casino so close to family residences. I don't think I'm the only one who would have to consider leaving if this project goes forward.

Putting a casino in the middle of (or directly adjacent to) a residential area is a terrible idea. Putting a casino on this site would be highly disruptive to our family-oriented community. The casino would bring light pollution/light pouring into our windows at night (we face the lot), noise, traffic, and the high potential for increased crime and other safety concerns.

River north is already congested and has been experiencing an increase violent crimes

The riviera front should be preserved for development that complements the current landscape of the area. A casino will tax an already strained infrastructure of roads, buildings, and commercial venues. The lighting will be obnoxious in an otherwise residential neighborhood. Traffic is already overwhelming; a casino will take this to a whole new level.

A casino is not a the right business for River North.

This casino would significantly worsen safety of what used to be one of the more safe areas of the city. The other proposals would have much less of an impact on neighborhoods in terms of the proximity of condo buildings nearby. River north is already recently struggling with increased crime and this casino would simply amplify that problem. The city of Chicago is going to end up losing a lot of residents because of decisions like these.

Traffic, reduced property values and crime are my biggest concerns. Presently, cars break numerous traffic laws including NEVER respecting pedestrians when they have the right of way versus the cars. A casino at this location will only worsen this problem with increased car and pedestrian traffic. There is little to no police presence in the River North community and increased crime with the addition of a casino would only make an already bad situation much worse. Our community is already overbuilt and too dense to add this casino project. Ballys, you are not welcome at the River North location!

I just bought a condo in the area. I will sell it if a casino get put up and I'll move across the Indiana border.

Virtually no one in this largely residential neighborhood wants more noise, more light pollution, more traffic and what would likely be more crime. When I first heard that this was a proposed casino site, it was such a bad idea that I thought it was a joke. To my horror, I found out that this was something serious people were considering seriously. Chicago is one of the greatest cities in the world but when we do things like this, we look like a laughing stock. Imagine taking a prime piece of residential space in Manhattan and turning it into a casino. That would NEVER happen. Further, the property values will certainly plummet. If this is approved, this will be the easiest decision to move I've ever had in my life.

Our home values in River North plunged in the 2nd quarter of 2020 with the combined punches of the pandemic and the city-wide looting. They have not recovered because we do not show a regular police presence and many home owners are terrified of the smash-n-grab-free-for-all-carjacking culture that has taken hold. Michigan Ave is still struggling and there is not demand for our condos in River North or Gold Coast (other than the occasional high profile sale). Don't let increasing rents fool you - ownership in these markets has not recovered and cannot take ANOTHER hit of traffic, crime, noise, prowlers, after hours joints, etc. that will come along with a casino. Get us back on solid footing and a feeling of safety before you introduce a huge business that comes with lots of undesirable side effects (fact, not my opinion). The old printing site on Halsted? How about a nice, clean semi-conductor factory like Columbus Ohio landed instead of a casino?

The western section of River North is a highly residential area – there are families and kids living there. The immediate west bank of the river is, essentially, therefore, across the street from a residential area. The light pollution from a casino will likely be bad, as will the increased traffic (whether vehicular or pedestrian). If the casino does not expect significantly increased pedestrian traffic, why does the plan show a new bridge over the river from Montgomery Park for pedestrians? The answer is that the casino expects significant pedestrian traffic through River North and through what is a very nice (but small) park. I guarantee the river and the park will also be subject to littering, noise, etc. as people come and go through the park and over the bridge.

This is a quiet neighborhood. A casino would negatively impact the residents quality of life

I refrained from forming my opinion on this issue until I was able to review research, all of which seems to conclusively show that a casino located at the Tribune site would undoubtedly cause problems for our neighborhood and the city. I'm in support of a casino (and the revenue for the city, in particular) in one of the other two locations, both of which are further from downtown and densely populated, residential urban environments, Äîenvironments where projects like this often fail.

This isn't Las Vegas! We don't want a casino in our family and pet friendly neighborhood. Find somewhere else to locate your terrible idea for this city!

If the city wants a casino, the other proposed locations are seemingly more aligned with the need for vitalization in that regard and have the infrastructure to support large scale businesses of a casino variety. The traffic patterns don't support current car flow alone. The casino business is not fitting with current, calm state of the neighborhood

Adjacent to the largely residential neighborhood of River North, will cause increased noise (particularly at night), potential crime, unsavory behavior, etc. We enjoy walking the neighborhood and this will undoubtedly bring unwanted traffic. As well, property values have remained where they are in part to limiting retail and big entertainment properties.

This is a very quiet residential neighborhood with a children's playground directly across the river from the proposed site. A casino is a terrible fit for the neighborhood.

the existing tribune plant is an eyesore and the apparent inability to develop this site is preventing meaningful improvements of infrastructure in the area, such as the chicago ave bridge. several recent projects have fallen through and it's unclear when another serious developer will come along to improve the site. with all acquisitions, planning, permitting, etc., we're looking at another decade of no changes. perhaps a casino is not the worst option?

i'm still opposed to the idea for personal reasons, but i'm also seeing the potential benefits to the area in the short-term. once the casino loses steam in the late 2030s, another developer will swoop in to make something happen. perhaps we need to create a condo pros/cons list?

any residential development on that site will have its own set of drawbacks. it may be nice to have a more commercial zone on that side of the river rather than more residential high rises.

Police aren't able to patrol our existing area, car jacking and gunshots are regular occurrences - it's only going to get worse

Inappropriate for primarily residential neighborhood; city/district police and police resources are already significantly strained and such strain would only increase upon development and operation of a casino in the neighborhood (e.g., negative and disparate impact on neighborhood crime prevention and protection of residents); would render the River north neighborhood no longer family friendly or a residential neighborhood as a result of promotion, presence and function of casino (i.e., gambling, alcohol and associated vices) and the element said casino establishment attracts; the property/land could be used in several other ways that better serve the River North neighborhood and city community such as development of a school (public/private), library (public/private), shopping/retail (e.g., the New City development in Lincoln Park), condominium complex; safety of the River North area, preservation of the neighborhood and safety/well being of River North residents should be the City's and City Committees' number 1 priority and concern, and development of a casino to replace the Chicago Tribune's former and long-standing presence is completely antithetical to said priority; there is no question that development and operation of a casino will significantly devalue the River North area (especially considering how such property and social/inhabitable value has already been drastically negatively impacted due to businesses and restaurants being forced to close as a result of the Covid-19 pandemic and City's/government's response thereto). As a 31-year-old Chicago-native (born and raised in Lincoln Park and River North), I would be incredibly disappointed to see the integrity of River North compromised, if not destroyed, by the City allowing a casino to be developed in one of Chicago's most beautiful and valuable neighborhoods.

It will bring additional and unnecessary added activity that will likely be negative in the community.

I attended the community meeting. I felt that the Bally team did a poor job of answering direct questions from citizens. The city rep was also unconvincing when he makes the claim that the city is moving forward despite the huge loss of residents. This is a money play that preys on people's worst impulses. River North is a residential neighborhood that doesn't need the issues that come with a casino.

River North is a neighborhood where all types of people and families live, work and raise their children. A casino is not conducive to maintaining a family neighborhood. The intersection of Halsted and Chicago is busy enough. There is no way both the vehicluar and pedestrian traffic generated by a casino would not be extremely distruptive to this family neighborhood. An erosion of housing valves with surely follow as no one would choose to live next door to a casino. Crime will surely follow along with home owner flight. Chicago already has a serious problem with tax payers leaving the city to get away from crime, traffic, etc. The residents of River North within a 2 mile radius will begin exiting not only the neighborhood but, the city of Chicago. Michigan Avenue is already seeing the exodus of both homeowners and shoppers. Also, I do not think a casino compliments the goal of the urban planners to revitalize of the Cabrini Green area. If the Tribune site is the final choice of the city power brokers I can assure you I will sell my condo and exit the city before the casino is completed. Don't ruin a neighborhood and continue the decline of the city just to meet pension shortfalls and line the pockets of power brokers. Enough is enough. Do the right thing for once.

The area immediately to the East is residential. A casino operating 24/7 would strain the roadways, increase potential for crime, create unwanted light pollution and diminish the value of all adjacent properties. The Chicago Avenue bridge is already a traffic and safety nightmare.

I don't want the crowd casinos attract

A casino should not be placed in the center of a residential area when there are other places to consider.

This is a residential area, not an entertainment district. There are so many issues placing a casino right next to people's homes! The noise will affect the nearby residential buildings that are directly across the river. The traffic will be a nightmare...the traffic today is already awful. Potential disruption from intoxicated patrons leaving the casino or concert venue. River North/River West is NOT the right area for a casino.

RN is a family friendly neighborhood which is already being driven out. A casino adds no value to the neighborhood or the city.

The area is very residential and it will have a negative impact on the neighborhood, residents, and business owners in the area.

Casino will create a bad image for Chicago where culture and art dominate. Generally, casinos should not be located in or near residential areas! They bring only chaos, loudness, traffics, and lower quality of life for people!

Casino is incompatible with the family oriented nature of River North. River North is a quiet and safe enclave of the city. Any casino project will change the nature of the neighborhood for all the reasons cited in the previous page of questions.

River North, and the proposed Bally's Casino Complex at Chicago Avenue & Halsted Street, is not a location that requires significant economic development. The intersection at Chicago Avenue & Halsted Street is already notoriously terrible (making a left-hand turn from Halsted onto Chicago is nearly impossible), and adding this development will only exacerbate that. Similarly, River North has experienced a spike in crime over the past 18 months which will only be exacerbated by the presence of this casino development. River North does not require additional vehicular or pedestrian traffic for the purposes of economic development, and the casino should be placed in a location that would benefit from the robust economic advantages that it would bring (i.e., a currently underdeveloped / underutilized site). River North is predominately a residential neighborhood and a massive casino development would fundamentally change the character of that. Additionally, placing a casino on the banks of the Chicago River will contribute to the pollution of that waterway, and destroy the tranquility and peacefulness of the northern branch river walk. The casino should not be placed at this site, and another, more suitable location, should be found.

It is intuitive that thousands more cars and people will be come into the area if a casino is built. That is logical and mathematically indisputable. Bally's and some aldermen say the casino-related incoming vehicular traffic will be less than other development already authorized for the area. So? I'd be equally opposed to any major influx of traffic.

Bally's will have more open space than the previously-authorized development for the area. So? ## **RE: Casino Proposal / Freedom Center Site**

Dear Alderman Burnett, Alderman Reilly, and Alderman Hopkins:

River North Residents Association (RNRA) was surprised to learn of the Bally's casino proposal for the Freedom Center site from news reporting. Given the site's direct proximity to the western portion of the River North neighborhood, we are providing our organization's early feedback regarding this location for the proposed development of a casino. We have concerns about the appropriateness of potentially siting a casino and high-rise hotel development at the Freedom Center location.

As you know, RNRA has been a responsible and thoughtful partner in providing feedback related to the continuing development of the River North area. To date, as an organization, we have been supportive of new development projects that are compatible with the neighborhood. However, we have concerns regarding the Freedom Center site as a location for the casino development project given its direct proximity across the Chicago River from the long-established residential neighborhood to the east.

Our concerns include, but are not limited to, the impact on the adjacent residential community and nearby businesses, of a 24/7, destination-oriented, gambling, entertainment, and hotel complex.

 River North is a high-density community. For example, 2020 data for just one River North census tract (adjacent to the Freedom Center site) – 17031081800 – reveals a population of 11,373 and total housing units of 8,096. Density continues to increase with multiple high-rise, mixed-use developments approved or under construction in close proximity to the Freedom Center site, including the following projects for a combined increase, to date, of over 5,700 residential units, 75,000 s.f. of commercial space, and other mixed-use development.

- The recently approved Halsted Pointe project, located near the intersection of Chicago and Halsted, will include multiple high-rise mixed-use towers, ranging in height from 30- to 46-stories, comprising over 2,600 residential units, and a 300room hotel tower, among other uses on this site.
- The 808 N. Cleveland mixed-use residential development at the corner of Cleveland and Chicago is under construction and will add 200 new residential units and 27,000 s.f. of commercial space.
- The HUGO development at 411 W. Chicago and 751 N. Hudson will be breaking ground shortly. This combined mixed-use residential development will include 227 residential units and over 18,000 s.f. of commercial space.
- The recently approved zoning changes allowing for the redevelopment of several Moody Bible Institute sites between Chicago and North Avenues along Wells Street to accommodate over 2,600 residential units and 30,000 s.f. of commercial space.
- Thousands of residential units in the neighborhood will experience additional noise impacts from increased tourist-oriented river traffic combined with casino visitors traversing the riverfront promenade, and any outdoor activities.
- Traffic congestion is already a challenge for the River North community, particularly in the western portion. Illinois Department of Transportation data show the average annual daily traffic volumes for the major streets adjacent and near to the Freedom Center site:
  - Chicago Avenue (from the Chicago River to Halsted) 24,600
  - Chicago Avenue (from Halsted to Peoria) 21,700
  - Halsted Street (north of Chicago) 15,700
  - Halsted Street (south of Chicago) 15,000
  - Grand Avenue (Orleans to Des Plaines) 17,100
  - Grand Avenue (Des Plaines to Halsted) 19,200
  - Ohio feeder ramp (east direction) 91,200

Traffic congestion on these roadways will be further exacerbated by the impacts from the many high-density residential and mixed-use developments approved or under construction in the vicinity of Chicago Avenue and Halsted Street. Additionally, the scheduled permanent replacement of the Chicago Avenue bridge will disrupt traffic for many months during construction.

- The location of a large-scale, entertainment complex in an already high-density area will make it more challenging from a public safety standpoint for the adjacent neighborhoods. Chicago Police Department 18<sup>th</sup> District crime data show existing challenges, which may be further exacerbated by a major 24/7 entertainment complex located nearby.
- Negative impacts on home values for residential properties immediately adjacent to the
  casino site is a likely outcome due to increased noise, traffic, lighting and other impacts
  resulting from a large-scale casino complex. Studies such as the National Realtor's
  Association 2013 "Economic Impacts of Casinos on Home Prices Literature Survey and
  Issue Analysis" (<a href="http://www.scribd.com/doc/151429358/NAR-casino-research">http://www.scribd.com/doc/151429358/NAR-casino-research</a>) have
  explored this impact in other locations.
- Casino-oriented crowds traversing the proposed pedestrian bridge connection across the river is likely to adversely impact to Ward Park and its heavily used playlot.
- Neon and other lighting will directly face hundreds of residential units fronting the Chicago River across from the casino site.
- A large-scale casino development at this site is likely to have a negative impact on local businesses.

While RNRA is supportive of public-oriented riverfront improvements, and compatible development of the Freedom Center site, a destination-oriented, 24/7, large-scale casino development presents a host of land use and quality of life challenges for the residential neighborhoods in River North and beyond. The area adjacent to the proposed development is home to thousands of residents and is a stable and family-oriented neighborhood.

As the City reviews the various casino proposals, on behalf of our 22,000 members, we ask that our earnest concerns be taken into consideration and that a more suitable alternate site be pursued for this large-scale, destination-oriented use.

Good morning,

I would like to continue to state my opposition to the Chicago casino on the Tribune Publishing Site (Bally's), following this week's casino community meetings. I do not believe it is wise to build a development of this type adjacent to two major bus routes, CTA 8 (Halsted) and CTA 66 (Chicago). The city historically has had issues with traveling east-west due to its lack of rail lines that travel east-west. Building a casino here would do just that to the CTA 66 bus that brings in residents living out west to and from the downtown area, where access to the CTA blue, brown, and red lines can be found along this route. In addition, the CTA 8 bus also serves as an additional lifeline for connecting the north and south sides together. It is slightly west of the train lines that feed into the loop and allows additional access to parts of the city that are not easy to get to without a personal vehicle.

I know a preliminary traffic report has been produced for the site. I heard the developer at that meeting say regarding traffic, "should result in less traffic in the weekday morning, similar traffic levels in the weekday evenings, and additional traffic during weekend evenings." Traffic in the morning when more people than ever are commuting from home doesn't make a big impact. The statement saying similar traffic levels in the weekday evening means "traffic in the PM is already bad, this casino will make traffic conditions worse, bust because traffic conditions are already bad then our impact doesn't have as large as an impact." Also, weekend evening traffic would make this area worse and congested, on a regular basis. Wait until concerts and events are hosted on the weekend and weekday evenings. It's a chokepoint connecting a heavily populated northside and westside to the southside and downtown.

I don't buy this traffic report at face value. If there is going to be parking provided on-site or nearby, then it is an absolute guarantee that traffic will be added to these roadways making traffic that much worse. More parking available more people will drive. What if this report isn't 100% accurate on the traffic effects and that it underestimated the impact? It's not worth the risk to take the study of a developer who has everything to gain if it paints their development in a favorable light. Not fair to the people nearby and not fair to the people who commute through this area. I'm fine with high-density residential development on this site but not a giant traffic generator like a casino. Since the developers decided to bring it up in the meeting, we should be able to see the traffic report and their assumptions. I would like to request a copy of this traffic report.

This site should be removed from consideration. Just looking at a map of the sites around Chicago it just seems out of place to be so far away from the Loop and the economic hub of Chicago. As I stated previously, I would rather see it go in the 78 plot of land. It can be serviced by a non-roadway-dependent form of public transit, the CTA Red Line, and it is close to the Loop which is serviced by all CTA rail lines. Another positive with this site or the Hard Rock development is that it is located in a less-trafficked area that is more accommodating and adaptable to an influx of traffic, as well as it is

Hello Alderman,

I recently saw you at the HW Library introduced as a key committee leader on the development of the Casino (etc) under discussion.

Gone are the days of local architectural firms submitting RFP to the City for re-developing smaller sections of space in existing loop structures. I recall attending an event at the Chicago Theatre under Mayor Emmanuel's tenure with this specific topic discussed years ago.

Today's planning is extremely large in comparison which implies risks to say least. The city's pension problems are clearly reflected. This said, please understand that the Hard Rock Plan has environmental consequences which were not addressed satisfactorily at the public meeting and many locals are extremely concerned for wild life, plants, green spaces, healthier water ways.

Under Rahm's planning RFP guidelines, casino proposals involved an expansion of our urban community with families, children being emphasized with lots of open spaces as the grand plan, per plans presented by architectural firms. The casino planning under Rahm was more or less a "test case" recreation concept not this force of domination which today's business models reflect... regardless of the bells, whistles and tinsel.

We need more discussion of the specific crimes associated with gaming at this level specifically to residents vs. the annual revenues generated.

Where are plans to provide supports like such as Gambler's Anonymous services or social services specific to the dark sides of this business model?

Great to see & hear all the highlights, but environment and social concerns for vulnerable are critically important to confront in front of the unleashing of this new force.

Your expertise/education is in food services with impressive credentials say least, but as important are social services and unbiased environmental studies in lock step with the project.

(One solution i think about fairly often is with regard to the mass exodus of chicago's population to warmer climate states which essentially enjoys the pension and retirement money of our former Chicago citizens, why not create a plan for the Florida's or Texas, for instance, to pony up some of that money spent in southern states back up north to our pension coffers since this is the money flow (naturally). The creativity and intellectual capacity of our best minds available are able to critically think of policies and potential idea's to re-direct some funds up north to help stabilize the outflow of our population drain. Human's nature aside.

I return to Mayor Rahm's answer to the casino probe years ago.... smaller solution initially on the site of an underutilized local asset ... possibly a test case without a tremendous impact to residents, nature, environment, etc.

I have attached an info sheet and would be glad to help provide further information you may desire. If you would be willing, I would like to meet with you regarding this topic.

I'm volunteering with Stop Predatory Gambling Illinois (<a href="www.stoppredatory.gamblingillinois.org">www.stoppredatory.gamblingillinois.org</a>) and I am a Chicago resident. I am deeply concerned about the impact of a casino, especially for locations (like the 78) near residential communities experiencing poverty. New casinos increase problem gambling, and problem gambling leads to more debt, divorce, depression, illegal activity to sustain addiction, and suicide.

Hello Alderman Tunney,

I am currently living downtown, but I lived in our ward from 2012 through 2020, and I admire all that you've done for the Lakeview neighborhood. I much appreciated your advocacy and support of livability in the Wrigleyville area. You've fought for noise protections, rationalized traffic flows, safety, and for the protection of a family friendly atmosphere. For that reason, I welcome your leadership in the task force that is considering the future site of the Chicago casino. I'm comforted by our prior advocacy, but also troubled by the overall city effort to push the casino without adequate protections for the neighborhood.

The casino affects my current neighborhood on the near north side. I live on the east side of the river, directly adjacent the proposed site of the Bally's casino. My current alderman, Brendan Reilly, has not taken a strong stand against the casino, and I am communicating with him as well. I am also contacting you, reminding you of the good work you've done in Lakeview, and calling on some of the same consideration for other city neighborhoods.

To be clear, I do not support the casino at all – not here, not anywhere, but I do reluctantly accept the decision of city. I would ask for the same protections for city residents and neighborhoods for any of the remaining sites. Certainly my own neighborhood seems to have the most to lose. The other proposed sites have less nearby housing, and they are already more effected by the business of tourism. Despite our proximity to River North, the north branch of the river has some calm streets and a neighborhood feel which is at risk.

The Bally's proposal for an outdoor music venue, along with all the other crowds and traffic, is enough to jeopardize our peace and quiet. We have existing concerns about pedestrian safety, congestion, noise, and lawlessness from vehicles of all shapes and sizes. We have an industrial / post-industrial vibe in the neighborhood which would be transformed by a glitzy casino site. We have an opportunity for future river front development to bring a sense of nature to the neighborhood, and the proposal stands in contrast to that. Dear Council Member,

It is estimated that one billion birds die every year from flying into buildings. You read that right – **one billion annually.** However, a recent study found that many of these deaths could be avoided by turning off the bright lights in buildings, which lure birds in and possibly to their demise. Despite this promising news, a proposed casino in Chicago poses massive threats to migratory bird species. **In fact, the casino might even be built on the very location where this bird life-or-death study was conducted.** 



# We demand to protect birds by not allowing this casino to be built at McCormick Place Lakefront Center!

Although Chicago is a common migratory bird destination, the city has a complicated relationship with bird migration, and some of its buildings are well known to be bird killers. McCormick Place – where the casino might be built – is one of the deadliest buildings for birds in the entire country.

Each spring, hundreds of birds migrate from the south to the north, stopping in the Windy City along the way. Up to 200 of those birds die every single night by crashing into McCormick Place's windows, which are brightly lit, attracting many birds to them. That's the equivalent of **72,000 dead birds** per year from one building alone. **If Commissioner Cox allows a bright** 

casino at the McCormick Place Lakefront Center, it would create an even worse bloodbath on the lakefront. It's important to note that casinos leave their blaring lights on even later than regular buildings, meaning more deaths to our beloved migratory birds.

Why would local officials knowingly put a casino in a spot that will be so devastating to wildlife? There are other options with locations that would be less detrimental to birds! Conservation advocates have been documenting the harm done by McCormick Place for decades -- there is no excuse for these officials not to act accordingly.

The McCormick Place Lakefront Center is already responsible for the deaths of thousands of birds each year. If the facility becomes bigger, brighter, and open later, we know that more and more migratory birds will die.

We are urging the Council and the Commissioner of the Chicago Department of Planning and Development, to reject the proposal to put a casino in this location. If Chicago cares about the health and safety of birds, it must show it now!
