Land Acknowledgement - Mali	Land acknowledgement was provided.
2. Call to order - Mali	Done by Mali
3. Open Action Items - Updates from all that are assigned	Action Item Log was reviewed and updated.
4. Membership Update	90 neighbours have renewed their membership.
	 Another membership drive will start again Thu May 9th – 25th. Captains are meeting at Leah's house – will do "knock-on" canvassing and flyer drop-offs. Some captains will send an eblast with a flyer drop-off.
5. Treasurer's Report	 Martin sent the Profit and Loss and Treasurer Reports for April'24. Key points \$2,972 in expenses including those related to the Pocket Change committee of \$1,652. \$19,000 has been received from the TDSB on behalf of the Pow Wow event to be held at the end of May. It will be fully drawn down by then for this event. Membership subscriptions are down. 2023 - \$3,600 vs. 2024 year to date of \$960. Please reference the efforts of the membership drives to bring this back up. There may be a need to draw down on part of the term deposit if memberships do not increase.
6. Feedback from Julia Morgan (Pocket Change)	 Grant Money – Bank account: Julia informed we cannot hold the Pocket Change grant money as there is a condition with the City directing the grant money be managed by an organization they have contracted as their trustee to handle this for all grantees, which is The Neighbourhood Organization (TNO). Annual Budgeting: September is early for the Pocket Change Committee since they will still be in the thick of 2024 activity in September, and they plan to have their elections for the next committee team in the fall
