Hey – good talking to you. Just got feedback from GSB in a meeting with most of the others receiving this.

Understanding that there's a PRO and a security element to this, could you please add the "mitigating measures" language we discussed (or a reasonable facsimile thereof) to capture steps we're taking both to address the potential conduct measures, but also the things we're doing to protect those members identified in the leaked material (e.g. removing them from operational roles without divulging operational info).

Once bolstered, the lines will be reviewed by PRO at HQ, GSB at leikin and most of those on this chain.

FYI Nelly is also tasked with taking approved language and crafting social media content to mitigate any further spreading of this in other media. FYI.

Our media response to any further questions should be held, pending new language.

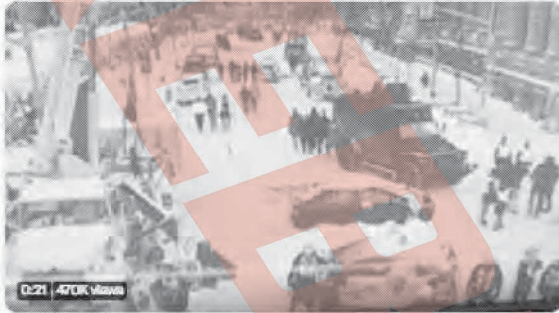
