The Ontario Special Investigations Unit (SIU) is investigating the incidents between a Toronto Police Service officer on a horse and a 49-year-old woman who was on Rideau Street and Mackenzie Avenue in Ottawa February 18, 2022 https://www.siu.on.ca/en/news_template.php?nrid=7495. As you probably know, the SIU is a civilian law enforcement agency that has jurisdiction over municipal, regional and provincial police officers. The SIU Director may cause a criminal investigation to be conducted into any incident in which a person is seriously injured. Since the matter involves a different police department and is under investigation, we cannot comment.

However, can confirm that we are aware of the material circulating on social media pertaining to a chat group that includes some of our members, and we can confirm that we are looking into the matter. This material is not representative of the vast majority who have committed themselves to serving Canadians with integrity and professionalism. Public trust is essential for the RCMP to effectively fulfill its mandate. As a result, RCMP employees are expected to conduct themselves in a manner that meets the rightfully high expectations of Canadians. Both on and off-duty, members are required to behave in accordance with the Code of Conduct of the Royal Canadian Mounted Police. Contraventions of the Code of Conduct are taken seriously and the RCMP is committed to handling conduct issues in a timely, efficient and fair manner.

The last few weeks the RCMP has taken part in operations to end illegal blockades and unlawful protests safely and peacefully. You have worked long and difficult hours and I want to thank each and every one of you for your continued support, commitment and professionalism.

At the end of a long day, we all deserve downtime with colleagues, family and friends. That said, we live in an era of 24-hour news cycles, social media and instant messaging, and the interactions we have with one another - and the public we serve - shape the public's perception of our organization and its members. I am asking that you be aware of your presence both in person and online and always consider the potential harm of social media on the reputation of the RCMP.

The taking and sharing of photographs, especially while on duty, could undermine operations and risk officer safety. Social media and text messaging applications are vulnerable, so private text messages and light-hearted photos shared between friends may get leaked and become the story of the event. Moreover, there is growing concern about the spread of disinformation, as photos and videos of our members are being circulated, out of context, to misrepresent the members of the RCMP as bad actors who seek to harm members of the public or who are aligned to a particular ideology.

Please remember that the eyes of the world (literally) are on us and on our country. Maintain self-awareness both professionally and personally, and continue to represent us in the extraordinary manner that has come to symbolize the police response to these events.

Update from 2010 hrs, 2022-02-19

- OPS published a message on social media asking that people only use 911 for emergencies and advising that for those deliberately attempting to flood the phone lines, they can and will track the numbers.
- OPS held a media update yesterday afternoon providing an update on the protests.
- Since mid-afternoon, protesters have moved from various spots in the downtown core and are now mainly confined to Bank Street, between Sparks and Queen. Some protesters are partying on the street. Another reporter points out that the crowd is mostly festive and not hostile.
- Wellington Street is almost empty. Some live TV reporters are saying that police are asking them to leave as it's a secured zone.
- OPS have said that all vehicles on Sir John A. Macdonald Parkway have left or have been towed.
- This morning, 87 vehicles were on Kent St. At this point, all trucks south of Queen Street have left.
- On Coventry Road, more transport trucks are leaving.
- Convoy protests leaders Pat King and Tamra Lich will remain in custody as their bail hearing was moved to Tuesday.
- Across the country, demonstrations against public health measures have again forced RCMP to block access to the U.S. border crossing in Surrey.

Update from 2202 hrs, 2022-02-19

- From investigative journalist, [REDACTED] : "A source in the emergency response team told me that Ottawa Police planned, then cancelled, at least one operation after discovering details may have been leaked to the occupiers. He adds: For about a week, I've been chasing a lead: that someone was sharing internal police communications with folks involved in the occupation. But: Far-right influencer Jeremy MacKenzie just posted a bunch of screenshots of an RCMP group chat."
- RCMP HQ Media Relations received information and a request from [REDACTED] to comment about these posted screenshots. After consulting with OPS and RCMP National Division Communications, they will be responding with "no comment" messaging.
- On Bank Street, the police have retreated strategically behind large fences, which block access to parliament. It's being reported that the mood is tense and that police have made a few arrests.
- The Ottawa Police say that protesters were assaulting officers with weapons warranting the deployment of mid range impact weapons (ARWEN) to stop the violent actions of the protesters. In another dispatch, the police are asking people to stop calling critical emergency and operational phone lines to express displeasure about the police action to remove an unlawful assembly downtown.
- Several Freedom Convoy protesters have told The Washington Post that they planned to regroup or join future anti-government demonstrations.
- After turning himself into police and being taken into custody yesterday, convoy leader Daniel Bulford was back downtown today. [REDACTED] no charges were laid.
- Today the RCMP national accounts posted about recent seizures of financial assets under the Emergencies Act. This will help to generate additional interest on the matter ahead of tomorrow afternoon's press conference.

- There were no further media requests yesterday for Nat Div.

Update at 0830 hrs, today

- OPS posted [a message](#) on social media reminding the public that police will be actively looking to identify protesters and follow up with financial sanctions and criminal charges.
- Protesters remain primarily on [Bank Street](#), where fences have been put up to prevent protesters from going to Parliament.
- The [Associated Press](#) points out that hundreds of police in riot gear swept through Canada's capital Saturday, retaking control of the streets around the Parliament buildings and appearing to end the siege of Ottawa after three weeks of protests.
- Lawyer [Paul Champ](#) says that he's "very impressed by the professionalism of the police. Coordinated and disciplined, almost no injuries."
