

# Soaring Higher: Hawk Cliff Woods & Beyond Campaign Update



Soaring Higher - The Hawk Cliff and Beyond Campaign is nearing completion. For many members of the Board, undertaking this campaign last year was a leap in fund raising faith. A \$1.6 million campaign was the biggest development campaign the Trust had ever done. We knew that the purchase of Hawk Cliff Woods was a wonderful opportunity. What we also knew was that we also had other needs to address and that it was the perfect time to blend our needs into a major ask.

For several years, the Trust has been waging annual campaigns. We did Wardsville Woods in 2013, then the Bebensee acquisition, and the Lusty Campaign in 2014. Within all these campaigns, we were acutely aware that there were demands on some of our established funds namely our Opportunities Fund and our Jane Bowles Limited Endowment Fund.

In 2007, Dick and Beryl Ivey established the Opportunities Fund in the amount of one million dollars. We were asked to use the fund to purchase conservation lands in a timely way. We were required to repay the fund for half of the value of the purchased property. In other words, if we purchased a \$200,000 property – we would return \$100,000 to our Opportunities Fund from our fund raising efforts. Despite our stellar fund raising efforts – our Opportunities Fund was depleted to half of its value in 2015 but we did have 14 properties. To restore it to it's original strength, we needed to add \$400,000 to the fund raising pot. We were unbelievably surprised and elated when Richard Ivey came forward and agreed to fund the whole amount.

We also decided to pursue enhancing the Jane Bowles Limited Endowment Fund. In 2013, through a substantial legacy gift by Jane Bowles and André Lachance, we were able to fund a newly created position of Property Manager at the Trust. It is our desire to keep funding this position for the 14 properties on our roster but in order to do so we needed to keep the fund balance in the account healthy. As of March 2016, we have made our goal of \$100,000.

The current balance on the Hawk Cliff and Beyond Campaign is at 88% of goal. This is truly amazing and awe inspiring. We need to raise another \$200,000 to get us to our final goal. Right now, we are approaching our friends, granting agencies and our corporate and foundation supporters to get us over the top.

#### What's With all The Rules?

What's with all the rules? In this article, Thames Talbot Land Trust explains why certain regulations are in place on conservation properties and the impacts associated with unpermitted activities.

#### Why are some properties closed?

TTLT has properties that are either open or closed for public access. When a TTLT property is closed, this usually means that there is sensitive habitat that would be impacted by human traffic. A closed property could also be at the request of the property donor or it could mean the property is not maintained for public access and therefore, it is not safe to hike.

#### Staying on the Trail

The trails on TTLT properties are the safest place for you to walk. Staying on the trail ensures that sensitive habitat is not disturbed and that hazards are minimized. Besides, we have put a lot of work into designing trail systems that showcase the most beautiful parts of our properties! Why would you want to walk anywhere else?



## **Motorized Vehicles, Bicycles and Horses**

The use of motorized vehicles, such as ATVs, horse-riding as well as mountain biking are considered high impact activities in natural areas by many studies. Impacts from these activities are most commonly soil compaction and erosion, loss of organic litter and ground cover vegetation, species loss, erosion and widening of trails as well as invasive species into natural vegetation. TTLT does not permit these activities for the safety of the natural environment and for your own personal safety! TTLT properties are not maintained for motorized vehicle and biking safety. A hazard that may be obvious to someone walking slowly along a trail may be less obvious if that person is moving faster on a bicycle or ATV.

#### **Keeping Dogs on Leash**

TTLT encourages you to bring along your furry friend to enjoy a nice trail walk but please keep them on their leash. This rule is in place for the safety of your pet, the forest and wildlife – the woods contain many hazards, potentially poisonous plants and not-so-friendly wildlife that may pose a threat to your dog. Dogs also love to explore. They may be unaware that they are entering sensitive habitat, that they should not try to play with the wildlife, and that they may be spreading invasive species seeds throughout the forest on their fur and paws. So, for the safety of the habitat and your pet, please keep your dogs on the trail with you.

#### Hunting

TTLT does not allow unregulated hunting because many of our properties are open to the public and it is a safety issue to hunt where the public may be hiking. TTLT may use hunting for management purposes as needed, however, general hunting is not permitted for public safety reasons.



Five Points Forest was donated to the Thames Talbot Land Trust in 2009 by Al and Lilianne Driedger, who wanted to protect the natural features of the land in perpetuity. The 29-hectare (73 -acre) property lies on a gently rolling moraine just south of the south branch of the Thames River between Putnam and Ingersoll, adjacent to other woodland patches.

Five Points Forest consists of mixed coniferous-deciduous upland forest and forest swamp. White Cedar is prevalent in the wetter areas. Upland areas contain mature White Ash, Red Oak, Sugar Maple, American Beech, Bitternut Hickory and Black Walnut. This area of Five Points Forest was never cleared, and its vegetation cover is well documented in Ontario Heritage Trust (OHT) and Upper Thames River Conservation Authority (UTRCA) reports. The wetland contains several rare orchids and there is a good understory of native plants on the property.

## **Five Points Forest Adopt A Patch Program**

This program aims to engage stewards of the property in ecological restoration by removing invasive species from their "patch" annually to protect surrounding habitat. This will lead to planting of the cleared areas with native species once the invasive ones have been kicked out! Individuals or groups of people, nature clubs, schools and other organizations can adopt one or more 10m x 10m patches within the forest. A training session fore those interested in participating in the program will be held at Five Points Forest on April 23rd, 2016 from 10:00 a.m. to 12:00 p.m. For more information, or to RSVP for the session please visit the TTLT website at www.ttlt.ca
