CANDIDATE ELIGIBILITY [VI (A)(III)]

 To be eligible for the position of President of the UBCIC, a person must be a member of one of the Indigenous Nations of British Columbia.

NOMINATIONS [VIII (E)]

- Nominations for President will be open four (4) weeks before the Election and close at
 4:30pm two (2) weeks before the election. The 2022 nomination period for the 2022 election is
 Wednesday, August 31, 2022 until Wednesday, September 14, 2022 at 4:30 p.m.;
- Nominations must be endorsed by three (3) Full Members (those who have paid their membership dues for the current year) or Active Members of the UBCIC; and
- Original or Faxed Nomination forms must be submitted to the Attention of the Chief
 Electoral Officer at one of the Union of B.C. Indian Chiefs' offices:

ELIGIBILITY TO NOMINATE CANDIDATES OR TO VOTE

Only Full and Active Members in good standing (those that have paid their membership dues for the current year) are eligible to nominate candidates or to vote in the election.

THRESHOLD FOR ELECTION [V(a)(ii)]

"(ii) A majority of 60% of voting delegates is required to elect the President. In the event that a majority of 60% is not achieved on the first ballot, the candidate with the least amount of votes will be eliminated from the ballot, and a second ballot will be held. This process will be followed



until a President is elected with the required 60% majority. However, if there are only two candidates for the position of President on a ballot, the candidate with the most votes will be declared elected. In the event of a tie where only two candidates are on the ballot, the election will be determined by a coin toss of the Chief Electoral Officer."

ELECTIONS FOR OTHER UBCIC EXECUTIVE POSITIONS

Elections for the remaining UBCIC Executive positions of Vice-President and Secretary-Treasurer, as well as Active Member positions (Women's Representative, Elder Representative, and Youth Representative), will be held at a Chiefs Council meeting scheduled for <u>February 22 & 23, 2023</u>. An election/nomination package for these positions will be distributed prior to the Chiefs Council meeting.
