PREAMBLE

We in the Republican Party of Wagoner County strive to build a more prosperous local community, state and nation where individual prosperity is encouraged, a person's productivity is limited only by his individual ability and personal initiative and where citizens may enjoy the freedom to pursue life as described by the Constitution of the United States of America. The Wagoner County Republican Party, composed of individuals of many views and opinions regarding the means to achieve that goal, unite with the common belief that those individual rights and the limitation of government set forth in the Constitution of the United States are sacrosanct, and the ideals of moral and fiscal conservatism and individual responsibility are paramount to maintain liberty for all people of our great state and nation.

STATEMENT OF PRINCIPLES

We believe in Limited Government, Individual Liberty & Personal Responsibility

Governing

- We believe in limited government.
- We believe life; liberty and the pursuit of happiness are all God given rights and are protected under the Constitution.
- We believe the Constitution is the supreme law and should be interpreted consistent with the original intent of our Founding Fathers.
- We believe under the Constitution, only Congress can make laws (Article 1, Section 1), Executive and Judicial authority is limited to those powers enumerated in constitution, all other powers belong to the states.
- We support the right under the 2nd Amendment for all citizens to keep and bear arms.
- We support term limits and a balanced budget requirement.

Right to Life

- We believe in the sanctity of life from conception to natural death.
- We oppose abortion and support adoption.
- We support adult, but not fetal stem cell research.

Religious Freedom

- We believe no citizen or business should be forced to act in opposition to his conscience.
- We believe voicing ones religious beliefs and freedom of worship is protected by the First Amendment.
- We support retaining the religious significance of holidays and public displays.

Education

- We believe the U.S. Department of Education should be eliminated, with education being managed at the state and local level.
- We believe it is the right of parents to choose the form of their children's education.
- We believe parents should be allowed to use education tax (credit) dollars for the family's choice of schooling.

Taxation

- We believe taxes collected at all levels of government should only be used for constitutionally allowed functions.
- We support replacing the federal income tax with a form of national sales tax, flat tax, or Fair Tax.
- We support the elimination the IRS.

Health Care

- We oppose nationalized medicine (ACA or "Obamacare")

Family

- We believe in traditional marriage between one man and one woman.

Immigration

- We oppose any form of amnesty and support strong border security.
- We support enforcement of current immigration laws.
- We believe we should welcome immigrants who legally seek freedom and desire citizenship.
- We support English as the legal national language.

Defense

- We support a strong national defense and advocate "peace through strength".
- We support fighting terrorists and organizations that support them.

Foreign Policy

- We support policies that protect all US embassies and allies.
- We oppose any UN control command of our military forces at home or abroad.
- We believe no international treaty should be entered by the State Department or president without 2/3 approval of the Senate.
- We support US withdrawal from the UN.

Election Reform

- We believe all voters must be registered and support the requirement for voters to show their government issued photo ID before voting.
- We believe election fraud and voter intimidation must be firmly prosecuted and punished.

General

- We believe constitutional eligibility must be verified for any candidate for office.
- We believe it is the private sector free market principles that best stimulate economic development with minimum government regulation and no subsidies.
- We support strict law enforcement and punishment for all crimes, including the use of the death penalty.
- We support abolishment of hate crime laws.
- We support tort reform.
- We support elimination of toll roads.
- We support elimination of government funding for Public Broadcasting, Endowment for the Arts, or similar activities.

I FAMILY

Preamble

Traditional marriage, consisting of one man and one woman, is designed to provide each family member's physical, emotional, financial, spiritual, and social needs. Both parents are needed to support and encourage happiness, health, and a good education for their children, creating the next generation of citizens who are constructive members of society. We believe God is the Author and Creator of human life and that each individual should be treated with dignity and compassion. We insist that any candidate receiving money and/or support from the Republican Party shall affirm and promote the Pro-Life concept.

I A. MARRIAGE, CHILDREN AND ADOPTION

- I A-1.** We affirm the State's recognition that marriage between one man and one woman is a covenant relationship, instituted by God, not to be entered into casually, and is fundamental to our very existence and survival as a nation. (SEE STATE PLATFORM I A-1)
- I A-2.** We support the right of parents to rear, educate, discipline, nurture and spiritually train their children without government interference. (SEE STATE PLATFORM I A-2)
- I A-3.** We support tax policies, enactment of legislation and public assistance policies that encourage a commitment to traditional marriage and strong families. (See State Platform I A-3)
- I A-4.** We support Federal and State legislation that prohibits recognition of same-gender marriages or domestic partnerships. (SEE STATE PLATFORM I A-4)
- I A-5.** We believe that in order to encourage and protect family values, those promoting homosexuality or other aberrant lifestyles should not be allowed to hold responsible positions over children or other vulnerable persons. (SEE STATE PLATFORM I A-6)
- I A-6.** We support strict adherence to due process of law in child abuse investigations and the protection of the constitutional rights of persons accused of child abuse. We oppose the removal of children from their family unless abuse allegations are confirmed or the child is in immediate danger. (SEE STATE PLATFORM I A-7)
- I A-7.** We support holding Department of Human Services and other State agents accountable and provide for civil and criminal penalties when agents abuse their authority. (SEE STATE PLATFORM I A-9)
- I A-8.** We encourage an adoption process that recognizes the rights of parents while maintaining safeguards for the children. We support adoption only by traditional families or qualified relatives. (SEE STATE PLATFORM I A-10)
- I A-9.** We oppose no fault divorce. (SEE STATE PLATFORM I A-11)

I B. RIGHT TO LIFE & MEDICAL ETHICS

- I B-1.** We believe in the sanctity and value of human life from conception through natural death. We oppose abortion (including the use of RU-486 and partial birth abortion), infanticide, euthanasia and mercy killings, and the funding of such by the government. We support a Constitutional Amendment protecting innocent human life. (SEE STATE PLATFORM I B-2)
- I B-2.** We support the right of hospitals, doctors, and staff to refuse to provide abortion services. (SEE STATE PLATFORM I B-3)
- I B-3.** We also recommend a 24-hour waiting period for a woman planning to have an abortion, in which time informed consent should be provided to patients of the developmental status of the unborn child, supply patients with all ultra-sounds, inform the patient that medical evidence indicates an unborn child can feel sensations of pain, and inform women of the psychological and medical risks associated with abortion including the link between breast cancer and abortion, and provide information on services available to mothers who choose to carry their children

to birth. (SEE STATE PLATFORM I B-4)

- I B-4.** As long as the unsafe practice of abortion continues, we insist that abortion clinics be required to comply with the same medical and safety standards required of hospitals. (SEE STATE PLATFORM I B-7)
- I B-5.** As long as abortion continues, we support enactment of legislation that requires a guarantee of parental notification and authorization 72 hours prior to a minor receiving an abortion. (SEE STATE PLATFORM I B-8)
- I B-6.** We support abstinence outside of marriage and parental notification before a minor is given birth control information and/or contraceptives. (SEE STATE PLATFORM I B-9)
- I B-7.** We support legislation that prohibits using any unborn child for the purpose of harvesting and/or any service related to the donation or purchase/sale of organs and tissue. (SEE STATE PLATFORM I B-10)
- I B-8.** We support adult, but not fetal stem cell research. We do not support unethical scientific experimentation. (SEE STATE PLATFORM I B-11 & 12)
- I B-9.** We oppose the manufacture of human life through the process of cloning. (SEE STATE PLATFORM I B-13)
- I B-10.** We believe that no person should have nourishment, water, and/or medical care withheld, unless a written legal directive has been signed by that individual. (SEE STATE PLATFORM I B-14)

I C. HEALTH CARE

- I C-1.** We support the patient-family-doctor relationship and oppose nationalized medicine. (SEE STATE PLATFORM I C-1)
- I C-2.** We believe parents should receive complete information and must give informed consent prior to their child, or themselves, receiving any immunizations and may refuse any such vaccination(s) for medical, religious or other reasons of conscience without retribution. (SEE STATE PLATFORM I C-4)
- I C-3.** We support Medical Savings Accounts (MSA) and Health Savings Accounts (HSA) that also allow the individual freedom of choice in services both traditional and alternative. (SEE STATE PLATFORM I C-7)
- I C-4.** We oppose all disability specific legislation, including “Nick’s law”. Any legislation based on limited diagnostic criteria creates duplication of programs and services, resulting in increased and unnecessary spending, as well as creating gaps and confusion for those who truly need assistance.

I D. ELDERLY

- I D-1.** We support tax incentives that help alleviate cost and thus encourage family members to care for their elderly parents. (SEE STATE PLATFORM I D-2)
- I D-2.** We support financial policies that do not penalize the elderly who choose to marry. (SEE STATE PLATFORM I D-3)
- I D-3.** We believe that strict standards should preserve the dignity of the elderly when in a retirement or nursing home. (SEE STATE PLATFORM I D-4)
- I D-4.** We support vigorous prosecution of those who financially exploit or otherwise abuse the elderly. (SEE STATE PLATFORM I D-5)

I E. RELIGIOUS FREEDOM

- I E-1.** Our Founding Fathers based our Constitution, Declaration of Independence, Bill of Rights and early laws on the Bible and traditional Judeo-Christian ethics and values. We believe these documents are the basis for law, order and behavior, allowing individuals, including government workers and officials, the freedom to involve God in all

activities according to their consciences. (SEE STATE PLATFORM I E-1)

- I E-2.** We believe the religion clause of the First Amendment was meant to protect individuals' freedom of religion, not remove religion from public life. (SEE STATE PLATFORM I E-2)
- I E-3.** We oppose any government oversight, harassment, licensing, or taxation of religious institutions and their ministries. (See State Platform I E-4)
- I E-4.** We support retaining the religious significance of national holidays. (SEE STATE PLATFORM I E-5)
- I E-5.** We strongly support federal and state legislation to encourage and preserve inscriptions, in or on, public buildings, and on our currency, that have reference to God; such as "In God We Trust". (SEE STATE PLATFORM I E-6)
- I E-6.** We strongly support retaining the phrase "One Nation under God" in the Pledge of Allegiance. (SEE STATE PLATFORM I E-7)
- I E-7.** We believe no foreign or Sharia law shall be recognized in any USA courts.

I F. GENERAL

- I F-1.** We oppose the promotion of homosexuality and the granting of minority protection or special status to any person based upon sexual preference or lifestyle choices. (SEE STATE PLATFORM I F-1)
- I F-2.** We believe that homosexuality is not a genetic trait, but a chosen lifestyle. (SEE STATE PLATFORM I F-2)
- I F-3.** We support limiting welfare benefits to only citizens of the United States and legal residents, including military service members and their dependents. We believe in a welfare policy that promotes family unity, hard work, and individual responsibility. (SEE STATE PLATFORM I F-3)
- I F-4.** We believe in welfare reform to help those truly in need. We support programs including faith based organizations that promote traditional marriage, stabilized marriages, abstinence education, decrease out-of-wedlock births and encourage responsible parenting. (SEE STATE PLATFORM I F-6)
- I F-5.** We encourage rigorous enforcement of all anti-pornography laws. Government agencies or tax supported institutions, especially libraries and public schools should not provide access to pornography. (SEE STATE PLATFORM I F-8)
- I F-6.** We believe that civic and religious organizations have the right of free association without interference by special interest groups. (SEE STATE PLATFORM I F-9)

II EDUCATION

Preamble

The primary goal of public schools should be to teach proficiency in the basic subjects of phonics-based reading, written and oral communication, mathematics, sciences, traditional history, founding documents and Godly heritage of our nation. Locally elected school boards should have the authority to determine and implement all public school curricula, policies and procedures for their districts. We demand excellence and accountability from all tax-funded institutions of education in Oklahoma. The federal government has no constitutional role in education.

It is the right and responsibility of parents to direct their children's upbringing and education whether public, private, charter or home school, without interference, regulation or penalty from the government.

II A. PHILOSOPHY

- II A-1.** The traditional family unit is the foundation of our social structure. The Oklahoma Department of Education should uphold and teach this definition of family at all levels of public education. (SEE STATE PLATFORM II A-1)
- II A-2.** Parents and legal guardians are responsible and accountable for the education of their children. We support a parent's choice of schools, including: public, private, parochial, charter or home schooling. We believe all parents should be allowed to use their education tax dollars for the family's choice of schooling by the use of tax credits. (SEE STATE PLATFORM II A-3)
- II A-3.** Parents have a right under the Oklahoma Constitution to home school their children. We oppose any and all regulation of home schooling.
- II A-4.** We affirm the right of students and teachers to the free exercise of religion as Guaranteed by the First Amendment, including: the right to wear and display religious symbols, voluntary vocal prayer, optional Bible and religious study, religious expression, and equal access to use school facilities for these activities. (SEE STATE PLATFORM II A-4)
- II A-5.** The American flag should be displayed in the classroom. Students should start the day by reciting the traditional Pledge of Allegiance, and be taught the history of and respect for our American flag. (SEE STATE PLATFORM II A-5)
- II A-6.** We support parental access to examine and evaluate in advance, educational, assessment, psychological, medical, physical, and all records pertaining to their children. (SEE STATE PLATFORM II A-6)
- II A-7.** Student participation in any program or counseling should be based upon prior written parental consent, without repercussion (opt in vs. opt out). Notification to parents should be clear, simple and descriptive. (SEE STATE PLATFORM II A-7)
- II A-8.** The Ten Commandments may be posted in all public schools as a means of moral guidance along with our national motto "In God We Trust" and the Bill of Rights. (SEE STATE PLATFORM II A-8)
- II A-9.** We oppose any government required community service condition of graduation. (SEE STATE PLATFORM II A-9)
- II A-10.** Computer technology and calculators should only be used after basic math and reading proficiency are achieved in order to reinforce, not replace, the learning of basic skills. (SEE STATE PLATFORM II A-10)
- II A-11.** The Federal Department of Education should be eliminated and its functions transferred to the states. (SEE STATE PLATFORM II A-11)
- II A-12.** We oppose the revision of American history.
- II A-13.** We believe a high school diploma should represent a 12th grade level of proficiency in basic subjects.
- II A-14.** The imposition of national curricula, aptitude testing, and teacher certification or education standards on any Oklahoma school is not acceptable.

- II A-15.** Public schools are prohibited from promoting any religion. That prohibition should include promoting or using secular Humanism, New Age philosophy, Deep Ecology, reincarnation, psychotherapy, channeling, transcendental meditation, altered states of consciousness or any occult practice.

II B. CURRICULUM

- II B-1.** Basic school curriculum should include reading, composition, literature, mathematics, science, history, and government. Reading shall include phonics instruction, and composition shall include grammar and spelling instruction. Fine arts, foreign language, and physical fitness should also be included in school curricula.
- II B-2.** American heritage should be taught in public schools and include representative government, limited government, lives and beliefs of the founders, influence of the Bible and religion on our laws and principles, and the concept of free enterprise. Students should study directly from the primary founding documents, which teach the distribution of power among three branches of federal government and between federal and state government. (SEE STATE PLATFORM II B-1)
- II B-3.** Where evolution is taught, intelligent design must be taught as well. (SEE STATE PLATFORM II B-2)
- II B-4.** Local school boards should maintain the right to choose curricula and textbooks without state limitations. They further maintain the right to insert disclaimer statements into textbooks. (SEE STATE PLATFORM II B-3)
- II B-5.** Parents must maintain the right and responsibility to educate their children regarding sexuality and sexual conduct. Neither classroom instruction nor school-based health services shall usurp parental rights to educate their children. (SEE STATE PLATFORM II B-4)
- II B-6.** We oppose the portrayal of homosexual or promiscuous behavior in a positive light in public schools.
- II B-7.** Multiculturalism promotes cultural segregation and should not be taught. We respect different cultures and affirm that U.S. citizens of any race, creed, or culture are fully Americans, not hyphenated Americans. (SEE STATE PLATFORM II B-6)
- II B-8.** English, the dominant language of our nation, should be the primary language taught in public schools with other languages offered as electives. (SEE STATE PLATFORM II B-7)
- II B-9.** We support curriculum that promotes national sovereignty and oppose one world government and global citizenship. (SEE STATE PLATFORM II B-8)

II C. ADMINISTRATION AND MANAGEMENT

- II C-1.** We oppose all un-funded mandates. (SEE STATE PLATFORM II C-1)
- II C-2.** Compulsory education should continue to be applied only between the ages of 8 and 16, as set forth in the Oklahoma Constitution. (SEE STATE PLATFORM II C-4)
- II C-3.** Extensive background checks of prospective school employees are necessary, with the right of local school boards to refuse employment to anyone. (SEE STATE PLATFORM II C-6)
- II C-4.** We support immediate decertification of all Teachers' Unions in Oklahoma so the local school boards are free to hire, direct, train, retain or terminate any teacher that fails to provide the highest quality of instruction, based on merit, not years of service. (SEE STATE PLATFORM II C-7)
- II C-5.** Teachers, school administrators and the local school board should work together to set and implement policies that give teachers the freedom and authority to lawfully maintain order and discipline. (SEE STATE PLATFORM II C-9)
- II C-6.** We call for enforcement of Oklahoma statutes that prohibit teachers from striking during the school year. (SEE STATE PLATFORM II C-10)

- II C-7.** Local school districts should be able to place year-end excess monies into an interest-bearing account, to encourage fiscal responsibility; and they should not be penalized by the State Department of Education for doing so. (SEE STATE PLATFORM II C-11)
- II C-8.** We support public independent auditing of all public schools and institutions of higher education in Oklahoma. (SEE STATE PLATFORM II C-12)
- II C-9.** The state school funding formula should be simplified and made understandable and equitable.
- II C-10.** Open student transfer, with receiving school approval, should be implemented.
- II C-11.** High school seniors should not be required to attend a full school day if they have otherwise satisfied graduation requirements. The district should receive a full day's financial credit by the State Department of Education for those seniors.
- II C-12.** Teachers or administrators who are indicted for a felony should be placed on unpaid leave until determination of their guilt or innocence.
- II C-13.** Unions must be limited to negotiate wages and conditions of employment. We believe that organizations should be denied tax-exempt status and all federal funds if they are labor unions and lobbying bodies. Any administrator who discriminates against any employee who refuses to join a particular union shall forfeit their credentials and/or teaching certification in Oklahoma.
- II C-14.** Alternative teaching certification programs should allow skilled professionals to teach in public schools by passing the State Teacher Certification Test.
- II C-15.** Efforts should be initiated to merge teaching resources and better utilize the technical and educational resources available. School administrations should be allocated based on enrollment.
- II C-16.** Any current, past, or future revenue appropriation supporting education must be, by statute and law, integrated into the current fiscal year's budget.
- II C-17.** We support a constitutional amendment in the Oklahoma state legislature requiring a student to be a legal resident of the United States before being enrolled in the Oklahoma public school system.

II D. HIGHER EDUCATION

- II D-1.** We support meaningful reform in the structure of our higher education system, including (SEE STATE PLATFORM II D-1):
 - II D-1. a** Evaluation of all programs and elimination or reform of substandard programs. (SEE STATE PLATFORM II D-1A)
 - II D-1. b** Accountability of administrators to include performance evaluation.
 - II D-1. c** Reforming of the faculty tenure system.
 - II D-1. d** Budgeting tied to comprehensive planning process with increases in funding directly related to specific goals and objectives listing expected improvements. (SEE STATE PLATFORM II D-1B)
- II D-2.** There should be a required course in phonics for elementary teacher certification, as well as for certification at all levels of reading and language arts. (SEE STATE PLATFORM II D-3)
- II D-3.** We believe state appropriated higher education funds should support state citizens.
- II D-4.** Federal and state grants and other aid for higher education should be applied consistently and fairly without regard to marital status.

III STATE

Preamble

We believe all persons are responsible and should be held accountable for their actions. We believe in transparent and honest government with minimal intrusion, providing protection for all its citizens with fair and equitable treatment, enforcement and justice. We realize without economic freedom there is no political freedom. We believe the greatest incentive for the creation of wealth lies in the respect for private property rights and the free enterprise system is the best and most efficient distribution of resources.

III A. CRIME AND PUNISHMENT

- III A-1.** We believe that the criminal should make restitution for crimes and riots. Charitable compensation for loss is always encouraged, but we believe that taxpayer money should not be used. (SEE STATE PLATFORM III A-3)
- III A-2.** We favor strict law enforcement as well as swift trial and punishment for all crimes, including the use of the death penalty when appropriate. (SEE STATE PLATFORM III A-4)
- III A-3.** We support legislation that would eliminate the filing of frivolous lawsuits by incarcerated persons. (SEE STATE PLATFORM III A-7)
- III A-4.** We oppose all hate crime laws. (SEE STATE PLATFORM III A-8)

III B. ECONOMIC DEVELOPMENT

- III B-1.** We believe that Oklahoma's efforts to attract industry should be grounded upon the establishment of a favorable and friendly economic climate rather than upon tax and other governmental subsidies to individual businesses. (See State Platform III B-1)
- III B-2.** We support the revision of corporate laws and regulations to encourage business and economic development while reflecting free market principles. (See State Platform III B-2)

III C. ELECTION REFORM

- III C-1.** In order to make them more accessible to voters, we encourage centrally-located polling places in each precinct. (SEE STATE PLATFORM III C-1)
- III C-2.** In order to conserve state money and to increase voter participation, we support the consolidation of election dates. (SEE STATE PLATFORM III C-2)
- III C-3.** We support requiring the Bureau of Vital Statistics to report, in a timely manner, any deaths reported to them to all affected state and county agencies, especially county election boards. (SEE STATE PLATFORM III C-3)
- III C-4.** We support a requirement that each vote cast in all elections be documented by a paper or other physical record. (SEE STATE PLATFORM III C-9)

III D. ENVIRONMENT AND WATER

- III D-1.** We support environmental regulations that respect the rights of property owners, and that do not impose unreasonable burdens on our state's businesses. (SEE STATE PLATFORM III D-1)
- III D-2.** We believe that the State of Oklahoma should not sell water or water rights to out-of-state buyers. (SEE STATE PLATFORM III D-2)

- III D-3.** We believe that a sustainable supply of water for a local area should be a priority before any permit is granted which would transfer water outside a local basin or aquifer area. Water is a natural resource, not a commodity, and should be protected for use by local residents, agriculture, and industry. (SEE STATE PLATFORM III D-4)
- III D-4.** We believe that water permits should not allow the withdrawal of water in large volumes such that the private property rights of other landowners are infringed. (SEE STATE PLATFORM III D-5)

III E. IMMIGRATION

- III E-1.** We strongly support enforcement of state and federal laws dealing with illegal aliens. (SEE STATE PLATFORM III E-1)

III F. INSURANCE

- III E-1.** We oppose the State Legislature mandating the rollback of insurance premiums. (SEE STATE PLATFORM III F-1)
- III E-2.** We oppose no-fault insurance.

III G. STATE GENERAL

- III G-1.** We believe that the size of state government should be reduced. (SEE STATE PLATFORM III G-1)
- III G-2.** We support the implementation of “sunset laws” and believe that outdated and irrelevant statutes should be repealed. (SEE STATE PLATFORM III G-2 & I-21)
- III G-3.** We believe that the Oklahoma Legislature, all legislative committees, and state and county agencies should be subject to the Open Meeting Act and Open Records Act. (SEE STATE PLATFORM III G-3)
- III G-4.** We support external annual audits and public disclosure of all financial records of public institutions including trusts, authorities, libraries, funds. (SEE STATE PLATFORM III G-4)
- III G-5.** We oppose un-funded mandates by the State Legislature. (SEE STATE PLATFORM III G-14)

- IV B-11.** We support the import of medication from other countries in order to lower the cost, if U.S. standards are enforced.

IV C. UNITED NATIONS

- IV C-1.** We believe that the United States Constitution is the supreme law of the land, and that no other laws will supersede it, including conventions and resolutions, rulings, mandates or any other laws or policies written by the United Nations or any other international organization. - IV C-5.** We oppose the Law of the Sea Treaty because it would turn 7/10ths of the earth's surface over to the United Nations. (SEE STATE PLATFORM IV C-5)
- III C-6.** We oppose Agenda 21 in any form. (SEE STATE PLATFORM IV C-6)
- IV C-7.** We believe the United States should withdraw from the United Nations. (SEE STATE PLATFORM IV C-7)
- IV C-8.** We oppose any UN tax applied directly or indirectly to the citizens of the U.S. (SEE STATE PLATFORM IV C-8)
- IV C-9.** We oppose any United Nations small arms treaty.

IV D. CONSTITUTIONAL ISSUES

- IV D-1.** We affirm our right under the First Amendment of the United States Constitution to exercise our freedom of speech including religious speech. We believe the First Amendment's Establishment Clause was intended to prevent a state-sponsored religion, not to separate God from our government or to remove religion from public life. - IV D-3.** We support the repeal of the Brady Bill. (SEE STATE PLATFORM IV D-3)
- IV D-4.** We oppose any legislation that would require the use of trigger or other locking devices on firearms. (SEE STATE PLATFORM IV D-4)
- IV D-5.** We support legislation that will protect gun manufacturers from lawsuits attempting to hold the manufacturers liable for criminal misuse of guns. (SEE STATE PLATFORM IV D-5)
- IV D-6.** We oppose the assault weapons ban and any efforts to register previously owned firearms. (SEE STATE PLATFORM IV D-6)
- IV D-7.** We believe the United States Constitution empowers the judiciary to interpret law, not make law or create law through judicial activism. (SEE STATE PLATFORM IV D-8)

- IV D-11.** We support capital punishment. (See State Platform IV D-12)
- IV D-12.** We support an amendment to the Constitution that will limit the institution of marriage to one man and one woman, thus prohibiting persons of the same gender from establishing the bonds of marriage under the laws of any of the several states.
