Item 10: Expenditure Report

Attached as Exhibit A is the FY 18/19 Budget with balances as of January 31, 2019.

Attached as Exhibit B is The Statement of Receipts and Disbursements for the quarters ending September 30, 2018, and December 31, 2018 from the Los Angeles County Auditor-Controller.

REVENUES

- 1. Operational lease revenue is on target with projections.
- 2. Staff is awaiting reimbursement from several other grants and professional service contracts; thus, revenue from Grant and Special Projects has been minimal. The revenue will be reflected when submitted costs expended under the grant has been approved for reimbursement and the reimbursement is received.

EXPENSES

- 1. Financial Audit Services and Dues & Subscriptions line items are significantly below the YTD budget projections as the Authority expects expenses incurred during the late third quarter to be within budgeted projections.
- 2. Funding Opportunities line item is lower than the YTD budget projections as the Authority have been invoiced through November 30, 2018. The Authority expects expenses incurred during the quarter to be within budgeted projections.
- 3. The insurance line item in both General Administration and Operational Expense categories is significantly below the YTD budget projections as the Authority expects expenses incurred during the late third quarter to be within budgeted projections.
- 4. Office supplies line item is slightly ahead of the YTD budget projections as the supplies were purchased in bulk and current inventory is expected to carry through the end of the fiscal year.
- 5. Security line item is slightly ahead of the YTD budget projections as the alarm services for the Duck Farm and River Wilderness Park are paid through April 1, 2019 and May 1, 2019 respectively. The Authority expects expenses through the end of the fiscal year to be within budgeted projections.

- 6. Propane line item is lower than the YTD budget projections as the Authority have been invoiced through December 5, 2018. The Authority expects expenses through the end of the fiscal year to be within budgeted projections.
- 7. Water System Operation/Irrigation line item is lower than the YTD budget projections as the Authority have been invoiced through December 31, 2018. However, with the termination of the current water system operator as of March 4, 2019, the Authority expects to receive a final invoice and contract with a new operator to keep the water system operations compliant.
- 8. Janitorial Services line item is lower than the YTD budget projections as the Authority have been invoiced through December 31, 2018. The Authority expects expenses incurred during the quarter to be within budgeted projections.
- 9. Property taxes for a portion of the Mt. Baldy property located in San Bernardino County are paid through the end of this fiscal year. The Authority do not anticipate expending the remaining budget balance.
- 10. All other expenditure items are projected to be within budgetary limits except for those line items previously reported in prior meeting such as Fiscal Services Auditor-Controller, Deferred Maintenance Contingency and Ranger Services.
