FOREWORD

For decades, the global discourse on refugees from the Middle East has centred almost exclusively on the Palestinian experience. Yet, a parallel tragedy has remained largely unspoken: the mass displacement of over 850,000 Jews from Arab countries in the mid-20th century. These were ancient communities — some predating Islam by over a millennium — erased in less than a generation.

The Jewish presence in the Middle East and North Africa long predates not only the modern Arab nation-state, but even the rise of Islam itself. Jewish communities thrived in Babylonian Mesopotamia, in the Arabian Peninsula, and across North Africa centuries before the advent of the Prophet Muhammad. These communities were foundational to the cultural and economic life of the region for more than two thousand years.

This booklet, developed by We Believe in Israel in partnership with Harif, Stop the Hate UK and The Shield of David, aims to restore historical balance, promote justice, and urge formal recognition of this neglected chapter of history. By highlighting the experiences of these forgotten refugees, we aim to foster a more comprehensive and equitable understanding of the Middle East conflict.

HISTORICAL OVERVIEW

Between 1948 and the 1970s, Jewish communities across the Middle East and North Africa faced systematic persecution. Following the establishment of the State of Israel, Jews in Arab countries were targeted for collective punishment. Mobs attacked Jewish quarters, synagogues were burned, and anti-Jewish legislation was enacted. In Iraq, the infamous 1941 Farhud pogrom foreshadowed what was to come: hundreds of Jews were murdered, and Jewish property was looted.

The Arab League actively coordinated measures that led to the revocation of citizenship, forced expulsions, and mass confiscations of property. In Egypt, Jews were labelled enemies of the state, imprisoned, and stripped of their assets. In Libya, pogroms erupted in 1945 and 1948, driving out nearly all of the country's Jews. In Yemen, Operation Magic Carpet airlifted tens of thousands to Israel to save them from worsening conditions. What united these diverse cases was a pattern of state and societal violence designed to eliminate Jewish presence from the Arab world.



LEGAL STATUS OF JEWISH REFUGEES



The absence of international recognition for Jewish refugees from Arab countries contrasts sharply with the sustained political and institutional support given to Palestinian refugees. While the plight of Palestinians has been the subject of hundreds of UN resolutions, not a single resolution has acknowledged the expulsion of Jews from Arab lands.

This disparity not only distorts historical understanding but also entrenches a biased narrative within international diplomacy and the public consciousness. The focus on one group to the exclusion of the other presents a one-sided view of the Arab-Israeli conflict, undermining efforts at mutual recognition and reconciliation. A just and durable peace requires that all experiences of forced displacement be acknowledged and addressed.



CULTURAL ERASURE AND LOSS

The Jewish communities of the Arab world were ancient and deeply embedded in their respective societies. In Baghdad, Jews once comprised a third of the population and were leaders in commerce, literature, and medicine. In Cairo, Jews contributed to education, finance, and architecture. These communities did not simply leave; they were eradicated. The cultural loss is immense. Thousands of synagogues, cemeteries, libraries, and schools were abandoned, destroyed, or repurposed. Sacred texts and artefacts were looted or lost to history. The displacement was not only a humanitarian crisis but a deliberate erasure of centuries of coexistence and contribution.

Economically, the loss was staggering. It is estimated that Jewish refugees from Arab lands left behind assets worth billions of pounds, including land holdings equivalent to the combined area of Lebanon and Jordan. None of these assets have been compensated or returned.



GLOBAL RECOGNITION EFFORTS

Despite institutional silence, several governments and parliaments have taken steps to acknowledge the injustice suffered by Jewish refugees from Arab countries:

- United States: In 2008, the U.S. House of Representatives passed Resolution 185, affirming that any reference to Palestinian refugees in international resolutions must be matched by reference to Jewish refugees.
- Canada: In 2014, the Canadian government formally recognised the forced displacement of Jews from the Middle East and North Africa and committed to include this narrative in its human rights discourse.
- United Kingdom: On 19 June 2019, the UK Parliament held a debate on Jewish refugees from Arab countries and Iran. Cross-party MPs called for official recognition and urged the government to support justice and redress.

These acknowledgments, though significant, must now translate into concrete policies and public awareness.





WHAT WE ARE CALLING FOR

We urge the UK Government to take meaningful steps to address this historical injustice:

- Formal Recognition: Acknowledge the expulsion and dispossession of Jewish communities from Arab countries as a refugee crisis.
- Inclusion in Policy and Education: Incorporate the history of Jewish refugees into UK foreign policy discourse and national curricula, ensuring future generations understand the full context of the Middle East conflict.
- Restitution and Compensation: Support efforts to catalogue lost Jewish property, encourage restitution where possible, and consider symbolic or financial compensation.
- Balanced Peace Frameworks: Insist that any future diplomatic resolutions to the Israeli-Palestinian conflict include provisions for all refugee populations affected, including Jews from Arab lands.
