Justin Adams

Senior Economist, LAEDC Institute for Applied Economics Dr. Justin L. Adams is the Senior Economist at LAEDC's Institute for Applied Economics. He conducts economic impact analyses for the LAEDC's public-sector and private-sector clients, performs research supporting LAEDC's many programs, and undertakes microeconomic and macroeconomic research to help inform regional stakeholders and decisionmakers.

Justin has over two decades of experience consulting to federal, State and local governments as well as private-sector organizations. Most recently, Justin served as President and Chief Economist of Encina Advisors, an economics research and analysis firm based in the city of Davis. Prior, Justin spent six years as an economist with the RAND Corporation in Santa Monica and worked at Sacramento-based management consulting firms. He has held positions in California state government at the Governor's Office of Planning and Research, the Department of Housing and Community Development, and the Department of Transportation (CalTrans).

Justin received his Ph.D. in Business with a concentration in Political Economics from the Stanford Graduate School of Business. He also received his A.M. in Political Science and his A.B. in Economics and Political Science from Stanford. Justin currently lives in Claremont with his long-time partner Gina and their three cats. He spends his spare time cycling, whether indoors or outdoors.

Alex is a land use attorney who handles zoning matters, environmental compliance, and litigation. He represents real estate developers before planning commissions and city councils, advises on permits and regulations, and works with public agency staff and elected officials.

structured complex land use entitlement projects for industrial, commercial, and educational clients.

In this position he co-leads the Department's Housing Policy Unit, which is responsible for developing various citywide housing related initiatives and coordinating the implementation of state legislation. He recently completed the City's update to the Housing Element and has led the development of many housing policies such as the Transit Oriented Communities (TOC) affordable housing incentive program, the City's Accessory Dwelling Unit (ADU) policy, the Home Sharing Ordinance, the Affordable Housing Linkage Fee, Permanent Supportive Housing Ordinance. He has a Master's Degree in Urban and Policy from the University of Illinois at Chicago and a M.F.A. in Urban and Regional Planning from the University of Illinois at Urbana-Champaign.
