DEFENDANT GLEN TAKAHASHI'S PARTIAL JOINDER TO FEDERAL DEFENDANTS' MOTION TO DISMISS FOR LACK OF SUBJECT MATTER JURISIDCTION [ECF #74] AND MEMORANDUM IN SUPPORT [ECF #75]

Pursuant to Local Rule 7.7, Defendant Glen Takahashi, in his capacity as Clerk of the City and County of Honolulu, joins in part in the Federal Defendants' Motion to Dismiss (ECF Nos. 74, 75) on the grounds that Plaintiffs' alleged injury is not redressable by a favorable decision. Takahashi joins in the redressability arguments for the same reasons that the State Defendants discussed in their joinder (ECF #78), and for the following additional reasons.

The Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), § 3-301 ("Powers, Duties and Functions [of the City Clerk]") states

that the "city clerk shall...[c] onduct all elections held within the city and perform registration functions pursuant to this charter or **the laws of the state**." § 3-301(2)(d) (emphasis added).

The laws of the state include various provisions referring to the clerk in both Chapter 15 ("Absentee Voting") and Chapter 15D ("Uniform Military and Overseas Voters Act") (UMOVA). See, e.g., HRS §§ 15-4 ("Request for absentee ballot"), § 15-5 ("Delivery of ballots"), 15D-13 ("Confirmation of receipt of application and voted ballot"), 15D-14 ("Use of voter's electronic-mail address"), and 15D-15 ("Publication of election notice").

Takahashi does not join in the remaining arguments raised by the Federal Defendants and expressly reserves the right to file a timely opposition thereto.
