**TO USE:** ARTICLE V CONVENTION, AMENDMENT CONVENTION, NATIONAL CONVENTION

Remember that we are calling for a limited convention as authorized by Article V of the U.S. Constitution for the sole purpose of proposing an amendment that will ensure Free and Fair Elections in America.

**NOT TO USE:** CONSTITUTIONAL CONVENTION OR CON CON

These are misleading terms because they suggest that a convention has the power to write (or even approve) a new constitution, and that's not the case.
