### Just announced!

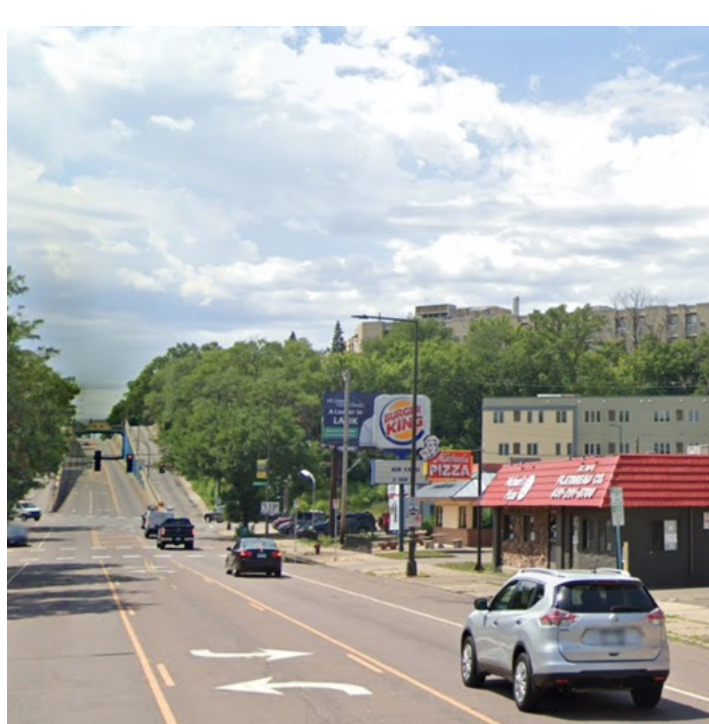
