Under the collective bargaining procedures as defined in Regulation 15 passed by the Board of Directors, Locals are to forward bargaining proposals to their Component on the approved form and in accordance with the established timetable.

It will greatly assist the bargaining process if the Local submits all the relevant background information to the proposals including an explanation of the problems, if any, encountered with the current provisions of the agreement, and the source and justification for any new proposals.

As provided in the Regulation, the Component shall then forward to the Negotiations and Programs Branch of the Public Service Alliance of Canada one proposal on each topic as the official position of the Component. Only proposals with complete rationale and justification shall be considered by the Public Service Alliance of Canada.

Each bargaining proposal must indicate the origin of the proposal, be signed by a responsible officer of the Component and be transmitted to the Public Service Alliance of Canada on a separate form and when appropriate, in both official languages and in an electronic format.
